# H.B. 704 RELATING TO MOTOR VEHICLE REGISTRATION

House Committee on Transportation

The Department of Transportation (DOT) **supports** this measure that expands the existing exemptions for marine terminal equipment to be moved between terminals at Hawaii's commercial harbors.

The existing law limits the public roadways upon which the marine terminal equipment may be operated without a valid motor vehicle registration. While this measure may promote operational efficiencies in loading, offloading, and otherwise moving cargo, the inclusion of heavily used highways and arteries may create congestion and inefficiencies in other parts of the state's transportation system. To minimize impacts to state highways, DOT requests that the exemption as it relates to Nimitz Highway be restricted to off-peak times, from 5:30 to 8:30 a.m. and from 3:00 to 6:30 p.m. DOT proposes that item (F) be amended to read as follows:

(F) Nimitz Highway, between 8:30 a.m. and 3:00 p.m., and from 6:30 p.m. to 5:30 a.m.;

In addition, to promote further efficiencies, DOT has designed and is constructing facilities, including the Kapalama Container Terminal, that will allow cargo to move between terminals without need to travel on state or county roads thereby alleviating congestion on these roads.
