IN SUPPORT of House Bill 847

Relating to Hiking Trails; Search and Rescue; Trespassing; Reimbursement

House Bill 847 requires government entities to seek reimbursement for all or a portion of search and rescue expenses for persons who require rescue after leaving a hiking trail to enter an area closed to the public or hiking on a trail closed to the public.

The Hawaii State Aha Moku (Aha Moku) supports this measure.

Attached to the Department of Land and Natural Resources (DLNR), the Aha Moku supports any and all rescue efforts to preserve the life of individuals who hike trails where the beauty and ambiance of Hawaii's public natural and cultural resources can be shared safely. The trails are not only on land, but those that are connected to the ocean, rivers and streams on each island. DLNR provides listings of all trails on public lands stressing that hikers stay on the designated areas for their own safety. They also stress the importance of staying away from hazardous rivers, streams and coastal areas especially during rainy seasons. However, unfortunately there are those who do not adhere to the signage that keeps them safe. The result is usually catastrophic and forces first responders to risk their own lives to save those in danger at great expense to the State of Hawaii. This is not fair to the people of Hawaii who only want to share the beauty of their home with visitors, or to residents who should know better.

Seeking reimbursement for search and rescue expenses from persons who require rescue by not staying on a public hiking trail either on land or close to a dangerous coastal area will discourage dangerous practices. We ask that this committee adopt H.B. 847.

Chair Ichiyama, Vice Chair Poepoe, and members of the Committee:

The Department of Law Enforcement (DLE) strongly supports House Bill 847.

This bill changes the circumstances when an agency may seek reimbursement for search and rescue costs by providing guidance on when such costs can be recovered and requiring agencies to seek reimbursement.

State law enforcement is regularly called upon to participate in search and rescue operations for people who have ignored posted warnings, left defined hiking trails, and ventured into closed areas that have been posted. These situations are not the standard search and rescue of lost or injured persons which are anticipated and part of expected operations of first responders. These are situations created by reason of an individual's choice to ignore warnings and efforts of government agencies or private landowners to keep them safe. When first responders are called upon to engage in these types of extensive search and rescue operations, ongoing operations must be put on hold and agencies often incur additional unbudgeted costs and expense. Requiring agencies to pursue reimbursement in these situations is a reasonable requirement.

The HPD opposes House Bill No. 847, Relating to Search and Rescue. This bill requires government agencies to seek reimbursement for search or rescue expenses from certain persons if the need for the search or rescue was caused by the person's disregard of posted warnings and closure signage. The HPD opposes this bill as there is no existing mechanism to seek reimbursement for these situations. In addition, it may deter or delay prompt notification of first responder agencies by persons who may need to be rescued. Such a delay in a request for assistance could make the situation worse and further endanger the lives of those persons as well as first responders.



Aloha. I am writing in support of Bill HB847. My family and I live in an area that is impacted by illegal hikers trespassing 24/7. I witness several helicopter rescues every year. All of these rescues involve inconsiderate individuals who knowingly embark on the illegal hike. I've literally seen people read the "No Trespassing" sign and proceed to climb over the fence. Then a few hours later, we see the same individuals clutching to a rescue rope as the yellow HFD helicopter plucks them off the mountain. Social media and hiking sites are encouraging this behavior. Sites such as alltrails.com have message boards where people publicly advertise their plans to hike Haiku Stairs, Sacred Falls, and many other illegal trails around the state. These posters will include their full name, email, phone number, and day/time they plan to hike. They include this information without any fear of repercussions. So why do we have to pay the bill for those who make a mockery of our laws?

I believe this bill will go a long way to help mitigate the illegal trespassing because it introduces a substantial financial consequence. And for those who suggest that this will prevent folks from seeking emergency assistance, I would beg to differ.
