SUBJECT: HB916 Relating to Social Services

The Hawaii State Council on Developmental Disabilities **SUPPORTS HB916**, which increases the monthly needs allowance from \$50 to \$75. Clarifies that the needs allowance is not intended to replace or affect funds received from the federal supplemental security income program. Requires certain long-term care facility operators to pay for generic toiletries, linens, and meals and snacks. Requires the department of human services to perform an annual review of the needs allowance. Appropriate funds.

Increasing the personal needs allowance (PNA) will help offset the rising costs of items due to inflation. The PNA's intent is to allow individuals in care facilities to still have some monies they can spend on personal products not provided by the home. For our intellectual/developmental disability (I/DD) population that resides in these homes, this allowance also offers an opportunity to build money management skills and help build individuals' capacity to make their own choices.

The Council also appreciates expanding what items a long-term care facility must provide. Including these items as baseline for individuals in care facilities will also free up more of the monthly needs allowance for genuinely personal items. With more essentials provided, it should promote the PNA to be used for things that will create opportunities for our I/DD population in these homes to be a part of our communities and or increase their quality of life.

Thank you for the opportunity to submit testimony in strong support of HB916.

<u>**DEPARTMENT'S POSITION**</u>: The Department of Human Services (DHS) appreciates the intent of this bill, offers comments, and requests amendments.

<u>PURPOSE</u>: The bill increases the monthly needs allowance from \$50 to \$75. Clarifies that the needs allowance is not intended to replace or affect funds received from the federal supplemental security income program. Requires certain long-term care facility operators to pay for generic toiletries, linens, and meals and snacks. Requires the Department Of Human Services to perform an annual review of the needs allowance. Appropriate funds.

This measure proposes to increase the monthly Personal Needs Allowance (PNA) paid for individuals living in specified settings under section 346-D-4.5, Hawaii Revised Statutes (HRS), from \$50.00 to \$75.00 per month.

The State Supplemental Payment (SSP) appropriation is used for the following:

Domiciliary care payments, as specified in section 346-53(c), HRS;

- PNA for individuals residing in settings as specified in section 346D-4.5, HRS; and
- Administrative fees paid to the Social Security Administration (SSA) to add the SSP amounts to each individual's monthly Supplemental Security Income (SSI) check.

In State Fiscal Year (SFY) 2022, DHS coordinated with SSA, and SSA paid \$3,764,504.19 in one-time retroactive SSP payments to address "shortfalls" by increasing expenditures.

Performing these one-time retroactive SSP payments enabled DHS to comply with the Maintenance of Effort (MOE) agreement, as referenced under Title 20 Code of Federal Regulation (CFR) 416.2096.

DHS respectfully asks the Legislature to consider this \$3,764,504.19 amount as the PNA rate increases in domiciliary care home settings, a \$25 PNA increase for approximately 2,129 individuals (SFY 2022 average enrollment) would increase annual expenditures to approximately \$638,700.00. For clarification, the PNA for individuals residing in domiciliary care home settings would be added to the care rate (\$25 PNA + current care rate = increased care rate) as the caregiver is required to remove PNA from monthly SSP payments for eligible individuals.

A \$25 PNA increase for approximately 195 individuals in nursing facilities would increase the annual expenditures by approximately \$58,500.00. The current budget can cover the increase with the projected budget surplus of approximately \$581,271.60.

In SFY 2022, approximately \$444,539.49 was expended for nursing home PNA and administrative fees resulting in a remaining balance of approximately \$581,271.60.

While the one-time retroactive SSP payment (shortfall) amount of approximately \$3,764,504.19 and the budget surplus of approximately \$581,271.60 are enough to cover the \$25 PNA increases, this assumes there will be no substantial increases in the number of eligible individuals entering domiciliary care home and nursing facility settings.

In addition to 346D-4.5(c), HRS, we note that sections 346-53(c)(1) and (2), HRS, will need to be amended to reflect the PNA increase to the domiciliary care rate amounts.

Therefore, if this is the Legislature's intent, we recommend Section 346-53 (c), HRS, be amended to read as follows:

- "(c) The director, pursuant to chapter 91, shall determine the rate of payment for domiciliary care, including care provided in licensed developmental disabilities domiciliary homes, community care foster family homes, and certified adult foster homes, to be provided to recipients who are eligible for federal supplementary security income or public assistance, or both. The director shall provide for level of care payment as follows:
 - (1) Beginning on July 1, [2008,] 2023, for adult residential care homes classified as facility type I, licensed developmental disabilities domiciliary homes as defined under section 321-15.9, community care foster family homes as defined under section 321-481, and certified adult foster homes as defined under section 321-11.2, the state supplemental payment shall not exceed [\$651.90;] \$ 676.90; and
 - (2) Beginning on July 1, [2008,] 2023, for adult residential care homes classified as facility type II, the state supplemental payment shall not exceed [\$759.90.] \$.

If the operator does not provide the quality of care consistent with the needs of the individual to the satisfaction of the department, the department may remove the recipient to another facility.

The department shall handle abusive practices under this section in accordance with chapter 91.

Nothing in this subsection shall allow the director to remove a recipient from an adult residential care home or other similar institution if the recipient does not desire to be removed and the operator is agreeable to the recipient remaining, except where the recipient requires a higher level of care than provided or where the recipient no longer requires any domiciliary care."

The Medicaid program has analyzed this proposed change and concluded that Medicaid does <u>not</u> need an additional appropriation. Currently, the Med-QUEST Division (MQD) anticipates that few to no additional individuals will become eligible for Medicaid due to PNA increases. However, MQD will need to take administrative actions to implement this change.

There are beneficiaries currently living in domiciliary care homes and Community Care Foster Family Homes that are eligible for Medicaid through the "medically needy" eligibility category. They contribute some of their income to help cover the cost of their care when they have income above Medicaid income eligibility standards. Although PNA increases would reduce this contribution marginally for some of these individuals, and MQD would expend some additional dollars on their medical care, this cost would be negligible, and there would be no need for an additional appropriation.

Page 3, line 16 states, "[t]he operators of facilities listed under subsection (a) shall pay for generic toiletries, including toilet paper, hand soap, and paper towels; linens, including bedding, sheets, blankets, towels, and bath towels; and meals and snacks for outings."

Regarding page Section 2, paragraph (e), page 3, line 16, DHS recommends this section be amended to clarify that operators are not authorized to use the PNA of residents for items without resident's consent and that operators maintain records when residents authorize the use of their PNA by operators describing how the money was spent.

Regarding Section 2, paragraph (g), on page 4, line 6: "The department of human services shall perform an annual review of the monthly needs allowance to ensure the allowance provides adequate coverage. The department of human services shall submit a report of corrections or improvements to the monthly needs allowance, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of the regular session of 2024, and every session thereafter." Regarding page 4, line 6, DHS coordinates with SSA in the disbursement of SSP and PNA but does not monitor the payments. To perform this task, DHS would require additional time to develop rules and resources to cover staff and system modifications, to perform annual reviews. As the measure continues through the session, DHS will update the resource needs.
