# In consideration of HB953 RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

Chair Ichiyama, Vice Chair Poepoe and members of the Committee. The Department of Business, Economic Development and Tourism (DBEDT) would like to provide comments on HB953. This bill provides funds to DLNR to create a website that contains all the necessary applications for recreational and commercial use of DLNR lands, including film permits.

We defer to DLNR on the substantive areas of the bill. DBEDT's Hawaii Film Office (HFO) is the one-stop shop for the majority of State film permits on all islands. HFO has been working with the state's designated vendor, NIC, for the past year to create an online Standard Film Permit application. This online application is targeted to go live in March 2023. We recommend DLNR integrate this film permitting system, into the new website, rather than creating a separate film permit application. This provides both agencies and the public they serve with one central online portal. Both HFO and DLNR can provide a link on their respective sites to further provide information and application processes for all applicants.

## In consideration of HOUSE BILL 953 RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES

House Bill 953 proposes to require the Department of Land and Natural Resources (Department) to develop and publish a website that includes the application processes for a permit, license, or reservation needed to conduct recreational and commercial activities in the State that are regulated by or under the jurisdiction of the Department. The bill also proposes to require the Department to convert existing application processes into a digital format for the website and appropriate funds for establishing the website. **The Department supports this measure with an amendment**.

The Department recognizes that user experience (UX) website design entails intuitive navigation, visual presence, and content that offers consistent user interfaces for computer interaction. Designing a website that clarifies applications and forms organization to achieve a desired hierarchical user flow is the goal expected to simplify access to the Department's online services. As detailed in House Bill 953 (SECTION 2), this project's scope provides an opportunity for a long-term strategic approach that can be accomplished in collaboration with a technology solutions company and the Department's division subject matter experts. The success of the new website re-design and upgraded functionality for various permits, licenses, reservations, and the conversion of existing application processes and forms requiring fee payments will require a multi-year, multi-phase effort to plan, develop and implement a coherent and consistent framework across the ten divisions. The process should include strategic data consolidation, electronic workflows for both the public and department user groups, electronic payments, and replacement of aging code bases. The extensive effort required to plan, implement, and maintain a solution that meets the specifics of this bill, benefitting residents, visitors, and commercial operators, is suggested to begin with a phased approach. To adhere to the intent of House Bill 953, we are

Accordingly, we respectfully request that SECTION 2 of the bill be amended by deleting the requirement that the new system be operational by December 31, 2023 and instead, replaced with a requirement that the Department report on the status of the aforesaid project at the start of the next legislative session. The Department respects the website improvements identified in House Bill 953 that advance government engagement.
