Legislators – I urge you to support HCR78/HR 82: URGING THE DEPARTMENT OF FACILITY MAINTENANCE OF THE CITY AND COUNTY OF HONOLULU TO CONDUCT AN ASSESSMENT AND PREPARE AND EXECUTE A PLAN TO MAINTAIN MANOA STREAM.

I am a concerned resident of Manoa Valley who witnessed the devastation of the 10/30/2004 flood that caused millions in dollars of damage to cars, homes, and the University of Hawaii. A lack of maintenace of the stream was a contributing factor as debris upstream caused a dam at the Woodlawn bridge, which then resulted in a rush of water being diverted onto the road and into areas that would not have been affected had the stream been maintained.

While it would be easy to assume that residents who live along the stream can/should be maintaining their property and ensuring it is free of debris, this is ultimately unrealistic given the confusing and often conflicting rules that residents must navigate through in order to determine what they can/not do. And this lack of clarity has made many residents hesitant and reluctant to taking action — and the result is a poorly maintained waterway that is going to present on-going risk of another disaster given the unknown consequences of erratic weather due to global warning.

The only well-maintained area of the stream fronts Manoa District Park and the Manoa Senior home, and this should be continued all the way up to the State-owned land in the back of the valley. A one-time, thorough clean-up of the large invasive trees (like the Albizia) would be greatly beneficial. And I can guarantee you that there are willing/able community organizations and volunteers who will plant indigenous flora that can/will flourish and help to maintain the natural flow of the water as well as ensure invasive species are removed regularly. This kind of public/community partnering effort would also be a positive step forward in achieving some of the goals of the Ala Wai Watershed project without major reconstruction or redirection of water – and it would be great if some of that funding could be used to perform the needed maintenance as it is a way to mitigate future risk.

We need bold and decisive action – and some creativity – so that we can make progress and not let any kind of deferred maintenance put the residents along the stream as well as businesses and schools downstream from being severly impacted when the next major flooding event occurs – and it is not a matter of 'if' but 'when' that will happen. I humbly submit this testimony and ask for your support of HCR78/HR82 – and, more importantly, develop a practical and sustainable approach to maintaining the stream.
