

Chair Dela Cruz and Members of the Committee:

The Department of the Attorney General provides the following comments on this bill.

This bill establishes within the Department of Hawaiian Home Lands (DHHL) a rent-with-option-to-purchase pilot program on the Leeward Coast of Oahu to assist beneficiaries on DHHL's homestead lease applicant waitlist who are homeless or threatened with homelessness. The program would provide those beneficiaries with micro housing units under a rent-with-option-to-purchase arrangement, as well as other support services. For clarity, we recommend the following amendments to the bill.

The bill, on page 3, lines 10-13, authorizes DHHL to purchase lands and determine which lands to use for the pilot program "pursuant to chapter 91, Hawaii Revised Statutes." Chapter 91 establishes statutory requirements for agency rulemaking and contested cases; it does not establish land acquisition or land use procedures for DHHL. We therefore suggest striking the language referring to chapter 91, HRS, at page 3, lines 12-13.

The bill, on page 3, lines 14-16, requires DHHL to establish necessary terms and conditions to facilitate the transfer of ownership of rent-with-option-to-purchase units to participants of the pilot program "upon the expiration of the lease and the exercise of the option to purchase." When a program participant exercises their option to purchase, however, they would presumably reside in their purchased unit under a long-term

homestead lease issued pursuant to section 207, Hawaiian Homes Commission Act, 1920. To provide greater clarity, we suggest replacing the aforecited wording at page 3, lines 16-17, of the bill with "upon expiration of the rental term and the exercise of the option to purchase."

The bill, on page 4, lines 15-18, allows the micro housing units to be used for affordable housing "through a deed restriction, easement, or other legally binding measure." However, because DHHL will presumably retain ownership of the lands upon which the micro housing units are developed, deed restrictions and grants of easement for affordable housing uses are unnecessary. As such, we recommend replacing the aforecited wording at page 4, lines 15-18, of the bill with "as may be determined by the department."

Finally, the bill, on page 6, lines 10-13, defines "threatened with homelessness" as lacking the resources to maintain the mortgage and other expenses "associated with owning a traditional department of Hawaiian home lands property." However, because DHHL administers a homestead leasing program and does not dispose of homestead properties to beneficiaries in fee simple, we suggest replacing the aforecited wording at page 6, lines 12-13, of the bill with "associated with maintaining a residence."

Aloha Chair Dela Cruz, Vice Chair Keith-Agaran and Committee Members,

I am writing in support of SB1040 and to offer comments, but I defer to the Department of Hawaiian Homelands (DHHL) on all matters of implementation.

The need to house Native Hawaiians experiencing homelessness is urgent and acute. As Section 1 of the bill points out, half of all people experiencing unsheltered homelessness (i.e., those on our sidewalks and parks) are Native Hawaiian. For the first time, in 2022, the annual Oahu Point in Time Count census of people experiencing homelessness (Oahu PIT Count) asked unhoused individuals whether they were eligible beneficiaries of DHHL. On a self-reported basis, 44% of homeless Native Hawaiians on Oahu reported being eligible for a Hawaiian Home Lands Lease, and 15% reported already being on the wait list for Hawaiian Home Lands.

Often, people who are experiencing homelessness may be deemed ineligible for housing due to narrow or restrictive definitions of what it means to be "homeless" and the documentation required to verify their homelessness. For example, many existing homeless programs target the "chronically homeless," i.e., individuals with a diagnosed physical disability, mental illness, or addiction and who are verified as being homeless continuously for at least twelve months" (HRS §346-378). Many homeless people do not meet this definition, and others struggle to obtain the documentation required to prove it. Further, any homeless individual who enters a hospital, treatment program, or jail for ninety days is no longer "chronically homeless," even if discharged back to the street.

If the intent of this bill is to enable elderly, homeless DHHL beneficiaries to obtain housing, then I recommend amending the definitions in Section 2.(h) to read as follows:

#### "Homeless" means "Homeless" means:

- (1) An individual or family who lacks a fixed, regular, and adequate night-time residence; or
- (2) An individual or family who has a primary night-time residence that is:
  - (A) A supervised publicly or privately operated shelter designed to provide temporary living accommodations;


(B) An institution that provides temporary residence for individuals intended to be institutionalized; or

(C) A public or private place not designed for or ordinarily used as sleeping accommodations for human beings.

"Threatened with homelessness" means lacking the resources to maintain the mortgage, utility, taxes, or other expenses associated with owning a traditional department of Hawaiian home lands property; or, scheduled for discharge from a hospital, release from a jail or prison, or emancipation from foster care into homelessness."

Aloha,

At the initial hearing of SB1040, Relating to Homelessness, I enthusiastically gave testimony in support. The intent of the bill seemed sound providing opportunity to native Hawaiian beneficiaries, who are on the DHHL waitlist with the opportunity to rent-with-option-to purchase.

However, I now note several testimonies from Homestead beneficiaries who oppose the bill concerned that the action proposed by the bill is a breach of the Hawaiian Homes Commission Act and may be contrary to the intent and purpose of Act 279 to reduce the waitlist. I believe the concept of providing opportunity to waitlisted native Hawaiians with the opportunity to rent with option to purchase would help to eventually reduce the wait list.

However, the problem is using this option as a means for reducing homeless and the ability of DHHL to provide all of the social services necessary to support such individuals. Further, it is highly unlikely that homeless who can ill afford rentals now will eventually qualify for mortgages to purchase homes.

I note also the testimony of Ikaika Anderson, then chairman-designate of the Hawaiian Homes Commission that stated, "The department appreciates the intent of this measure and supports the kauhale concept, recognizing that the department has focused on the development of homestead lots for award to beneficiaries. **DHHL has recently begun to analyze the number of beneficiaries who are homeless and has a request for proposals (RFP) out for rehabilitation and renovation of a building in Kalaeloa for use as a temporary transitional housing for homeless native Hawaiian beneficiaries.** If the Legislature prefers a kauhale pilot program, DHHL is interested in working with the Legislature on such opportunities for beneficiaries." (Bolded for emphasis).

Thus, it appears that the Hawaiian Homes Commission is addressing the need for temporary housing for homeless native Hawaiian beneficiaries.

The proposed Kauhale Program, as a means to help waitlisted beneficiaries to rent to own has merit and I continue to support it, but suggest that the bill should be further vetted with DHHL and homestead beneficiaries. Too, I am concerned with any exemptions from laws that protect the environment and Hawaiian cultural sites.
