Chair Yamashita, Vice Chair Kitagawa, and Members of the House Committee on Finance.

The Office of Planning and Sustainable Development (OPSD) offers <u>comments with</u> <u>strong concerns</u> on SB 1136, SD1, HD1, Relating to State Parks.

OPSD appreciates the intent of SB 1136, SD1, HD1, to address the complaints of Maui residents who have been unable to find parking spaces at Makena State Park. However, OPSD is concerned that carrying capacity studies are not the most effective way to improve the parking situation at Makena State Park for residents. OPSD agrees with DLNR that implementing parking improvements to reserve a sufficient number of free parking spaces for residents would be much quicker with better results.

If the House Committee on Finance is inclined to move this measure forward for further discussion, OPSD respectfully requests that the term "carrying capacity study" be replaced with "parking improvement analysis and actions" and OPSD be replaced with DLNR wherever these terms occur in the HD1.

OPSD defers to DLNR for other strategies to improve the parking situation at Makena State Park.

In consideration of SENATE BILL 1136, SENATE DRAFT 1, HOUSE DRAFT 1 RELATING TO STATE PARKS

Senate Bill 1136, Senate Draft 1, House Draft 1 proposes to require the Office of Planning and Sustainable Development to conduct a study of the carrying capacity of Mākena State Park in Maui County and appropriates funds. The Department of Land and Natural Resources (Department) respectfully does not believe the study is necessary and provides the following comments.

The Department appreciates this measure's intent to better support Mākena State Park, agrees that the parking situation needs to be improved and spaces need to be set aside for local residents, and asks that State Parks be allowed to keep its focus on implementing parking improvements rather than diverting staff time to conduct or oversee a study. State Parks has never performed a carrying capacity study for the 3 park units, including Ha'ena State Park, Wai'ānapanapa, and Diamond Head State Monument that currently have advanced reservations.

The Department is initially addressing the Mākena parking situation with paving and striping of the shoulder areas of the entry road that now get congested with parked cars. The Department is examining an exterior fence option to restrict access from outside the park boundary – a prerequisite to an advanced reservation system. The other 3 park units with reservations have a single control point for entry, reserve sufficient stalls for local residents, and keep parking free for local residents.

When State Parks rebids the parking contract by the end of the year, a reservation system based on lot turnover can be established that sets a temporal capacity over the span of a day and will ensure that there will always be parking for local residents as well. These limits can be adjusted to allow for more resident parking and entry on weekends and holidays to support free, non-reservation-based access for our local residents. We believe this is a more prudent course of action to establish a parking reservation system at Mākena.

Aloha Chair Yamashita, Vice Chair Kitagawa, and members of the committee. Thank you for hearing this important bill.

In the 1980s when the Wailea-Mākena area began experiencing rapid growth, developers made plans to build beachfront condos at Oneloa (or Big Beach), which was then a long, isolated stretch of sand surrounded by kiawe. Realizing what was at stake, citizens began a successful effort to convince the Legislature to acquire the land. The result is Mākena State Park, now one of the most popular beach parks on Maui. The waters offshore are still some of the cleanest in the state, and endangered hawksbill turtles are known to nest there.

Today this park is under immense pressure as a result of increasing tourism numbers. Residents are often unable to find parking, as every available space is often taken up. As a result, people are parking outside the paved parking areas, and State Parks' proposed response has simply been to try to accommodate that demand by paving new parking areas without knowing the capacity of this beautiful natural area to absorb impacts. A carrying capacity study is needed to determine whether the Park's environmental, cultural, psychological or social carrying capacity have been exceeded. If such a study is not conducted, Mākena State Park will be at risk of losing its 'sense of place' due to the impacts of overtourism on the ecosystem andlandscape. Many would argue that this has already occurred, but there is no objective way of knowing without conducting a carrying capacity study.

The Division of State Parks has already taken action to manage overtourism on Kaua'i, through its adoption of the H \bar{a} 'ena State Park Master Plan. This plan aims to improve the long-term management of the park and visitor satisfaction by implementing transportation and parking management practices; as well as establishing a target for a reduction in the number of daily visitors.

Similarly, in recent years crowding at Waianapanapa State Park near Hāna had impacted the adjacent community and overall visitor experiences. In response, a reservation system was launched, with fees for visitor entry and parking, while Hawai'i residents are still able to park there for free.

On the State Parks web site for Waianapanapa, State Parks Administrator Curt Cottrell is quoted as saying, "Quality over quantity is our new target in management." Mākena State Park deserves the same consideration, and a carrying capacity study for this park will be a good first step.

The Office of Planning and Sustainable Development has conducted several carrying capacity studies in the past, and is an appropriate choice to perform this study as well.

I urge you to support this important bill.
