This new authorization will include building a milling facility to meet the cooperative processing needs of the growing Maui coffee industry, in other words, it will be designed meet the processing needs of All Maui Coffee growers large and small. It will meet the public interest as a Hawaii brand builder and further diversify Maui County's agricultural productivity.

SB-1223 is a request to re-authorize Act 116 for another 5 years. The effort to find bond funding during the original bond period that expired in 2022, was sidelined from the effects of Covid-19. It can take years to set everything up to achieve a successful bond offering.

Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 1223, which authorizes a new issuance of special purpose revenue bonds in the amount of \$30 million, to assist MauiGrown Coffee, Inc. with the operation and expansion of its farm and mill.
