EOA's Position: The Executive Office on Aging (EOA), an attached agency to the Department of Health, strongly supports the SB1372, Relating to the Executive Office on Aging Kupuna Care Program.

Purpose and Justification: The purpose of this bill is to clarify the definitions of "caregiver support services", "kupuna care services", and "respite care" in section 349-16 HRS.

In 2022, Act 160 combined the Kupuna Care and Kupuna Caregiver programs. Currently, as written, the definitions for "caregiver support services" and "respite care" only apply to employed caregivers. This measure will allow for all caregivers (employed and not employed) to receive caregiver support services and respite care. Additionally, the definition for "Kupuna care services" will be amended to be available to all care recipients, caregivers and employed caregivers.

I am Roberta Wong Murray, Chair of the Policy Advisory Board on Elder Affairs (PABEA), an appointed board which serves to advise the Executive Office on Aging (EOA).

On behalf of PABEA, I am submitting written testimony in favor of SB1372, which clarifies those individuals eligible to receive Kupuna Care funds.

SB1372 adds 'caregiver' as a separate and distinct category to the current 'employed caregiver' and 'care recipient' designations.

PABEA believes that the greater majority of the 155,000 caregivers in the state fall into the category of caregivers who provide 24/7 caregiving duties to a spouse, family member or loved one at home without compensation. Many of these unpaid caregivers are themselves kupuna.

SB1372 thus would allow the Area Agencies on Aging to provide not only stipends but also respite care to unpaid caregivers.

Please pass SB1372.
