Chairs Kim and Moriwaki and Members of the Committees:

The Department of the Attorney General provides the following comments.

The purpose of this bill is to require the University of Hawai'i to submit an annual report to the Legislature of all University of Hawai'i employees who performed work from a location outside of the State during the applicable year.

Section 6 of article X of the Hawai'i State Constitution gives the Board of Regents of the University of Hawai'i "exclusive jurisdiction over the internal structure, management, and operation of the university." Section 6 further provides: "This section shall not limit the power of the legislature to enact laws of statewide concern. The legislature shall have the exclusive jurisdiction to identify laws of statewide concern." If the Committee decides to pass this bill, we recommend an amendment that adds a preamble that includes a statement identifying this bill as a law of statewide concern.

By operationalizing this report on an annual basis, the University will have to design and implement an IT solution.
