S.B. 1430 RELATING TO MOTOR VEHICLES

Senate Committee on Transportation and Culture and the Arts

The Department of Transportation (DOT) **opposes S.B.1430** which repeals motor vehicle safety inspections requirements for certain motor vehicles.

Our Periodic Motor Vehicle Inspection data for the number of vehicles that failed show that even newer vehicles, 2 years old, had a failure rate averaging 15 percent (see table below for additional years). This demonstrates the need to have safety checks annually, to identify and correct broken equipment (headlights, taillights, tires) that may contribute to a preventable motor vehicle crash. Additionally, stalled vehicles often cause delays for roadway users. Every minute that a lane remains blocked during peak travel time results in 4 minutes of delay, during and even well after the lane is cleared.

TESTIMONY BEFORE THE SENATE COMMITTEE ON TRANSPORTATION AND CULTURE AND THE ARTS ON SB 1430 RELATING TO MOTOR VEHICLES

Aloha Chair Lee and committee members. I am Gareth Sakakida, Managing Director of the Hawaii Transportation Association (HTA) with over 350 transportation related members throughout the state of Hawaii.

Hawaii Transportation Association has concerns with this bill.

Our primary concern is older vehicles that are 10,000 lbs. GVWR and under should be inspected. We do not know where that age threshold should be, but perhaps the inspection stations could weigh in on that.

Certainly a vehicle which "is in such unsafe condition as to constitute a menace to the public or is not equipped as required and cannot reasonably be restored to a safe condition as required in this part," should be inspected. However that could not be enforced if there is a blanket exemption for the lighter vehicles.

I am in support of this bill as I believe vehicle safety inspection is does not provide a benefit to Hawaii drivers nor does it increase safety and it is actually causing the state to lose out on tax revenue from vehicle registration fees.

The first reason I say this, is that during the COVID-19 pandemic the State of Hawaii suspended the safety inspection requirement, however the auto repair business was deemed essential. I believe if safety inspection was necessary it should have been deemed essential. It was not deemed ESSENTIAL.

The second reason I am in support of this bill is due to the fact that of all requirements needed to legally operate a vehicle in the state of Hawaii the most severe penalty is for lack of insurance. No license, expired safety & registration are all monetary citations. No insurance can result in arrest and the monetary fine is significantly higher than the other offenses. What this tells Hawaii drivers is that above all else insurance is the most important thing you need.

My last reason is the over 5,000 citations issued to drivers. Currently a valid safety inspection is needed to update vehicle registration. Two separate transactions are needed to keep vehicles legal in this state. Without a valid safety you cannot update registration resulting in the backlog we see now. By repealing safety inspection and allowing drivers to register vehicles with valid insurance, the result would be a significantly higher amount of updated registrations which in turn equals an increase of tax revenue collected by the state. Bottom line a \$25 transaction is blocking vehicle registration fees from coming into the state.


