Dear Chair Dela Cruz, Vice Chair Keith-Agaran, and members of the committee:

The Office of Enterprise Technology Services (ETS) is the State agency charged with information technology (IT) governance for the executive branch as well as maintaining and operating Hawai'i State government's enterprise IT, network and telecommunications infrastructure and services.

ETS **strongly supports this bill** and the vision of a new multipurpose IT facility within the First Responders Technology Campus and Cybersecurity Data Center that offers sufficient space to consolidate government IT operations as required by Act 179 SLH2022; is flexible to meet changing future technologies; is located near the statewide electrical and secure commercial communication infrastructure; and is close to collaborating State and local government agency partners.

Further, as ETS' 40-year-old facilities are in the flood-prone Kalanimoku building basement, moving to a modern above-ground location in the new campus would ensure government IT operations could continue in the case of a major disaster.

Aloha Chair Dela Cruz, Vice-Chair Keith-Agaran, and members of the committee:

I am James Barros, Administrator of the Hawai'i Emergency Management Agency (HI-EMA).

The HI-EMA provides written testimony to **SUPPORT** Senate Bill 1469.

SB1469 appropriates funds for the development of the First Responder Technology Campus and Cybersecurity Data Center. When complete, the campus would provide facilities serving multiple agencies, including our own.

The existing headquarters complex for HI-EMA at Diamond Head dates to World War I, which creates complications and costs that impact our ability to fulfill our mission.

HI-EMA has been the beneficiary of federal and State funding that has advanced the design process that ultimately could deliver a new State Emergency Operation Center, with the eventual site envisioned at the First Responder Technology Campus. The campus site is situated out of the hurricane and tsunami inundation zone and would enable a more flexible and modern approach to emergency management.

We ask for your support of this bill, provided that its passage does not replace or adversely impact priorities indicated in our Executive Budget.

Chair Dela Cruz, Vice Chair Keith-Agaran, and Members of the Committee, thank you for the opportunity to testify on S.B. 1469. The Department of Accounting and General Services (DAGS) strongly **supports** this bill and offers the following comments:

1. Relocating emergency management and first responder operations and facilities outside of inundation zones is necessary to ensure the continuity of government operations in support of our residents particularly during times of crisis. State, county, and federal emergency management operations and first responders must be focused on their missions in support of our citizens and not have the

added burden of evacuating their own facilities because they are in vulnerable locations.

- 2. Existing facilities that support critical government operations are outdated, inefficient, and vulnerable. Development of this campus and data center will allow the State to take advantage of new building technology, energy efficient systems, and ensure resiliency in the face of disaster.
- 3. The synergy created by having similar operations in close proximity to each other would allow agencies, at all levels of government, to share resources, increase coordination, improve training, and enhance the overall response to the growing potential threats that exist today and in the future.
- 4. Our existing Enterprise Technology Services (ETS) facilities are located in a vulnerable location. Moving the operations and equipment to a modern, safe, and secure site, such as the proposed technology campus, would further ensure our ability to support departments, agencies and the community that rely on the data and services provided by ETS during disasters.

The funding and development of this campus and data center will signal the State's investment in the necessary infrastructure and facilities thereby ensuring the readiness and responsiveness of our first responders. It is for the above-mentioned reasons that we humbly request your support for this request.

I am Co-Founder of the Hawaii chapter of 350.org, the largest international organization dedicated to fighting climate change. 350Hawaii.org is in **strong opposition to SB1469** that would appropriate funds for the development of the First Responders Technology Campus and Cybersecurity Data Center.

UNDERMINING FOOD SOVEREIGNTY EFFORTS

Hawaii already relies too heavily on imported food. Efforts should be focused on fostering food sovereignty, not spending money to develop a "Technology Campus" on 243 acres of agricultural land. It is noted that construction would cost between \$315–470 million, including \$50 million in state funds. Our tax dollars need to be put towards real solutions that truly help us build our resiliency to the climate crisis and don't take away needed agricultural land.

UNDERMINING WATER CONSERVATION EFFORTS

Parts of Oahu are already experiencing drought conditions as a result of the effects of global warming. Oahu's sole-source aquifer has been further compromised by the jet fuel leaks from the Navy's Red Hill Bulk Fuel Facility. As a result, the Board of Water Supply has been urging for dedicated water conservation efforts. This misguided Technology Campus project would include a new well for water use (using an estimated 249,700 gallons/day, plus another 228,600 gallons/day of nonpotable water for an onsite fire-fighting training facility), and wastewater infrastructure to process an estimated 1,018,215 gallon/day. All of this, at a time when Oahu is experiencing a water crisis, is completely unacceptable.

A CASE OF GREENWASHING

SB1469 is nothing more than a classic example of greenwashing in its portrayal to be a response to the impacts of global warming. We don't need to be building a "Technology Campus" with a 2,000-space parking garage; a privately developed hotel/dormitory; a vehicle wash facility; a fitness area and pool; warehouses; office buildings; and an indoor shooting range on 243 acres of agricultural land to help Hawaii mitigate the climate crisis. We don't need any of that to prepare for sea level rise and other impending climate disasters. What we need is vital public infrastructure upgrades, a sustainable food system, truly affordable housing, and a transition to 100% clean, renewable energy.

Don't waste our money on ill-advised projects like this. We urge you to OPPOSE this misguided bill.

On behalf of Our Revolution Hawaii's 5,000 members and supporters statewide, we stand in STRONG OPPOSITION of passage of SB1469 that appropriates funds for the development of the First Responders Technology Campus and Cybersecurity Data Center.

First the Hawai'i Technology Development Corporation's statutory purpose is to "facilitate the growth and development of the commercial technology industry in Hawai'i" and to develop a "local, commercialized innovation research and technology workforce."

By the definition above the proposed First Responders Technology Campus and Cybersecurity Data Center's detailed description as stated in SB1469 does not fulfill the Hawai'i Technology Development Corporation's statutory purpose, because it will not facilitate the growth and development of the commercial technology industry nor will it develop a commercialized innovation research and technology workforce.

Second the proposed project would include: a new well for water use (est. 249,700 gal/day, plus another 228,600 gal/day of nonpotable water for an onsite fire-fighting training facility), and wastewater infrastructure to process an estimated 1,018,215 gal/day. At a time when the island of Oahu is already experiencing a drought due to the effects of the growing Climate Crisis that may continue for years, and a water contamination crisis as a result of the Navy's Red Hill Bulk Fuel Facility that may permanently close down some of our wells, our aquifer simply cannot sustain the project.

Dear Members of the Legislature:

I am writing to **strongly oppose SB1469** which relates to the first responders technology campus and cybersecurity data center. I am opposed both to the content of the proposed bill as well as the short-circuited process being used to rush this bill through the Senate. The bill's content and process goes against key Hawaiian values of our society to protect the *aina* and the people and to be *pono* as far as all involved.

This bill would appropriate \$50 million in taxpayer dollars to develop a First Responders Training Campus for 19 state and federal agencies including police, the FBI, and Homeland Security. I oppose this measure for the following reasons:

Immediate impacts on community: This project will have significant impacts on the Launani Valley and Wahiawa Communities, as the massive campus will be accessible only from a two lane road, in an area where traffic at intersections is already a problem for residents.

Environmental concerns: These 2 parcels are located on former agricultural lands that are now covered by dense forest. Construction alone would emit at least 60.5 tons of CO per year (based on conservative estimates) for at least 5 years for just the first phase of this massive project. Most importantly, a new well for water use will likely need to be drilled, along with associated pipelines and necessary road extensions. In the middle of an unparalleled water crisis, we should not be misallocating our water resources.

Climate preparedness: The Draft EIS states that the project is needed to ensure that the facilities of involved agencies are safe from the impacts of climate change. However, if climate resiliency is our concern, then the project's massive budget could be better used to invest in alternatives that help our communities prepare and care for each other in the face of climate emergency. We want to see this funding directed toward building sustainable food systems, developing community preparedness, and promoting the health of our native ecosystems and watersheds.

Fund Communities not Cops: I am tired of taxpayer dollars being spent on policing and militarization of the State rather than on community needs. The State Department of Public Safety received \$528 million in general funds in 2022. Meanwhile the Department of Education received \$74 million, and the Department of Agriculture received just \$24 million, which is just

half of what this project demands in state funding alone. That means that this bill is asking taxpayers to spend more on a single facility than we do on developing our food systems in an entire year.

Diversification of Hawai'i's Economy beyond tourism and the military: As the Covid-19 crisis has clearly demonstrated again, the State of Hawai'i must diversify its economy. The State already relies far to heavily on tourism and the military. We do not need further investment in the military and police. The funds that would be appropriated for this firsts responders campus should be used to diversify our economy in the areas of sustainability and addressing the climate disruption crisis.
