TESTIMONY IN SUPPORT OF SB-1482 RELATING TO AEROSPACE.

Dear Chair Dela Cruz, Vice Chair Keith-Agaran and members of the Committee:

I am writing in support of Bill SB-1482 which establishes the Aerospace Development Office in Hawai'i within the Hawai'I Technology Development Corporation (HTDC).

Given its unique geographical advantage, Hawai'i has strong potential for becoming a main player in the development of the Aerospace and Aeronautics industry. Creating an Aerospace Development office, solely dedicated to promoting the Aerospace Industry by attracting companies to establish operations in Hawai'i can be of great benefit to the state's economic recovery post COVID. It will help diversify our industrial portfolio so we're not so dependent on tourism.

Potential industries that could benefit from Hawai'i include small satellite manufacturing, small vehicle launch operations, Unmanned Aerial Systems, Space Tourism. Having an aerospace industry cluster will also benefit our universities and community colleges creating career pathways for our students who currently find limited employment opportunities in this industry in the State.

However, for this office to succeed, it will require full support from the State at the Legislative, Executive and County levels to help attract companies to the state. It is also important to point out that funds for this office should not be taken away from funds used for the Pacific International Space Center for Exploration Systems (PISCES) which Is now within UH Hilo and continues to produce ground breaking research in planetary exploration.

Finally, I would suggest that the term "Aeronautics" be added to the name of this new office (Aerospace and Aeronautics Development Office – AADO) in order to better cover areas that are not strictly related to aerospace.

Your affirmative consideration of these bills will be deeply appreciated.
