Testimony of the Hawai'i State Ethics Commission in SUPPORT of
SB 1493, SD1 -- Relating to Lobbyists, with a PROPOSED
AMENDMENT

Aloha Chair Tarnas, Vice Chair Takayama, and Committee Members:

The Hawai'i State Ethics Commission ("Commission") supports SB 1493 SD1, which prohibits lobbyists from making or promising campaign contributions during the legislative session. This measure could be an important step towards reducing the appearance of undue influence by lobbyists. It would send a strong message that Hawai'i is committed to upholding high ethical standards and promoting fair and open government.

On a pragmatic level, there may be situations where an individual engages in lobbying activity, but fails to register as a lobbyist. To ensure candidates are not caught off-guard by an unregistered lobbyist, we respectfully suggest that this measure be amended to prevent candidates from receiving contributions from a <u>registered</u> lobbyist.

Proposed Amendment: On page 3, line 13 should say:

"Lobbyist" shall mean any lobbyist actively registered with a state or county ethics board or commission.

A similar amendment should *not* be made to Haw. Rev. Stat. chapter 97 (page 4, line 11). A lobbyist, regardless of whether they are registered or not, can be prohibited from making a campaign contribution during session (assuming this measure were to pass). This avoids a perverse incentive not to register.

Mahalo for your continuing support of the Commission's work and for considering its testimony on SB 1493 SD1.

### SUBJECT: Testimony on S.B. No. 1493, SD1, Relating to Lobbyists.

Thank you for the opportunity to testify on this bill. The Campaign Spending Commission ("Commission") supports this measure.

Section 2 of this measure adds a new section to the campaign finance laws to prohibit a lobbyist from contributing to an elected official or making an expenditure on behalf of an elected official, during any regular or special session of the Legislature, and for five calendar days before and after a session. The Commission recommends that Section 2 be amended by adding the following sentence to the end of page 3, line 9:

"Any contribution prohibited by this subsection shall escheat to the Hawaii election campaign fund."

Section 3 of the measure makes the same amendment to Hawaii Revised Statutes §97-5, pertaining to restricted activities of a lobbyist. The Commission believes this bill will prevent corruption and the appearance of corruption.

The Commission requests this Committee to pass this measure with the above-stated amendment and with an effective date upon approval.
