Thank you for the opportunity to testify on this bill. The Campaign Spending Commission ("Commission") supports the intent of this bill.

This bill establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices to beginning with the 2024 general election year, appropriates funds to the Hawaii Election Campaign Fund, and appropriates funds to the Commission.

The bill establishes the maximum amount of comprehensive public funds ("CPF Max") for each office. The CPF Max ranges from a low of \$20,000 for candidates for the Board of Trustees for the Office of Hawaiian Affairs ("OHA") to a high of \$2,500,000 for candidates for Governor. However, as a percentage of the amounts spent by winners, or an average spent by winners, for office in recent elections, these amounts range from a very low of 49% (\$20,000/\$41,013.45) for candidates for OHA to a high of 133% (\$20,000/\$15,062.42) for candidates for Hawaii County Council. The Commission urges this Committee to increase the CPF Max for candidates for OHA to \$40,000 (97.5%).¹

In order to qualify for comprehensive public funding, the bill establishes the minimum number of qualifying contributions each candidate must receive from registered voters residing within the respective district from which the candidate seeks nomination or election to office. It appears that the minimum number of qualifying contributions is equal to .25 percent of the CPF Max for each office, except for the Senate and House of Representatives, where the minimum number of qualifying contributions is .20 % of the CPF Max for those offices. Although the Commission is still considering whether the minimum number of qualifying contributions for all offices is sufficient, the Commission urges this Committee to at least raise the minimum number of qualifying contributions for candidates for the Senate from 200 to 250 and the minimum number of qualifying contributions for candidates for the House of Representatives from 100 to 125.

Finally, section 4 of this measure requires the Commission to submit a report to the Legislature in the 2024 session of the Commission's findings and recommendations, including any proposed statutory amendments that may be necessary to implement the comprehensive public funding program. Because of this mandate and because the Commission will have to work on forms, make modifications of its electronic filing system, and train candidates, the Commission urges this Committee to begin the comprehensive public funding program with the 2026 general election.

The Commission requests that this committee pass this measure with the described amendments.

Members of the Judiciary Committee:

Thank you for the opportunity to testify on this important issue. It's crucially important that we remove the impact money has on our elections. We instead need a robust clean elections system that HB967 would provide.

We Need Money Out Of Politics Now

The influence that money has on our elections needs to end. A system that requires candidates to raise private funds is simply legal bribery. If we want our government officials to act on behalf of its residents rather than those who fund their campaigns, we need to end the current system.

Money is incredibly crucial in our elections, as candidates who outspend their opponents win at a 91% rate. Of all campaign donations candidates received in the 2022 election cycle, over half of the money was given by just 980 donors who gave at least \$6,000 each. This massive political power by a small group is not democratic.

Too many candidates are reliant on their donors to stay in office and an even larger number of potential candidates don't have the wealthy donor connections that are needed to win. This is a formula for uncompetitive elections and elected officials that respond to a few private interests rather than the public at large.

It's Well Past Time for Clean Elections

In order to get money out of politics, we need to provide a pathway for candidates to win without private campaign donations. HB967 would do just that. HB967 would establish a clean elections program that would allow participating candidates to receive enough public funds to win their elections and ban them from receiving any private donations.

Hawai'i County Council races had a very successful clean elections program in 2010 and 2012. Both Connecticut and Maine have statewide clean elections programs that are hugely popular. Over 60% of all legislators in Maine participate in their clean elections program and receive no private donations. Connecticut's system was established as a response to their huge corruption scandals.

If we are serious about ending the corruptive practices that plague our state we need to establish a clean elections program now.

Hawaii Holding Power Accountable

In strong support of SB1543

A reform like public financing has been due in Hawaii for many years. With last year's convictions of Senator J. Kalani English and Representative Ty Cullen for cash bribes, ethics in our state government has leapt to the front of the public's collective mind.

Some incumbents dislike public financing because they see it as a threat to their reelection. This is not necessarily the case. The 2012 Maine Policy Review found that "challengers are only more likely to win if they participate in MCEA [the 1996 Maine Clean Elections Act] and the incumbent does not. When incumbents accept public funding, they are actually more likely to win reelection" [1].

SB1543 is a fair bill. It includes every major state and county office, not singling out any one group for a trial, as some previous bills have done. After qualifying, candidates are "barred from soliciting, accepting, or using contributions from" anyone but voters in their districts. Violating the rules brings appropriate penalties, and thorough, regular reporting requirements should prevent abuse.

Publicly-funded elections will make you and future elected officials better at your jobs. You can spend your time meeting with many constituents, not just a few large donors. Owing only your voters lets you take a principled stand on every issue. You can work on the needs of all voters, not just a few moneyed interests. And you can spend more time doing your real job.

To qualify for public financing, candidates must show a broad base of support in their community (something incumbents already have). That makes any lawmaker more effective and more respected.

Public financing will make your campaign easier. No one likes asking individuals for large sums of money. Public financing will free you from fundraisers and countless phone calls. And the steps required to qualify will help you get to know your constituents better, so you can better speak to their concerns.

It will improve the state legislature overall. Public financing has been shown to increase the diversity of candidates, including women and people of color, and to encourage interaction between candidates and low- and moderate-income communities. Our elected officials will no longer be just career politicians or people who know the right people, but regular folks from all walks of life—nurses, veterans, small business owners, teachers. Candidates can spend more time on ideas and less time

raising money that tends to commit them to special interests.

SB1543 will serve the people who elected you far better than the current system. One of the primary reasons for public funding is to avoid situations like Oahu's rail boondoggle, and the myriad more subtle ways voters' money is wasted. The role of special interests in government decision making will be greatly reduced; the voices of regular people amplified. This is one reason that rates of participation in Clean Election systems are high. They decrease real or apparent conflicts of interest for elected officials.

Public financing will restore faith in our elections and political system. After six years of questions about the integrity of our elections, Americans' confidence in voting needs a boost. Fraud in elections has always been extremely rare, but the corrupting influence of money in politics—real and perceived—continues to erode our confidence in the system.

It will improve Hawaii's political reputation. Thirteen states use some form of publicly-funded elections, as do 20 local governments [2]. Hawaii's partial public funding program is woefully out of date and underused. With Supreme Court decisions like *Citizens United* deforming our campaigns, a robust public funding system is long overdue. Following our recent passage of reforms like Vote by Mail and Automatic Voter Registration, passing public funding will arguably make Hawaii the most forward-looking state in the union in terms of elections.

Finally, SB1543 is fiscally responsible. This year the state has plenty of money to fund the 2024 general election cycle. In the future, if funds are insufficient, the program will not be run for that cycle. Amounts will be adjusted with any change in the consumer price index.

SB1543 is a thorough, well-conceived bill with an array of benefits. Common Cause Hawaii strongly urges the Judiciary Committee to pass it. Thank you for the opportunity to testify.

Testimony of Senator Craig V. Hickman in Support of SB 1543 Relating to Public Financing for Candidates to Elected Office Before the Senate Committee on Judiciary

Chair Rhoads, Vice Chair Gabbard, and distinguished members of the Senate Committee on Judiciary, good morning. My name is Craig Hickman. I represent Senate District 14, 11 towns in Southern Kennebec County, in the Maine Senate. I ZOOM before you today to testify in support of SB 1543 Relating to Public Financing for Candidates to Elected Office.

History

Last year Maine celebrated twenty-two years of Clean Elections, a law that exists because Maine people wanted it. On Election Day, 1995, a diverse array of 1,100 volunteers stationed themselves at polling places around the state. Fourteen hours later they had more than enough signatures to qualify the question for the ballot. The question was, "Do you want Maine to adopt new campaign finance laws and give public funding to candidates for state office who agree to spending limits?"

One year later, 56% of voters approved the new law. The victory was statewide, in 15 of 16 counties. Exit polls showed that majorities of women and men, Republicans, Democrats and unenrolled voters supported new campaign finance laws including the public financing of campaigns for state office. It was the first full public funding system for state offices in the country.

Naysayers challenged the Clean Election Act in federal court, and it was found to be constitutional in both the District and the 1st Circuit Court of Appeals. Critics thought that, for a host of reasons, it would never work: no one would use it; only Democrats would use it; candidates would not ask voters for five dollars; candidates foolish enough to use it would be drastically outspent.

None of that happened. Much to many peoples' surprise, it worked. It has been used now in eleven election cycles, with several hundred candidates participating in each of those cycles -a total of around 1,600 Clean Election candidate campaigns in general elections. Scores, maybe

hundreds, of candidates and legislators have never run any other way. It works because Maine people keep coming forward to participate in it. Eighty percent of the 125th Legislature successfully used Clean Election funding to win their seats. Every one of the senators who won their seats for the first time last year used Clean Elections. Candidates in all parties and unenrolled candidates use Clean Elections. Many legislators say that without Clean Elections they would not have run for state office.

How it Works

Qualified candidates for State Senate and House have used it since 2000; candidates for governor have used it since 2002. In 22 years – 11 electoral cycles with Clean Elections – it's been used by a majority of candidates – and a majority of winning candidates. Today Clean Elections is a well-established part of Maine's elections and is popular with candidates and voters alike. It's used by candidates in every part of the state, all parties, incumbents, challengers and open seat candidates, first-timers and veterans, all genders. In a typical legislative cycle, over 50,000 Maine voters participate by making Qualifying Contributions of \$5 to candidates they support in order to help them qualify for public funds. The law has kept up with the times, and now many Qualifying Contributions are made online.

Successes

Clean Elections removes a significant barrier to running for state office. It's proven to be an excellent tool for recruiting good candidates to run — both major parties have used Clean Elections with great success.

It's been particularly helpful for women. They use it more, like it more, win more with it, and more frequently cite Clean Elections as a key factor in their decision to run.

Clean elections changes the relationship between lobbyists and legislators. No checks change hands at election time; no threat of a withheld contribution sways legislators who know they can rely on Clean Elections in their next campaign.

It has allowed Maine to rebuff well-financed industries, for example Maine was first state to outlaw DECA, a flame-retardant chemical and known carcinogen, after passionate advocacy by citizens countered the millions spent in opposition by the chemical industry.

In 2000, the Maine Legislature approved a daring new pharmaceutical program which gives Maine families the chance to buy drugs at a deep discount. The law was upheld by the Supreme Court and went into effect in January 2004.

It has been well administered and enforced by our Ethics Commission, with very high rates of compliance by candidates. The small number of serious violations have been ably handled by the Attorney General.

Candidates are happy to say that running with public funding gives them the freedom to spend more time with our constituents discussing important issues. They are no longer stuck "dialing for dollars" – spending long hours on the phone asking special interest donors and lobbyists to contribute to their campaigns.

Maine has seen no influx of frivolous candidates. The qualifying requirements are high enough that the great majority of candidates are serious, capable people. As in any system, there will be some candidates who stretch and break the rules. However, a strong enforcement system protects the Maine Clean Elections program from abuse.

Clean Elections is popular among legislators in Maine. A full majority of our State Senate and House ran "clean." Each year the proportion of lawmakers elected using the system has increased from the previous election.

Challenges

Twenty-two years after it went into effect, we are the envy of states around the country because the Maine Clean Election Act works. Opponents have not given up, and we continue to face challenges in the courts and in the legislature. But with each challenge, Maine people come forward to defend their law.

Right to Life groups, the ACLU, and others challenged the constitutionality of our Law almost as soon as it passed. It survived those challenges. It's constitutional because it is voluntary. That's important because the law includes spending limits — only possible in a voluntary system.

Those challenges never made it to the U.S. Supreme Court... but then came the Roberts Court which has steadily rolled back established campaign finance precedents, totally changing the legal landscape. The Court overturned a provision in Arizona's Clean Elections law, and since that law was modeled on Maine's, we also lost an important element of our System.

Maine responded by reinventing our system, creating a workable new model that would repair the damage done by the Court. When the legislature failed to pass it, citizens went back to the ballot for a second successful Clean Election initiative in 2015. Its mandate was renewed by Maine people.

Another challenge is that we have no gubernatorial winner yet, although party candidates have won the nomination with Clean Elections, and independent candidates have qualified. But so far no Clean Election candidate has won the general election. This was not true in Arizona, where under a similar system, a Clean Elections governor was elected in the first cycle and many time since.

The gubernatorial system had its worst setback in 2014 when the then-current governor, an opponent of public funding, suspended funding for gubernatorial candidates in that cycle (his reelection). Some feel that the jury is still out as to whether Clean Elections "works" in the gubernatorial race, but every attempt to eliminate that part of the system has been met with strong, even overwhelming, opposition from citizens. (See Arizona above.)

Maine citizens have never let us forget that it is their law, and they want it to work. Maine is not immune to the flood of outside spending unleashed by another Roberts Court decision — Citizens United. We managed to get most of the big money out of candidate coffers, but the rollbacks at the federal level have added this significant and unwelcome dimension to our

elections, just as it has in every other state.

Conclusion

Thanks to the 1996 reforms, there are no large contributions going to candidates for state office. Private money plays a diminished role in elections. Candidates compete on a level playing field. Voters have more choices, with more first-time candidates, more women, and more contested races. Clean Election campaigns are different, with more time for voter contact and a strictly limited budget. Legislators have a more straightforward relationship with lobbyists than did their predecessors.

The Maine Clean Election Act is a success thanks to the sound principles on which it is based, the continued enthusiasm of Maine people, and the careful attention of successive legislatures. In each cycle since 2000, led by the legislative committee that I now chair, our Legislature has sorted through many bills, consulted with staff at the Ethics Commission, the Attorney General's office and with the legal analysts, listened to citizens and elected leaders, and made the necessary small adjustments to make a good system better.

The Clean Election model is a constitutional, workable, voluntary public funding system that is good for democracy. It engages more citizens in candidate campaigns than private financing does: citizens are invested in the Clean Elections candidates. It enlarges the pool of potential candidates, providing resources and creating opportunity for civic-minded people who lack personal wealth and have no desire to court private donors. For countless Maine legislators from a great variety of backgrounds, Clean Elections is what made it possible for them to run, win, and serve.

Comments:

Good morning, my name is David McCluskey, a former 6 term Connecticut State Representative and one of the members of then-Governor Rell's Campaign Finance Reform Working Group. I am honored to testify in support of your Senate Bill 1543 concerning Public Financing For Candidates To Elected Office.

In 2005, Connecticut became the first state in the nation where legislative incumbents passed a full public financing law that applies to their own political campaigns. Every state has unique legislative and political environments and I am not here to tell you to simply adopt Connecticut's Public Financing law. However, I am testifying that our system works. It has significantly reduced the influence of large moneyed interests in our legislative deliberations and it has made our elections more democratic by having more competition in our primaries and elections.

Since the 1800s, Connecticut has been called the land of steady habits. Change continues to be very hard in my state and asking legislators who know how to get reelected under the existing rules to adopt new campaign financing rules was particularly tough. But we were successful after a lot of struggle both inside and outside our State Capitol. Hawai'i can and should enact public financing of elections to improve the credibility of the legislative process for your state residents and to free legislators from the increasingly chaotic and escalating rules to raise funds.

In Connecticut, candidates must raise small to moderate amounts from residents in the towns they represent. Once they reach the necessary number of in-district contributions and the necessary dollar amount, the state provides them with a reasonable amount to campaign. This process is heavily regulated by the State Elections Enforcement Commission to prevent fraud and abuse. Asking your family, friends and neighbors for reasonable contributions is actually very liberating. I am not burdening them multiple times in a campaign for more and more money. Instead of spending an enormous amount of time raising dollars, I can spend it talking to voters.

Since Public Financing has been adopted, there has not been wholescale ouster of incumbents as was feared. Yes, some incumbents do lose in primaries and general elections, but mostly because they are no longer in touch with their voters, a policy issue or an economic situation, NOT because their opponent was publically funded. Yes, our system can punish incumbent complacency, but their opponent is equally funded, no more, no less. Incumbents still have the advantage in elections if they are doing their job and are talking to their constituents.

In terms of legislative deliberations, incumbents can now vote their convictions and without having to worry about being punished in re-election campaigns by well-healed lobbyists and interest groups who used to provide the lion's share of campaign dollars. Again, this is very liberating to most incumbents and has, in my opinion, significantly improved policy outcomes for Connecticut residents.

In conclusion, I strongly urge Hawai'i to adopt public financing for its state legislative races. I would be happy to answer your questions.

I am writing to strongly support for SB 1543. I am delighted that a program for comprehensive public funding--Clean Elections--is finally back for consideration. Starting in 2009, a group of my advanced students at UH-Hilo agreed that getting big money out of politics was critical. They joined the Global HOPE association to petition and lobby to get the State to fund the popular Clean Elections Pilot Program on the Big Island's 2010 and 2012 County Council elections. It was a stunning success. Even the candidates who were initially against the pilot program – but used it after it had passed -- acknowledged that it was better to spend their time meeting with their constituents about community issues rather than fund-raising.

The 2010 *Citizens United* Supreme Court decision legalized political bribery, using the absurd legal fictions that "corporations are people" and that "money is speech." And unfortunately, the Big Island pilot program was not continued. But I see that the Maine and Connecticut Clean Elections Programs still thrive. On the Big Island in 2010-2012 we saw a new crop of younger and working class candidates who were more representative of the Big Island community. That's democracy.

Without Clean Elections, democracy declines. The rich and big corporations can tilt the playing field. Historically, bribing politicians was illegal – and punishable by prison time. But 3 Republicansupported Supreme Court decisions in 1976, 1978 and 2010 re-opened the way for the rich to contribute vast sums to (control) candidates and government officials. The Big Island's Clean Elections Pilot Program of 2010 and 2012 was very popular and a great success. Let's get something like it statewide for all elections—as proposed in SB1543-- and begin the restoration of a more democratic government.

Aloha Chair Rhoads, Vice Chair Gabbard, and Committee Members:

I am Colin Moore, a political scientist and professor at the University of Hawai'i at Mānoa. I strongly support SB 1543. It follows the successful "clean elections" model of public campaign financing currently used in the states of Arizona, Maine, and Connecticut.

In the United States, politics costs money. To raise sufficient funds, candidates rely on wealthy donors and organized interests for support – and this can invite corruption and distort public policy. Challengers often struggle to raise funds because they lack the name recognition and access to networks that benefit incumbents. Over the past decade, an average of 90% of incumbents were reelected during each election cycle in Hawai'i.

Public financing can solve this problem by providing challengers with sufficient resources to run competitive campaigns. More competitive elections often lead to stronger voter mobilization and communication efforts – and this reduces ballot "roll off," which is the tendency of voters to leave ballots blank for less-visible legislative and municipal races. Furthermore, public financing eliminates the need to raise private funds, allowing candidates to spend more time connecting with voters and discussing public policy. This is good for candidates and good for citizens.

A large body of research in political science indicates that generous public campaign financing programs can increase electoral competition, contribute to greater diversity among candidates and donors, and encourage more contact between office-seekers and voters.

For these reasons, I urge you to support SB 1543.

Time, place and manner legislation, such as that passed last year by the legislature and those bills introduced in the 2023 Legislature are a good start, but they do not eliminate the potential for abuse of the campaign finance system. Only the elimination of privately funding campaigns will accomplish this goal. An added benefit is that it will level the playing field for all candidates so that in similar races all qualified candidates will have the same amount of funds to run on. Everyone starts on the same yard line. Those candidates who work the hardest and are best able to deliver a message to their voters with the same amount of funds wins. I am writing on behalf of Global HOPE (Hawaii Organization for Peace and the Environment), a registered independent student organization at UH Hilo, in favor of comprehensive public funding for candidates for political office (SB 1453). Global HOPE students supported Hawaii County's Clean Elections Pilot Program of 2010-2012. Based on the experience of the pilot program, we believe that if SB 1453 becomes law, elected officials who may be skeptical of publicly funded elections will realize that they would rather spend their time meeting with their constituents and discussing community issues than hustling for donations.

By passing SB 1453, not only will the playing field for political candidates be leveled, but a more secure trust between voters and representatives can be fostered. There is a responsibility for candidates to abide by the terms set by the people, which is often muddled by the interests of wealthy lobbyists who shift priorities from creating effective policies to having their favors granted. If Hawaii transitioned to public funding, which would alleviate this issue, candidates would no longer have to rely on or act according to outside, greedy influences.

As college students, it often feels as if we are not heard or taken seriously. A recent statistical analysis of US government policy by political scientists Martin Gilens and Benjamin Page confirmed that while the policy preferences of economics and organized groups representing business interests have a substantial impact on what bills become law, the policy preferences of ordinary American citizens have no measurable influence. We hope that our political participation can push the collective voice, but the privatization of elections makes this nearly impossible. The youth's faith in the current political system has eroded and measures need to be taken to reach a state of true democratic process. Gilens and Page have argued that public funding is an excellent way to reduce the corrupting effect of private money. We believe that the cost of clean elections is a small price to pay for the larger humanitarian, environmental, and social problems that result when candidates are sold to the highest bidder. Testimony in Support of SB1543

Committee members,

Mahalo for the opportunity to speak before you today. On behalf of the 8,000+ supporters of Our Hawai'i, I stand in strong support for Senate Bill 1543, relating to public financing of candidates to elected office. Our supporters are local people — kama'āina and kānaka maoli, keiki and kūpuna, from Kailua to Kapolei to Kaua'i, Kohala, and every corner of our islands. They have joined our movement to fight for a Hawai'i that puts local people — not big money interests — first, because they are deeply worried about the direction of our islands and believe now is the time for change.

I, too, am worried. At 31, growing up here I was told that things would change if young people "just voted." My whole life I have voted. The first opportunity I got. I have seen new governors, new legislators, new council-members, and what has happened in those 31 years? Median home prices are now over \$1 million, our rent is the highest in the nation, our water is poisoned, our islands are sinking, we are still dangerously dependent on imports of food and other goods, many of my friends can't afford to live here anymore, our teachers and schools are chronically under-funded, and there are more Native Hawaiians now living outside of Hawai'i than in our islands. As crisis after crisis mounts up, transformational action, frankly, fails to come from these halls. Why would my peers and people younger than me believe voting would make things change? We haven't seen it. Not in my lifetime.

Young people and working people aren't voting at higher rates because we're apathetic or don't care. It's because we're akamai; we're actually paying attention. We know that for too long, big money interests: luxury developers, big tourism, big agriculture, energy monopolies, military contractors, and the who's who of the wealthy and well-connected have held a stranglehold over our politics, drowning out the voices, values, and desires of the maka'āinana — the every day working people. Over half of all campaign donations in 2022 came from just 980 donors who gave at least \$6,000. This is a small group of people, maxing out to candidates and committee chairs during elections, to cash in on favors during legislative session and determine what bills live or die.

Our corruption and public trust in government crisis has reached a tipping point, too. After years of the FBI putting our officials in handcuffs, resignations, and scandals, <u>Hawai'i voters as a whole in this past election ranked government corruption as their number 3 top issue, only behind inflation and affordable housing, and 74% favor the adoption of a policy like SB1543 which would provide full public financing of elections and ban corporate and private donations. Public trust is at an all time low. It's not time for band-aids, it's time for real solutions.</u>

SB1543 is that. It's a historic opportunity to get big money out of our politics where it begins, in our elections, allow every day people an equal voice with the rich and powerful, and allow candidates to be beholden only to their voters, their constituents, their values, and their conscience. We know it works, we've seen it in places like Connecticut, Maine, and now Seattle. We know it's popular. In addition to the strong public support, the bill has the backing already of the state Democratic Party, current and former legislators from both the Republican and Democratic Parties, and was introduced by a historic 40% of legislators in both chambers. We know we have the resources: the

We have the policy. We have the resources. We have the public desire for change. The only question is do we have the political will? That will be up to you to make it so. As you deliberate, know the public is watching.

Lastly, on a technical policy point, I'd like to attach for the record the request for an amendment to increase the amount of funding allotted in the legislation for Maui County Council Races. This past cycle on Maui County saw out of control spending by corporate, out of county, and even out of Hawai'i interests. Due to the <u>now very competitive nature</u> of the Maui County Council races, the costs of campaigning has increased in recent cycles. This cycle (see attached chart), the average winning amount was over \$58,000, with some candidates spending north of \$100,000. This, of course, does not even include the very robust and expensive <u>independent expenditures</u>.

For all of these reasons, I want to advocate strongly for increasing the Maui Council allocation to at least \$50,000, if not more, for these county-wide races. In addition to the below chart, I've also attached a report conducted by Our Hawai'i on big money spending and influence in Maui County.

Exposing the Big Money Influencing Maui Nui Elections

Overview

In the last 4 years, the Maui County Council has finally begun to put the needs of working families and the protection of our natural resources over corporate interests, in the backdrop of rapidly changing conditions for the people of our Maui Nui islands and our way of life. Money was shifted from promoting tourism towards local agriculture, a moratorium was placed on hotel construction, our water control and crises were taken more seriously, and out-of-state renters and investors and property owners were cracked down in order to address the housing crisis.

Now, with all the Council seats and the Mayor's office up for grabs, big money development, hospitality and tourism, and other interests that stand to lose from further cracking down on overdevelopment, environmental exploitation, and more are intervening in the elections to try to hand-pick their candidates. Meanwhile, <u>new polling from Our Hawai'i and Data for Progress</u> released this month shows that Hawai'i voters are more likely to support candidates who do reject campaign contributions from out-of-state developers, hotel conglomerates, energy companies (74%) and corporate PACS and lobbyists (70%) and support moving to ban corporate contributions and enact publicly financed elections (74%).

This report aims to shine a light on what's at play, what's at stake, and who's behind it all by educating voters about the campaign finances and contributions of major candidates for Maui County Council and Mayor this August and November. We also take a look at and connect the dots between contributions to candidates and County Contracts awarded in the past two years.

We find a consistent pattern of key interests, largely in the real estate, development, and tourist industries, but also others, intervening in key contests to try to support candidates they hope might be favorable to their interests. We hope this timely report can serve as an educational resource for voters as they prepare to cast their ballots this election.

A note on our data:

The data for this report is sourced entirely from public documents, including Hawai'i Campaign Spending Commission public financing and contains only up to the most recent July 15th candidate campaign filings. You can view our grouping of the Campaign Spending Commission data <u>here</u> and the data for County contracts <u>here</u>, or view the raw data yourself at the <u>Campaign Spending Commission's database</u> and the <u>Maui County Current Awards website</u>.

The Race for Mayor

The race for Mayor has three major competitive candidates: Incumbent Mayor Michael Victorino, Judge Richard Bissen, and Councilmember Kelly King. Here we look at the campaign finance of these candidates.

Support from Maui County locals vs. Outside Donors

There's a stark difference between the three major candidates when looking at the geographic sources of their donors, with Judge Bissen receiving almost half of his contributions from outside Maui and one third of Incumbent Mayor Victorino's donors coming from outside. Meanwhile 91% of Councilmember King's donors come from Maui County.



Developer influence

Another notable area of contrast between the three major candidates is in their financing from Real Estate & Development interests, which heavily participate in elections and lobbying of the Mayor council in order to get their sometimes controversial projects approved. Bissen has received over \$150,000 from

these interests to date, almost 40% of his overall contributions, while Victorino has received a smaller but still significant \$54,600. Kelly King has received only just over \$5,000 from any real estate interests on the islands.

BUNDLING: At least **\$40,500 of Richard Bissen's donors can be traced back to a legal, but ethically questionable, practice called "bundling"** which is essentially a way of skirting caps on donations from individual and corporate donors, put in place to limit corrupting influence in our campaign finance system and governments. Fundraisers, or agents of the corporation, gather large donations from multiple sources within a company or interest group (usually senior business leaders and their spouses or other family members) and present them together to the campaign. Most observers believe this is with the goal of buying access to or influence over a potential representative once they are elected. In Bissen's case, our investigation uncovered apparent bundling from the **Kobayashi Group and Black Sand, two development and hotel companies run by the powerful Kobayashi family amounting to \$20,500, including 7 donations from leaders in the Kobayashi Group which added up to \$16,500 all on the same day** (June 7th). Similarly, known for their predatory landlord practices in Kihei and their retail centers, **the MW group bundled \$20,000 from 11 donors across a 19 day period to the Bissen campaign.**

County Council Races

In August voters will narrow the field for four competitive seats for County Council: South Maui, Kahului, Makawao/Pā'ia/Ha'ikū, and Upcountry. In November, they'll elect the full council. For now, this report focuses on these top competitive races. We pull out notable toplines for each candidate and provide summary breakdowns. Candidates are listed alphabetically by first name.

South Maui

Dennis O'Shea

According to campaign finance reports, Dennis O'Shea has raised \$0 and spent \$1,557.48 of his own funds.

Robin Knox

Robin Knox is 93% funded by Maui County residents, and received no money from PACs, developers, or hotels.

Connecting the Dots: Contributions and County Contracts

Hawai'i State law dictates that it "shall be unlawful for any person who enters into any contract with the State [or] any of the counties" to "make any contribution to any candidate committee...or to any candidate...for any political purpose."

Our review of current government contracts awarded during this election cycle would, on surface, make it appear that there are dozens of companies currently in violation of this law in Maui County, as our chart shows below. But upon further investigation, the current way that the law is interpreted is that it only regulates direct contributions from corporations and their PACs — not from the owners, President, Vice President, Chairman, Executives, their spouses, or others who stand to directly profit from the contract. This is a major loophole in State and County law, and our review demonstrates it is being exploited.

We cross-referenced Maui County Contracts awarded in 2021 and 2022 with campaign contributions from owners, decisionmakers, senior staff, directors, and family members associated with those same interests in the 2021-2022 election cycle.

Pay-to-Play: Contracts and Contributions

As you can see, there are 17 companies with Maui County Contracts whose senior staff, owners, directors, other decision makers, or their close family have also made significant contributions to Maui County campaigns this cycle. In total this represents about \$100,000 contributed for a total of \$55 million in contracts awarded. If you thought of these campaign contributions as business investments, they'd collectively yield about a 550% "return on investment." Not bad!

And if that feels like a stretch, if you look underneath the patterns of donations, you can see that many of these people do view their campaign contributions as "costs of doing business." Why else would you donate significant sums of money to multiple candidates in a race if you were not trying to "play both sides" and curry favor with multiple candidates who you think you can later extract concessions or business from. Some examples:

- Jim Falk Valley Isle Motors associates, who sells vehicles to the county, donated \$4,000 to Mayoral candidate Michael Victorino, and 3,000 to Richard Bissen.
- Bowers & Kubota, with \$2.5 million in contracts, kept it even with \$2,000 each to Victorino and Bissen
- Munekiyo & Hiraga leadership's \$2250 they contributed this cycle includes contributions to both Victorino and Bissen, and last but not least,
- SSFM's former President Michael Mastumoto, who was involved in <u>pay-to-play political</u> money laundering scandals in the early 2,000s, is still at it at a lower level, with high level donors from his company including him, making sure that they contribute to both Bissen and Victorino as well.

Of all the contributions Goodfellows Bros. through the "bundling" practice described in the Mayoral section of the report, has made \$48,000 in campaign contributions this cycle – \$30,000 to County level candidates for council and mayor, and \$18,000 for state representatives and senators in Maui County – and was awarded an over \$4.5 million contract for the Moloka'i Landfill Phase V Disposal Cell.

Conclusion and Policy Recommendations

Voters have big choices, and there are major differences between the candidates. Certain industries see the council and mayor race as critical to their interests. In almost every race, major real estate and development interests are largely aligned as to where their contributions are going. It would be fair for voters to observe and draw their own conclusions from those observations.

It's also clear that there remain problems in our campaign finance laws, and loopholes like bundling and rules on government contracts, that make it easy for big money interests to continue to engage in legal but unethical pay-to-play practices as part of their normal operations and "costs of doing business." These problems are bigger than any one race or candidate. Grassroots candidates that aim to reject these donors have clear disadvantages in this system, and are sometimes even disadvantaged by otherwise well intentioned efforts at campaign finance reform that create onerous reporting or compliance requirements that are harder for less experienced campaigns with less resources to comply with. So yes, we should make more reforms around the edges, like banning bundling, and fixing the contract loophole, but we need to ultimately pursue more systemic reforms that will create a better, fairer, more democratic system overall, like putting disclosure requirements on big donors rather than candidates, and ultimately moving to fully publicly financed elections.

Chair Rhoads, Vice Chair Gabbard, and Members of the Judiciary:

My name is JoAnn Yukimura. I served as an elected official on Kaua'i for 28 years, 22 years as a councilmember and 6 years as mayor.

I strongly support SB 1543. It is a game-changer that will level the playing field for serious candidates for public office and remove the unfair advantage that candidates with access to large sources of money presently have in elections.

In the Himalayan country of Bhutan, the policy of "Gross National Happiness" stands upon four public policy pillars: The first three pillars are: 1. a balanced economy, 2. protection of the environment, and 3. perpetuation of culture. The fourth pillar, upon which the three aforementioned pillars depend, is **good governance**, which insures that decisions implementing the first three priorities are made on behalf of the public good. It is impossible to have good public policies without good governance.

SB 1543 addresses good governance at its core. Money from special interests currently has huge influence and impact on the outcome of our elections. Maui County has had undue influence on our elections from Political Action Committees and large donors with a significant amount of money coming from outside of the County and state.

When I decided to run for office a wealthy builder tried to talk me out of it saying, "You can't afford to run for office, I can" it made me angry but it is true. Clean elections will create a fairer election system where a more diverse set of candidates can run and financial support can come from constituents, as opposed to the current system where wealthy candidates with wealthy donors are favored.

My opponent in the County Council race for South Maui, a builder backed by off-island interests raised significantly more money and benefitted from the more than \$300,000 spent by the Be Change Now SUPER PAC to influence Maui County races. Be Change Now sponored extensive radio ads and campaign mailers that were delivered to voters daily in the weeks before the election. Maui County elections are for a 3 island district with 9 residency areas. One mailer cost more than \$30.000. My campaign could not afford even one mailer, while off island intersts paid for dozens of mailers for my opponent.

Elections are largely won by name recognition, and I found my time, funding and efforts focused on fundraising for advertising in lieu of speding time meeting voters.

Big money funding of elections discourages many people from running for office because it is an intimidating.
