## In consideration of SB 1572, SD1, RELATING TO COLLECTIVE BARGAINING

Chair Dela Cruz, Vice Chair Keith-Agaran, and Members of the Committee:

The Office of Collective Bargaining (OCB) appreciates the intent of SB 1572, SD1, which creates a separate bargaining unit (16) for City and County of Honolulu Emergency Medical Services Department (EMS) employees, and recategorizes EMS employees from bargaining unit (10) into bargaining unit (16). However, we must respectfully oppose this measure.

The OCB is concerned for the following reasons:

- 1. The Honolulu Emergency Medical Services (EMS) Department may include employees in other bargaining units (BU) besides BU 10 and as currently written it is unclear as to whether the intent of this measure is to include these employees in BU 16.
- 2. BU 10 is comprised of institutional, health and correctional workers, which include, among others, EMS employees, Adult Corrections Officers (ACOs) and Licensed Practical Nurses (LPNs).
- 3. OCB believes that separating EMS employees from BU 10 is not necessary, as the current collective bargaining agreement addresses changes to wages, hours and other conditions of work. For example, EMS employees, ACOs and LPNs are covered under three distinct salary schedules.
- 4. In addition to wages, Section 55 of the BU 10 collective bargaining agreement was specifically negotiated for EMS employees to include work schedules, temporary work unit, seniority, and personal equipment. Similarly, Section 61 was negotiated for Adult and Youth Correction Officers and

- Juvenile Detention Employees.
- 5. Should there be operational concerns in the workplace that may not have been addressed, as an alternative to creating a new BU, Section 89-10, Hawaii Revised Statutes, provides for other agreements to be reached by the parties during the term of the collective bargaining agreement to address such issues.

Relating to Collective Bargaining

Senate Bill No. 1572 SD 1 creates a separate bargaining unit 16 for the City and County of Honolulu Emergency Medical Services Department employees. It recategorizes the City and County of Honolulu Emergency Services Department employees into bargaining unit 16.

For the purposes of aiding the Committee in its deliberations, the City and County of Honolulu (City), Department of Human Resources (DHR), respectfully provides the following clarifying information.

The Honolulu Emergency Services Department (HESD) currently has employees represented by the United Public Workers (UPW) and the Hawaii Government Employees Association (HGEA) that are included in bargaining units 01, 03, 04, 10, 13, and 15. As presently written, Senate Bill No. 1572 SD 1 would place all HESD employees into a new bargaining unit 16, regardless of their current bargaining unit or union.

The City is currently administering contracts for nine different bargaining units involving four separate unions. As such, DHR has concerns regarding the increase in costs and complexities related to establishing, negotiating, arbitrating, and managing yet another bargaining unit and contract, particularly without added staff and resources.

Finally, the proposed bargaining unit 16 would be comprised only of City employees in one department, yet the City would have no substantive bargaining autonomy to negotiate with the proposed bargaining unit 16 because the Governor will still have six votes and the Mayor will have only one vote for purposes of collective bargaining.



### Comments:

The educational requirements increased tremendously since 1970 when Honolulu Emergency Medical Services was assigned bargaining unit 10. Back in 1970, the ambulance crews were called "ambulance drivers." There were no EMTs or paramedics. Today the paramedic is the highest-trained medical crew member in the ambulance, and to achieve that title requires years of training.

Today the requirements to be a paramedic in Honolulu are

- 1. Certificate of completion from an approved Emergency Medical Technician-Paramedic Course
- 2. Current American Heart Association Advanced Cardiac Life Support Certificate (ACLS)
- 3. Current American Heart Association Basic Cardiac Life Support Certificate (BLS)
- 4. Current National Association of Emergency Medical Technicians, Emergency Pediatric Care Certificate (EPC) or Equivalent Pediatric Advanced Life Support(PALS)
- 5. Current Pre-Hospical Trauma Life Support Certificate (PHTLS)
- 6. Current Board of Medical Examiners EMT-P Certificate
- 7. Current Medical Examiners DOT Certificate
- 8. Current Hawaii State Drivers License (Class 3)

The license and certifications are renewed every two years and require 60 hours of continued medical education. The educational requirements provide a solid reason to move Honolulu EMS into bargaining unit 16.

Paramedics are the highest-trained medical pre-hospital professionals that provide a service like no other in bargaining unit 10, which has a tremendous impact on the public with morbidity, disability, and mortality and the statistical evidence to support this claim.

The nation is suffering a national crisis of paramedic shortage. Honolulu EMS is no different. Since 2020, Honolulu EMS has hired 124 employees and has lost 117 employees. With 21

ambulance units serving the entire island of Oahu, Honolulu EMS has responded to a recordhigh call volume in 2021 (~101,000) and 2022 (~104,000). Honolulu paramedics also train other EMTs from neighboring islands and departments to become paramedics. Occupational burnout is high compared to what is found in other health professions. Honolulu EMS is on an accelerated path that needs critical intervention. State legislators should be concerned about the significance of the problems in EMS, such as the causes, effects, and results of high paramedic shortages. Because the public elects legislators, they should be motivated to address these problems and implement goals to solve the issues that negatively affect patient care and improve the overall safety and well-being of the public.

There are many different jobs in bargaining unit 10, therefore, many different pay scales. The wage increases do not differentiate within bargaining unit 10. It is awarded evenly to all of unit 10. How can this be applied relatively in bargaining unit 10 with the vast difference in job duties? In 2014 Honolulu EMS implemented an alternative staffing schedule negotiated outside of the master agreement with the city and county, but today staffing is still an issue. As a 20-year veteran serving as a District Chief and the Chief Steward of Honolulu EMS for UPW, creating bargaining unit 16 for Honolulu EMS will positively impact our employees and the public we serve.

By the time help arrived, my mother's lips were blue; she was struggling to breathe and was no longer aware of her surroundings. Fortunately for our family, the system worked as intended, with Fire arriving within a few minutes, followed quickly by an ambulance. However, with the continuing decline in EMS providers, that will not be the case for some families if we do not make radical changes to retain our critical workforce.

Much like the rest of the nation, Hawai'i continues to struggle with recruiting and retaining enough medical responders to meet the needs of their communities. This was a projected issue prior to the pandemic, with the increase in an aging population requiring more medical attention. The pandemic has exacerbated the problem, with many leaving the workforce for easier, safer, and more lucrative jobs. In addition, the marginalized populations utilizing EMS as their primary access to medical care has also increased, further burdening an already strained system.
