## In consideration of SB 1572, RELATING TO COLLECTIVE BARGAINING

Chairs Wakai and Moriwaki, Vice Chairs Elefante and Lee, and the members of the committees:

The Office of Collective Bargaining (OCB) appreciates the intent of SB 1572, which creates a separate bargaining unit (16) for City and County of Honolulu Emergency Medical Services Department (EMS) employees, and recategorizes EMS employees from bargaining unit (10) into bargaining unit (16). However, we must respectfully oppose this measure.

The OCB is concerned for the following reasons:

- Bargaining Unit (BU) 10 is comprised of institutional, health and correctional workers, which include, among others, EMS employees, Adult Corrections Officers (ACOs) and Licensed Practical Nurses (LPNs).
- 2. OCB believes that separating EMS employees from BU 10 is not necessary, as the current collective bargaining agreement addresses changes to wages, hours and other conditions of work. For example, EMS employees, ACOs and LPNs are covered under three distinct salary schedules.
- 3. In addition to wages, Section 55 of the BU 10 collective bargaining agreement was specifically negotiated for EMS employees to include work schedules, temporary work unit, seniority, and personal equipment. Similarly, Section 61 was negotiated for Adult and Youth Correction Officers and

- Juvenile Detention Employees.
- 4. Should there be operational concerns in the workplace that may not have been addressed, as an alternative to creating a new BU, Section 89-10, Hawaii Revised Statutes, provides for other agreements to be reached by the parties during the term of the collective bargaining agreement to address such issues.

SUBJECT: Senate Bill No. 1572
Relating to Collective Bargaining

Senate Bill No. 1572 creates a separate bargaining unit 16 for the City and County of Honolulu Emergency Medical Services Department employees. It recategorizes the City and County of Honolulu Emergency Services Department employees into bargaining unit 16.

For the purposes of aiding the Committee in its deliberations, the City and County of Honolulu (City), Department of Human Resources (DHR), respectfully provides the following clarifying information.

The Honolulu Emergency Services Department (HESD) currently has employees represented by the United Public Workers (UPW) and the Hawaii Government Employees Association (HGEA) that are included in bargaining units 01, 03, 04, 10, 13, and 15. As presently written, Senate Bill No. 1572 would place all HESD employees into a new bargaining unit 16, regardless of their current bargaining unit or union.

The City is currently administering contracts for nine different bargaining units involving four separate unions. As such, DHR has concerns regarding the increase in costs and complexities related to establishing, negotiating, arbitrating, and managing yet another bargaining unit and contract, particularly without added staff and resources.

Finally, the proposed bargaining unit 16 would be comprised only of City employees in one department, yet the City would have no substantive bargaining autonomy to negotiate with the proposed bargaining unit 16 because the Governor will still have six votes and the Mayor will have only one vote for purposes of collective bargaining.



Dear Senators,

I would like to humbly ask for your support towards the passage of SB1572, which seeks to recategorize the Emergency Medical Technicians and Mobile Intensive Care Technician-paramedics of the City & County of Honolulu's Emergency Medical Services Division from UPW Unit 10 to a new Unit 16.

I am a paramedic supervisor with over 40 years of experience in EMS. I am also a Registered Nurse with 25 years' experience in emergency medicine and also have a Master's degree in Public Health. Throughout the past 4+ decades, EMS has been lumped in Unit 10 alongside Adult Corrections Officers, psychiatric aides, and LPNs, though we are the only members required to possess both state and national certifications that must be renewed every other year. EMS is an essential part of public safety, on par with HPD, HFD and Ocean Safety. Our training is by far the most lengthy and difficult of all the public safety professions as training an EMT to a paramedic level takes nearly as long as a 4-year bachelor's degree. The job of a paramedic requires not only a tremendous amount of academic knowledge and the ability to apply it, as well as being physically, mentally, and emotionally challenging. The profession of EMS requires that we wear the most "hats" in terms of being not only the doctor in the field, but also the nurse, social worker, rescuer, public health reporter, patient advocate and chauffeur. We are perpetually overworked---on Oahu we have only 21 full-time and 1 part-time EMS units but the call volume has been increasing yearly. In 2022, Honolulu EMS responded to nearly 86,000 911 calls (Honolulu Star-Advertiser, January 2, 2023.) However, we are so short-handed of personnel due to burnout, injuries, attrition due to the pressures of training, and people leaving for less-demanding and better-paying jobs that we must close units nearly every shift because we lack sufficient medics to staff all our units. This greatly increases the number of calls and the corresponding workload on the remaining units and those that work them.

EMS is the only public safety sector without our own bargaining unit, and hope that if we can achieve this all-important first step, we can offer better pay, working conditions, develop a career ladder, retain crucial employees, and inspire more people towards making EMS their career. Saving lives and serving the public is our tenet, but we could better attract, train, and retain these essential caregivers in a bargaining unit separate from that of unrelated professions and more tailored towards the specialized nature of our job. I hope you will see fit to agree.

I have served on the same Executive Negotiations Committee that had addressed various issues with our Blue Collar Workforce which includes our Honolulu Emergency Medical Services Department. Bargaining Unit 10 consist mainly of Institutional, Health and Correctional workers. During this last cycle of contract negotiations there was a plethora of Contract Bargaining Agreement(CBA) proposals that were submitted by the Union Membership that many of which were eliminated from further advancement. The process of eliminating these CBA proposals was very time consuming as there seemed to not have some type of streamlined process for a standardized submission of CBA proposals such as a standard form. The point being here is that there appears to be not enough time to address certain concerns between the Honolulu Emergency Medical Service and the Employer. By creating a new Bargaining Unit for our fellow EMS workers would enable them to focus on issues and matters that pertain to their jurisdiction. In doing so it will also be highly beneficial for our communities to have a stronger EMS workforce that will adequately staffed and educated. #### Comments:

I have been employed with the City and County of Honolulu Emergency Medical Services Department for the 24 years. I support the New Bargaining Unit SB1572 for the following reasons. This Bill would give the City and County of Honolulu EMTs (Emergency Medical Technicians) and MICTs (Mobile Intensive Care Specialists/Paramedics) the ability for the Union to Bargain on behalf of us alone and not be lumped with Instutional, Health and Correctional Workers; we currently make up the smallest number of members in UPW unit 10 and are often overlooked. In 1976, when our Paramedics and EMTs were lumped with Unit 10, we were considered "amublance drivers" who picked up an item at one location and dropped off this item in another location, saying that this job description was similar to the Refuse Collection who also picked up items in one location and dropped it off in another location. Since that time our job demands and description have changed and we are now a specialized group in Unit 10 who holds State and National licensing and five (5) or more other specialized certifications to practice medicine and be an extention of the Emergency Room Physicians in the prehospital setting.

Retention, burnout and job satisfaction/dissatisfaction have accelorated under the current conditions we face. For instance, call volume continues to rise, with our current call count to be over 11,000 for just this year alone (a little over one month). Call volume for the year of 2022 was over 104,000 for Honolulu County EMS which is only 21 ALS units. Daily we have unit closures limiting our resources for 911 responses for the total populace of the island of Oʻahu, which further burdens the ALS (Advanced Life Support) Paramedic units that are open. Measures need to be taken to entice those to seek out this job and make it their longterm careet, retain the current employees we have so that we may continue to care for the people of this island. Measures such as more pay, steps for years of service compensating those with experience which will promote longevity and repricing our current employees would be addressed properly should EMS have their own bargaining unit. This Unit would be able to address and give undivided attention that Honolulu EMS requires.

Having our own Unit in UPW would also allow EMS to represent themselves. Meaning, currently the Business Agent representing Unit 10 UPW EMS is a nonEMS worker who does not understand the inner workings and special challenges we face. In this past year we have had 4 Business agents and because EMS is small in Unit 10 we do not get the representation with current or retired EMS workers to be our agents at the negotiating table.

Honolulu EMS, in Unit 10, is now the only agency who is funded by the City and not by the State as all the other agenices within Unit 10 are.

Please take your time in reviewing all of the in-person testimony and that of the written ones. Mahalo piha for your time.

By the time help arrived, my mother's lips were blue; she was struggling to breathe and was no longer aware of her surroundings. Fortunately for our family, the system worked as intended, with Fire arriving within a few minutes, followed quickly by an ambulance. However, with the continuing decline in EMS providers, that will not be the case for some families if we do not make radical changes to retain our critical workforce.

Much like the rest of the nation, Hawai'i continues to struggle with recruiting and retaining enough medical responders to meet the needs of their communities. This was a projected issue prior to the pandemic, with the increase in an aging population requiring more medical attention. The pandemic has exacerbated the problem, with many leaving the workforce for easier, safer, and more lucrative jobs. In addition, marginalized populations utilizing EMS as their primary access to medical care has also increased, further burdening an already strained system and further exhausting remaining personnel.

My name is Kenneth Faria. I am testifying as a citizen of Hawaii. I have been with Honolulu Emergency Medical Services for twenty years. My current position is Field Operations Supervisor, also known as District Chief, and I serve the metropolitan areas. I am also the Chief Steward for EMS with our Union UPW and have been so for around ten years. I strongly support SB1572. This bill is critical for Hawaii's residents, especially on the island of Oahu. A paramedic and EMT staffing shortage is happening not only in Honolulu EMS but on a **national level**, so much so that it's a crisis. It is vital to address the staffing shortages in Honolulu EMS because of its effects on patient care in out-of-hospital settings. These patients are our families, friends, and us.

The shortage of paramedics means fewer ambulances on the road to serve the community, which means a longer response time to an emergency; this can have a profound negative impact on the patient whose medical emergency requires a timely response and rapid recognition of a stroke or heart attack and transport to an appropriate hospital facility. These trained professionals are critical in reducing death and disability so patients can return to everyday life.

In 2022 Honolulu EMS treated and transported roughly 104,198 calls.

- -1205 cardiac arrest
- -1379 strokes
- -171 TIAs (transient ischemic attack)
- -197 STEMI heart attacks
- -2102 chest pains
- -1462 advanced airways

With the funding of Honolulu EMS moving from the State to the City, now is the time to make these necessary changes. Providing the paramedics and EMTs with their bargaining unit will address the critical issues affecting the industry that are vital to public safety. These issues require undivided attention during negotiations and individuals who understand the severity of the industry voting on the issues. Honolulu EMS serves the island of Oahu and serves as a training entity for all neighboring islands. Thank you for allowing me to share my testimony with you today, as some of you may know I served as the State President of UPW for 12 years but I want to clarify that today I submit testimony as an individual and my testimony is not in anyway a representation of the union.

About 10 years or so ago HGEA was able to get the Legislature to pass a bill that allowed for a new bargaining unit 14, that separated ocean safety and the Sheriff's out of unit 3 which was made up mostly of clerical staff, how that came to be that they were all together, well that's a question for another time. After co existing in unit 14 for about 8 years or so both ocean safety and the Sheriff's realized that while fundamentally they agreed on things like raises, benefits and retirement their duties though both involved protecting the public, well they were very different. So again they went to the Legislature and asked them to create yet another bargaining unit just for ocean safety and were once again successful and unit 15 was born.

This is exactly the reason these members from both PSD and EMS are asking you to consider doing the same for them. While They both have extensive training in their field, the duties and responsibilities could not be more different. As the former Director of the Honolulu Emergency Services Department (2017-2020), I have seen first hand the challenges faced by the employees of the Department's Emergency Medical Services Division (Honolulu EMS).

During the past 6 years, the Legislature — in coordination with the Department of Health and the City and County or Honolulu — has successfully addressed many of these issues through the implementation of the C.O.R.E. program; of an updated Electronic Medical Records system that meets National Standards; of alternate destination transport for non-acute medical cases with Federal reimbursement. Several other initiatives are in planning.

In regards to collective bargaining, the issue before the Committees today, my testimony is to highlight the disparity our licensed paramedics face in the design of Bargaining Unit 10.

Paramedics in the State of Hawaii are licensed to practice medicine. This requires significant education, training, skill, and field experience. It comes with great responsibility as emergency medical services are delivered on the sides of our roads and freeways, in homes and apartments, in commercial and industrial buildings and factories, or any other place where a medical emergency occurs. This is in distinct contrast to the delivery of these same services done in a clinic or hospital emergency department. Paramedics must know and follow standing medical orders and every aspect of their professional service delivery is subject to both administrative and professional medical review.

Bargaining Unit 10 is primarily composed of adult correction officers. The small subset of paramedics in the BU and the specific issues related to terms and conditions of their employment are often not fully understood or recognized as a priority by the members of the BU.

The very distinct differences between the ACOs and paramedics in skill, knowledge, location of work, and professional accountability in our state is incongruous. SB 1572 is designed to correct this situation and I urge your support and passage of this Senate Bill.

My name is Chris Lai Hipp, Pharm.D., and I am writing to express my heartfelt support in favor of SB1572: Relating to Collective Bargaining as it regards to our Emergency Medical Services personnel. In my work as an Emergency Medicine Clinical Pharmacist employed in one of the busiest emergency rooms in Hawaii, I have had the pleasure of working with many EMTs and MICTs in Honolulu over the past 9 years. I have known these medical professionals to be key members of the health care team who skillfully and competently perform their jobs with care and compassion. These professionals are usually the first on scenes of tragedy and deal with the stressors of these situations on a daily basis. They are often asked to provide much more than emergency medical care, often including support for grieving families as a shoulder to cry on, and as a someone to talk to for patients experiencing various types of mental issues. The recent COVID-19 pandemic has also proved to drastically alter EMS' daily operations, causing obvious strain these consummate members of our states first response system. What stuck my throughout the most difficult part of the pandemic was despite huge increase in workload, the ever changing PPE requirements, and wavering public support of the states healthcare approach to the virus, the EMS personnel continued to provide the highest level of care without so much as a complaint. My high level of respect for the staff of our EMS only became more as I saw them deftly navigate this difficult time in our history.

Currently, their collective bargaining agreement lumps the staff of EMS together with other job groups that bear little relation to the work that the EMS does on a daily basis. This makes it nearly difficult to adequately recognize and reward the unique work that our EMS staff does. Allowing them to organize into a new specialized unit, Unit 16, would hopefully allow the EMS staff appropriate representation. This would likely allow a more fair and appropriate collective bargaining that would likely lead to increase in staff satisfaction and retention.

In closing, I hope that you will affirm this bill, and allow our EMS staff to leave Unit 10 and form Unit 16, for the betterment of all of Hawaii's future!
