In consideration of S.B. 1573 SD2
RELATING TO AFFORDABLE HOUSING.

HHFDC <u>supports</u> S.B. 1573 SD2, which establishes a working group within the Office of the Governor to inventory all available water resources statewide and identify sources of aquifer replenishment in relation to affordable housing development. The executive director of the Hawaii Housing Finance and Development Corporation (HHFDC) is identified as a working group member.

Permitting for the development of potable-water systems is a critical issue affecting housing development in many areas of the state, particularly in North Kona where it has stalled HHFDC's Kamakana Villages, a master-planned community in north Kona with the potential of 1,600 affordable housing units. Lack of potable water and the water permit process is also affecting HHFDC's Villages of Leialii housing project on Maui.

We appreciate the work that went into creating this measure to address a long-standing issue and are hopeful that this working group will lead to a better balance between water resource management and fulfilling the need for more affordable housing, particularly in North Kona.

In consideration of SENATE BILL 1573, SENATE DRAFT 2 RELATING TO AFFORDABLE HOUSING

Senate Bill 1573, Senate Draft 2, proposes to: 1) establish a working group within the Office of the Governor for administrative purposes, to ascertain the State's available water resources as pertaining to affordable housing; 2) inventory all available water resources statewide and identify sources of aquifer replenishment in relation to affordable housing development; 3) streamline the well permit approval process to ensure available water supply and 4) require a report to the Legislature. **The Department of Land and Natural Resources (Department) acknowledges the intent of this measure and offers the following comments.**

The Hawai'i Water Plan (HWP) serves as a dynamic, long-range planning guide for the Department's Commission on Water Resource Management (Commission) to help protect and regulate the State's fresh water resources. The plan consists of five component parts:

- Water Resource Protection Plan (WRPP) last updated 2019
- Water Quality Plan (WQP) –last updated 2019
- State Water Projects Plan (SWPP) last updated 2020
- Agricultural Water Use and Development Plan (AWUDP) last updated 2019
- County Water Use and Development Plans (WUDP) Kaua'i 1990; Maui 2022; Lana'i 2011;
 Moloka'i (in process); Hawai'i 2010; O'ahu 1990 (update in process), Ko'olau Loa Watershed

Management Plan 2009, Wai'anae Watershed Management Plan 2009, Ko'olau Poko Watershed Management Plan 2012, North Shore Watershed Management Plan 2016

The latest update of the State Water Projects Plan (SWPP), one of the five components above, prepared by the Department's Engineering Division accounts for water demands for affordable housing by the Hawai'i Housing Finance and Development Corporation (HHFDC) and the Hawai'i Community Development Authority (HCDA). HHFDC's two projects are identified in the SWPP 1) Villages of Leiali'i in Lahaina, Maui and 2) Kamakana Villages in Keauhou, Hawai'i Island, and HCDA's two projects, 630 Cooke Street Micro Unit and 690 Pohukaina.

The 2017 SWPP update only considered water projects of the Department of Hawaiian Home Lands (DHHL). Water needs of DHHL, which constitute affordable housing water demand, are a public trust purpose of water and have a special protection and priority in the State Water Code (Hawai'i Revised Statutes (HRS) chapter 174C). The Commission is committed to fulfill its mandate to incorporate and protect adequate reserves of water for current and foreseeable development and use of Hawaiian home lands as set forth in Section 221 of the Hawaiian Homes Commission Act, as provided in HRS section 174C-101. The Commission's 2019 WRPP includes a priority task (Task 2.3.4) to establish additional water reservations for the DHHL.

The County WUDPs are intended to inventory all projected water demands within each county and ensure that the future water needs of the county are met. This includes future affordable housing projects. The WUDPs need to be consistent with county land use plans and land use entitlements, including affordable housing, are included the county's calculation of authorized planned use. The Department acknowledges that several County WUDP are long overdue for an update and the Commission is working with the counties to ensure timely updates.

The bill asks the working group to conduct a variety of tasks, including an inventory of all available water resources statewide, address state watershed management, and identify appropriate aquifer replenishment. Most of this information can be found in the WRPP, which identifies hydrologic units for ground and surface water statewide, the quantity of available water resources and the sustainable limits for water supply (i.e.: ground water sustainable yields and surface water interim instream flow standards). The WRPP also highlights the importance of watershed protection and the value of native forests in the creation of long-term sources of water supply. The Department's Division of Forestry and Wildlife is primarily responsible for the management of mauka watersheds and has identified priority watersheds where management is critical to ensure future water supply. These locations often overlap with priority recharge and replenishment areas for the counties where affordable housing may be located.

The bill also asks the working group to streamline the well permit approval process to ensure available water supply. The approval of new wells and the issuance of permits by the Commission is informed by the HWP and its various components, but is assessed on a case-by-case basis. Even if an affordable housing project is identified in the HWP, this does not mean the project will have sufficient water. In its determination and approval of new well permits, the Commission must weigh reasonable and beneficial use and is mandated to give priority to public trust uses of water. A robust permit review process is already in place, which includes review from a variety of State and County agencies. The Commission is willing to work with the working group to identify more ways that the permitting process can be streamlined for affordable housing projects.

SUBJECT: Senate Bill 1573, SD2: Relating to Affordable Housing

The Honolulu Board of Water Supply (BWS) supports Senate Bill (SB) 1573, Senate Draft (SD) 2, which establishes a working group within the Office of the Governor to ascertain and address state watershed management to enable the development and construction of affordable housing projects across the State. The bill requires the working group to inventory all available water resources statewide and identify appropriate aquifer replenishment as it pertains to each county water use and development plan, including water source in relation to affordable housing development and submit an interim report no later than September 15, 2023 and a final report to the 2024 Legislature.

The purpose of this Act is to establish a working group that will ascertain available water resources and water system source capacity and streamline well permit approval processes to ensure available water supply to further plan for the development of affordable housing.

Recent Commission on Water Resource Management (CWRM) regulation has reduced municipal groundwater source and stream diversion supply to restore streams in support of traditional and customary practices at the expense of municipal and agricultural water systems. CWRM is further expected to reduce aquifer sustainable yields to increase groundwater flow to groundwater dependent ecosystems that will reduce available water resources. CWRM is required to balance water resource needs of all 4 public trust resources (water in its natural state, traditional and customary

practices, water for DHHL developments and domestic use as a component of municipal water systems), as well ensure existing non-public trust uses are not significantly impacted.

The Natural Energy Laboratory of Hawaii Authority (NELHA) is pleased to support SB 1573 S.D. 2 which establishes a working group attached to the Office of the Governor to inventory all available water resources statewide and identify sources of aquifer replenishment in relation to affordable housing development. This makes good sense.

Hawaii Housing and Finance Development Corporation (HHFDC) and NELHA need a new well to support new affordable housing and economic development. We have been trying to get approval drill a new well since 2018. With court rulings regarding the "public trust doctrine" and the "precautionary principles" there have been many changes over the past

several decades with issues surrounding the development of new freshwater wells, especially in West Hawaii.

We understand that there are very important deep social and traditional cultural values to provide for clean flows of groundwater, in part tied to the historical significance of traditional food production, and as such the process for obtaining approval to drill a new well is problematic and needs to be addressed on a Statewide level.
