EOA's Position: The Executive Office on Aging (EOA), an attached agency to the Department

of Health, strongly supports the intent of SB 1592, SD2, relating to Senior Medicare Patrol

(SMP) Hawai'i.

Fiscal Implications: This measure appropriates funds for SFY 2023 and the same sum for SFY

2024 for one full-time equivalent (1.0 FTE) Program Specialist III position, one full-time

equivalent (1.0 FTE) Program Specialist IV position, and one full-time equivalent (1.0 FTE)

Program Specialist V position within the EOA for the Senior Medicare Patrol Hawai'i program.

Purpose and Justification: The purpose of SB1592 SD2 is to appropriate funds for three (3)

full-time permanent positions to further assist the EOA's SMP Hawai'i program as well as

expand the EOA's ability to protect kūpuna against the onslaught of multiple forms of frauds and

scams being besieged upon them. These positions will strengthen and increase EOA's ability to

ensure that timely, reliable, and accurate services are provided to kūpuna, their families, and caregivers in need.

SMP Hawai'i's mission is to provide a "help net" to educate, assist, and refer residents to the proper authorities, and be a reliable source for accurate information and responsive assistance with Medicare, Medicaid, and other health-related scams, fraud, or abuse.


Unfortunately, scams and fraudulent behaviors against kūpuna are not limited to Medicare, Medicaid, and other health-related scams. As a community, we have all experienced the increase of other types of scam behaviors on our phones, social media accounts, emails and even the television ads that harangue us with enticing offers that are "too good to be true!" Our shorelines no longer protect us from the barrage of scams that inundate us due to our growing reliance on the internet and social media in our daily lives.

Hawai'i ranks number one nationwide in longevity at 81.3 years of age! As the population of those age 65 and over is projected to grow, so has the incidence of scams that target this vulnerable group. The frequency and complexity of scams have grown significantly as con artists know that Hawai'i's people are very giving and trusting of others by nature and the potential for harm to this targeted group continues to rise disproportionally.

SMP Hawai'i receives various statewide inquires on our dedicated Helpline and our interactive website from kupuna calling for assistance and are too ashamed and embarrassed to reach out to their own loved ones. SMP provides a clearing house for kūpuna, their families, and caregivers to call for help.

SMP Hawai'i operates statewide providing a toll-free helpline, provides 1:1 counseling and referrals and conducts community outreach to underserved groups and communities to expand access and assistance for Medicare, Medicaid, and other health-related scams, fraud, or abuse as well as many other types of scams and fraud against kūpuna.

In response to the rise in scams, SMP Hawai'i has established a network of partnerships across the finance, technology, legal, and retail industries to triage non-health related fraud cases to the proper authority to provide timely assistance with gift card and charity schemes, romance, caregiver, and imposter scams and ransomware that trick older adults into giving away their personal information and money.



Unfortunately, the prognosis for kūpuna's safety does not look promising. Annually, Medicare loses an estimated \$70 billion dollars to fraudulent claims. Criminals steal an average \$34,200 per victim. Hawai'i reports over \$17 million lost annually to online scams. If we don't increase community awareness and continually educate kūpuna about the most recent scams, Hawai'i is projected to lose more than \$53 million annually by 2035!

In 1997 EOA received the first SMP grant and established two temporary full-time equivalent (2.0 FTE) staff. Twenty-five (25) years later, the program is still managed by these two positions, while the Medicare population in Hawaii has nearly doubled in size and the frequency and types of scams have increased significantly. The following table compares states with similar full-time staff and demonstrates the disparity based on the Medicare beneficiary population being served.

## \*Hawaii's aging population is growing more rapidly than any other state in the country.

EOA's mission is "To optimize the health, safety and independence of Hawai'i's older adults and people with disabilities. We support kūpuna and their caregivers through planning, development, advocacy, and coordination of policies, programs, and services." Without an increase in staffing, EOA is limited in our ability to safeguard against further kūpuna victimization and preserve the Medicare program, thus jeopardizing EOA's directed mission.

The passing of this bill to establish three (3) permanent full-time positions will allow EOA to increase capacity to meet the demands for timely, accurate, and reliable services to kūpuna, family members, and caregivers in need and ensure a stronger and wider "help net" for the most valued asset, our islands' kūpuna.

**Recommendation**: EOA strongly supports the intent of this measure provided that its enactment does not reduce or replace priorities with the Administration's budget request.

#### Support for SB1592, Relating to Funding for the Senior Medicare Patrol

As an SMP volunteer since September, 2011, I have a special devotion to this program that informs and educates kupuna and all ages to protect themselves from fraud and scams. As an active volunteer in performing various roles, including printed media and television assignments, I have received attention, giving me the opportunity to relay our mission to prevent, detect, and report scams and fraud.

I observed a surge in membership and services in my first seven years followed by a period of decline in membership a few years before and during the pandemic when there were several turnovers in the positions of director and volunteer coordinator, which went unfilled during part of the pandemic. During this time we began to see a gradual turnaround with innovative projections and a vigorous effort to meet the demands in technology to improve our presentations, counseling, and outreach to the public. Since then we are beginning to have better training, mentoring, and retention of the core volunteers with both the director and a volunteer coordinator, who was recently hired. However, with fraud and scams growing by *"leaps and bounds,"* it is paramount that we acquire funding for additional program specialists.

With faith that the increasing demands for our services will be met with additional staffing, I would like to share a few personal examples that have kept me firmly grounded as a contributing volunteer:

At a tabling event at the Kahala Mall last year, a stranger came up to thank me for participating in a public service television skit that I did with two other volunteers and a program specialist from the EOA. She appreciated how our skit helped her to be more aware of financial fraud, causing her to be concerned that her vulnerable mother will not become a victim when answering scam phone calls. I was quite surprised that she recognized me as the narrator, who addressed the viewers with lines like "It's not your fault!" and "Please report suspected scams to SMP..." After three years, they're still running this skit or just my narrator's segment on KGMB, seen during commercial breaks on Jeopardy, my favorite game show. According to my son, his friends on the mainland have reported seeing this segment on Facebook, so the far reaching effects of social media are helping to spread our mission to a wider audience. Occasionally I receive friendly phone calls or emails from kupuna who thank me for information given in previous individual interactions when I have cautioned them about not answering suspected scam phone calls, trashing suspicious snail mail, and not pressing on unfamiliar links in emails. I am reassured that my kupuna friends who recognize the red flags will not fall prey to scammers.

Another role that brings joy in being a fraud watch volunteer is when I conduct reference check interviews for volunteer applicants and at the end of the interview, the references often say, "Thank you for what you do to help protect us from scams and fraud." Hearing these words of appreciation is encouraging that our message is being heard and heeded.

I humbly ask for the committees' favorable support of SB1592 for funding our need for additional program specialists, so that SMP will be better able to fight against fraud and scams in Hawaii and to make this a safer place especially for our silver-haired generation that is also growing by *"leaps and bounds.*"
