The Hawaii State Teachers Association <u>supports SB 1596</u>, relating to school campuses. The bill establishes and appropriates moneys for a Maui campus housing pilot program, to be administered by the School Facilities Authority which shall make on-campus housing available to employees at Lahainaluna and Kulanihakoi high schools on the island of Maui. It also requires the School Facilities Authority and Department of Education to submit joint reports to the Legislature.

Hawai'i continues to suffer from a shortage of licensed teachers with over 1000 vacancies each year. Affordable options for teacher housing is one key strategy for the recruiting and retaining of teachers, particularly given that Hawai'i's teacher salaries continue to trail the nation, when adjusted for cost of living. Housing is a big portion of each teacher's paycheck.

If we concentrate on retaining our teachers, the Department of Education would not have to focus so much on the recruitment. To recruit and retain effective educators, policymakers must find ways to lessen the financial burden of being a public school teacher. Establishing an on-campus housing program on Maui is a good first step. An affordable housing option on campus would not only help teachers with affordable housing, but cost of living broadly would arguably be lessened. The ability to walk to work would save both in travel time and gas. The price of which remains very high.





Chairs Kidani and Chang and Members of the Committees:

The Department of the Attorney General (Department) provides the following comments.

The bill establishes and appropriates moneys for a Maui campus housing pilot program (Pilot Program), to be administered by the School Facilities Authority (SFA), which shall make on-campus housing available to employees at Lahainaluna and Kulanihakoi High Schools on the island of Maui. The bill also requires the SFA and Department of Education to submit joint reports to the Legislature. The Pilot Program shall commence on July 1, 2023, and end six years later, on June 30, 2029.

The Department wishes to propose one modification to address an issue concerning SFA's powers. As noted in the bill (page 1, lines 13-17), section 302A-1703(a), Hawaii Revised Statutes, requires that the SFA "be responsible for all public school development, planning, and construction related to capital improvement projects assigned by the legislature, governor, or board of education." The bill, however, requires the Pilot Program to be "administered" by the SFA (page 2, line 12). The SFA has no express power and authority under current law to administer teacher housing programs. Thus, once the development, planning, and construction of the on-campus housing is complete, continued administration of the Pilot Program, as it may relate to charging or collecting rent, managing the properties, or other administrative duties, would need to be handled by a different entity.

The Department respectfully recommends the following amendments:

- 1. Revise section 2(a) (page 2, lines 11-16) as follows:
 - (a) There is established a Maui campus housing pilot program, to be administered by the school facilities authority[-] during the planning, design, and construction of the on-campus housing. The program shall make on-campus housing available to teachers, staff, and administrators employed at Lahainaluna and Kulanihakoi high schools on the island of Maui. The program shall commence on July 1, 2023, and end on June 30, 2029[-]; provided that after construction of the on-campus housing is completed, [entity] will administer the program.
- 2. Add the following statement to section 2(b), after paragraph (3):

 The school facilities authority shall not be required to participate in submitting the joint report to the legislature the year after the completion of the construction of the on-campus housing, if submission of the joint report is still required at that time.

Thank you for the opportunity to testify in **support** of this important measure. This measure would appropriate moneys, to be administered by the School Facilities Authority, for a pilot program to implement the planning, design, and construction of on-campus housing for employees at Lahainaluna and Kulanihakoi high schools on the island of Maui.

The Maui County Council has not had the opportunity to take a formal position on this measure. Therefore, I am providing this testimony in my capacity as an individual member of the Maui County Council.

I **support** this measure for the following reasons:

- 1. Maui County's lack of attainable housing is a limiting factor to attracting and retaining quality, specialized school teachers, staff, and administrators.
- 2. Lahainaluna and Kulanihakoi high school campuses already have existing infrastructure and are located near high traffic roads, which makes them ideal locations for the pilot project proposed by this measure.
- 3. Using existing infrastructure and state property to provide on-campus housing for school employees would reduce costs, construction time, and traffic congestion.

For those reasons, I **support** this measure.
