In consideration of SENATE BILL 193 RELATING TO THE STATE FIRE COUNCIL

Senate Bill 193 proposes to add to the membership of the State Fire Council, and to the membership of advisory committees that the Council may appoint, representatives from the Hawaii State Aircraft Rescue Fire Fighting Unit and the Division of Forestry and Wildlife of the Department of Land and Natural Resources (Department) to reflect all non-federal fire-fighting agencies in the State. **The Department supports this measure.**

The Department's Division of Forestry and Wildlife (Division) is the primary responder for wildfires on 26% of the land area in Hawai'i and has approximately 150 staff trained to respond. The Division has agreements with federal and county agencies for jointly responding to fire events and works closely on fire response across the State. Becoming a member of the State Fire Council would provide another opportunity for the Division to engage with county fire departments on fire issues that affect natural resources and public safety.


