The Hawaii Coalition for Child Protective Reform strongly SUPPORTS SB406, SD1, HD1, Relating to Child Visitation. Aloha Chair, Vice Chair and members of the committee,

My name is Misty Kuheana and I strongly support SB406 SD-1 HD-1 and believe the necessary steps were taken in amending this measure to satisfy any existing federal and state precedent.

I myself am a grandparent who played a significant role in raising my grandchild who lived with me from birth until my daughter's untimely death when her biological father took her and denied me all contact with her for reasons only known to him.

After many failed attempts to mediate and address any reservations he had, I felt my only option was to take him to court and sue for visitation rights . There I was told by the judge that he could not support my claim because in the state of Hawaii there are no Grandparents Rights! therefore I was at the fathers whim unless a law would be passed that would allow me this right.

It has been 2 yrs.7 mos. and 23 days since I've seen my granddaughter and everyday has been a painful struggle. So I humbly ask that you pass SB406 SD-1 so that me and so many grandparents like me have a chance to bond with our grandchildren and teach them important values such as respect, pride and tradition which too many of our youth today do not possess.

Our Kupuna's are the ones that have instilled these values in us as this Olelo perfectly explains " Ulu Na Lala no ke kumu " which translates to " The Branches grow because of the trunk " .

The responsibility is ours but for some of us the decision is in your hands, and it is my biggest hope that you find favor in this measure.

You, our legislative congress are the Kupuna's of Hawaii and we are relying on you to make the right decisions. The fate of our families are depending on you.

If you should for any reason have reservations about this bill just ask yourselves "What would my grandparents say? " or reflect on your own childhood and picture it without your grandparents, I'm sure you'll find that hard to imagine.

I wholeheartedly believe that passing this measure will bring families together and in extension lay down a stronger foundation by building better relationships.
