> SENATE BILL NO. 637 SD1 RELATING TO HEMP

Chairperson Gates and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 637 SD1. This measure amends hemp processing rules to allow licensed hemp farmers to process hemp in agricultural structures and buildings that are permit-exempt under section 46-48, Hawaii Revised Statutes, as well as food hubs and agricultural parks, as was allowed prior to 2021. The Department of Agriculture (DOA) offers comments.

DOA supports the Hawaii hemp industry but respectfully does not agree with the statement regarding "overregulation of production" on page 2, line 3. DOA does not regulate farming of hemp within the state. The USDA regulates the entire production such as growing, harvesting and other on-farm operations including licensing of Hawaii hemp growers. Monitoring transport of hemp materials (flowers, leaves, viable seeds) and buffer zone restrictions are not part of USDA regulatory function. These are responsibilities assigned to DOA under Act 14, SLH 2020 as amended by Act 137, SLH 2020, that are necessary to ensure such nonfarming intrastate activities are conducted in a safe, healthy, and appropriate manner.



The Hawaii Department of Health (DOH) regulates hemp products and processing of hemp within the state. DOA defers to comments of DOH regarding rule amendment to allow licensed hemp farmers to process hemp in agricultural structures and buildings.

4 **Department Testimony:** The Department respectfully provides the following comments on

5 0637 SD1, which amends Chapter 328G, Hawaii Revised Statues (HRS). The Department

6 supports hemp farmers and seeks to clarify that the good manufacturing practices required for the

7 conversion of hemp plants into a form for ingestion or topical application (such as a tablet,

8 capsule, powder, gelcap, or liquid form) do not apply to hemp farming in general. The general

9 agricultural and incidental operations of hemp farming (including drying, curing, grading, or

10 trimming) are allowed to be exempted from building permit and building code requirements

11 under 46-88, HRS are already currently allowed under 328G, HRS.

Purely agricultural activities such as those likely to be performed in a permit-exempt building pursuant to section 46-88, HRS, are not subject to chapter 328G, HRS. Chapter 328G, HRS, governs hemp processing, which is defined as "making a transformative change to the hemp plant following harvest by converting an agricultural commodity into a hemp product." While section 46-88(a), HRS, allows the counties to exempt from county permitting "agricultural buildings, structures, or appurtenances thereto, which are not used as dwellings or lodging units", section 46-88(c), HRS requires that such "agricultural buildings, structures, or appurtenances

1 thereto are located on a commercial farm or ranch and are used for general agricultural or 2 aquacultural operations, or for purposes incidental to such operations". Hemp processing, which 3 is already defined as something other than a purely agricultural activity, would not be permitted 4 under 46-88, HRS even with the proposed amendment to 328G, HRS. 5 6 The Department also notes that the proposed amendment to section 328G-2, HRS, adds 7 to the list of documents to be provided to the Department as part of an application for 8 registration, but does not change the existing requirement that hemp may be processed only 9 inside an enclosed building. The requirement that hemp be processed only within an enclosed 10 building is found in section 328G-3(b), which provides: 11 12 "Hemp and hemp products shall be processed within an enclosed indoor facility secured 13 to prevent unauthorized entry. Hemp, hemp products, and any toxic or otherwise 14 hazardous by-products of hemp processing, or by-products, including but not limited to 15 delta-9 tetrahydrocannabinol, shall be stored within an enclosed indoor facility, secured 16 to prevent unauthorized entry in a manner that prevents cross-contamination and 17 unintended exposures." 18 19 Since the requirement in section 328G-3(b) that hemp processing be performed only 20 within an enclosed building remains, the proposed amendments requiring submission of 21 documents related to an agricultural exemption will not change the fact that processing must be 22 performed within an enclosed building. Moreover, documentation of an agricultural-based 23 exemption is not particularly relevant information for an application for hemp processing since 24 registration is not required for purely agricultural activity. 25 26 The Department thanks you for the opportunity to provide comments. 27 28 Offered Amendments: None 29 30

Aloha Chair Gates, Vice Chair Kahaloa, and Members of the House Agriculture & Food Systems Committee,

The Hawaii Farmers Union United (HFUU) is a 501(c)(5) agricultural advocacy nonprofit representing a network of over 2,500 family farmers and their supporters across the Hawaiian Islands. **HFUU supports SB637.**

Hemp is a versatile crop that can be used for medicinal and industrial purposes and has seen increased demand due to its numerous benefits. Prior to 2021, Hawaii's licensed hemp producers processed small batches of hemp on their farms in agricultural buildings and structures with no adverse consequences. These types of buildings and structures are regularly used to store and process other crops with no restrictions. However, 2021's hemp processing rules unintentionally eliminated farmers right to process hemp on their farms and in these structures.

By amending the rules to allow producers to process their hemp on the farm, they can save money and remain competitive. By amending this hemp processing rule to allow farmers to process hemp in agricultural structures, it will make hemp production more financially feasible and allow our farmers to thrive.

Aloha Chair Gates and the Committee on Agriculture and Food Systems,

Thank you for your continued support of Hawaii Hemp farmers. The Hawaii Hemp Farmers Association, which is composed of Hawaii hemp farmers, processors, and manufacturers, is in strong support of SB 637 with the following amendment in bold.

This amendment clarifies that processing in agriculturally exempt structures is allowed only for certain processes that don't involve compressed gas, etc.

(4) Documentation that the indoor facility and planned hemp processing operation complies with all zoning ordinances, building codes, and fire codes<u>: or for processing that does not include heat or volatile compounds or gases under pressure, such as cold-water extraction, documentation that the processing is an enclosed indoor facility that is a permit-exempt structure pursuant to section 46-88; or is in an enclosed indoor facility in a food hub or agricultural park;</u>

SB 637 is needed because current rules,

1.) Are not flexible enough to allow hemp processing in HRS 46-88 ag buildings where there are no safety issues. These safe processes include extractions with ice water or coconut oil using a hand screw press and don't use chemicals or heat or compressed gases. If an agricultural building is exempt per HRS 46-88, it is not permitted and therefore there is no way to prove that the building meets building codes other than going through the expensive process that would require permitting - secure architectural and engineering stamped plans, which defeats the purpose of HRS 46-88, which in part, is to make agriculture feasible for farmers. Some hemp processing methods are as safe as washing cucumbers, therefore, should be fully exempt per HRS 46-88. We agree with the

Department of Health that for processes that include heat, volatile compounds, or compressed gases, documentation of compliance with codes is important.

2.) Exclude farmers from accessing almost all food hubs and some ag parks because of 500-foot buffer requirement for hemp processing. Most food hubs are within 500 feet of other structures, some of which are rural residences. Given current hemp rules and regulations, it is impossible for hemp farmers to use the cold and frozen storage facilities at food hubs and ag parks or to use their facilities to set up small batch processing. Therefore, allowance for farmers to process in food hubs and agricultural parks is needed. Food hubs often have the capacity to apply for funding for infrastructure that serves numerous farmers. Without this allowance for hemp processing at food hubs and ag parks, hemp farmers continue to be singled out and forbidden from accessing opportunities allowed for every other farmer in the state.
