# **TESTIMONY ON SENATE BILL 685** RELATING TO FIREARMS Before the Senate Committee on Public Safety and Intergovernmental and Military Affairs Friday, February 10, 2023; 3:05 p.m. State Capitol Conference Room 225, Via Videoconference

## WRITTEN TESTIMONY ONLY

Chair Wakai, Vice Chair Elefante, and members of the Committee:

The Department of Law Enforcement (DLE) recommends that the Legislature address the issues of this bill through Senate Bill 1282 or House Bill 984, which are the Administration's comprehensive bills on this subject.

The administration measures address many of the firearms related issues facing the State following the United States Supreme Court decision in N.Y. State Rifle & Pistol Ass'n, Inc. v. Bruen, 142 S. Ct. 2111, 2133 (2022), which held that the Second Amendment provides for an individual right to keep and bear arms for lawful purposes and the states retain authority to enact "a 'variety' of gun regulations." id. at 2162. The Attorney General has addressed the Constitutionality or legality of the various provisions of these bills that address a variety of firearms related issues facing the State and this Legislature. For this reason, the DLE recommends that the Legislature pass one of the Administration's bills, Senate Bill 1282 or House Bill 984.

The Hawaii Firearms Coalition (HIFICO) provides COMMENTS FOR SB685

HIFICO agrees with the intent of SB685 in that firearms cannot be used to threaten others unless used in self-defense. However we believe that the current law of terroristic threatening already covers the intent of this bill.

Should you still intend to move forward with this bill, HIFICO wants assurances that legal gun carriers are not charged with this crime for accidental displays of a firearm that can be taken out of context. Such as a gust of wind exposing a firearm under a shirt when conversing with someone that may see that as a threat. To avoid this issue I recommend amending this bill to only apply to intentional acts and removing "<u>or in reckless disregard of the risk of terrorizing</u>"

There needs to be clear protections in the event a firearm is displayed in prevention of crime. Attached is an Arizona law that protects people displaying arms in prevention of crime from prosecution that can be used as an example as an amendment to this bill.

I stand in opposition to this bill. I have more than a few concerns about the vagueness of the bill, I'm also curious as to how you can prove intent. Since Hawaii has been forced to comply with the constitution and start issuing carry permits, I have heard and seen numerous letters and comments saying that if they see or even suspect someone has a gun in public they will scream bloody murder and do all they can to cause a panic.

And we've seen how this can quickly escalate, we had an incident at Kaiser Moanalua where a man was walking around openly carrying a taser in the parking lot. The man was literally minding his own business when a report was made to security with someone saying there was a man with a gun and the hospital went into lockdown, and quickly escalated online with people saying there was an active shooter, and a man with a machine gun was going through Kaiser executing patients.

While in practice we do not have the right to openly carry firearms. What happens when despite my best attempts to keep my gun concealed it becomes accidently exposed and someone sees it and causes a panic, will I be charged with brandishing under this law? What happens if I'm riding with someone and we get into a road rage incident and my friend says 'you better watch your mouth, my friend has a gun and will shoot you'? What happens if an incident occurs where I am justified to use force to defend myself and simply exposing the gun is enough to end the conflict, but later my assailat says I threatened them for no reason?

Bruen specifically states that any law or limitation to keep and bear arms must have historical precedent from when the 2nd amendment was ratified in 1791 or re-ratified 1868. The burden is on the state to prove their laws and limitations are based on those historical precedents. Justice Thomas wrote in Bruen: The right to keep and bear arms in public for self defense is not

"a 2nd class right, subject to an entirely different set of rules than the other Bill of Rights guarantees." If you do not stand by the Constitution, you do not belong in your position. We are a Constitutional Republic, not a democracy. The law clearly states "shall not be infringed [...]". the Constitution protects individual liberties from being abused by the government. A significant accomplishment of the Constitution was finding a means to agree on this basis of power. Any where you limit the ability to conceal carry makes the people in those locations, the most vulnerable. Gun owners are by far the most patriotic, responsible, and law abiding citizens. **SB685**'s attempt to define brandishing doesn't even mirror the plain-English definition of brandishing. Instead, the measure seeks to carve out a broad misdemeanor charge for any inadvertent, non-intentional display of a firearm. A person's "conduct," for example, can be finessed to mean virtually any situation or interaction that the individual is engaged in, including a verbal conversation.

**SB685** simultaneously seeks to make justifiable and intentional display a firearm a misdemeanor during any effort to reduce crime in-progress. In a life-or-death situation where a lawfully armed individual is under immediate jeopardy and seeks to deter a criminal from proceeding with an act of lethal violent force, the armed individual would be guilty of a misdemeanor during any presentation of their firearm to stop the threat. In the previous example presented, **SB685**'s proposed revision to **§707-\_\_ Brandishing a firearm Section (1)**, Subsection (b) would punish the individual seeking to avoid death or other serious bodily injury during the temporary presentation of their firearm in response to a direct threat initiated by another individual.

#### SB685 Will Not Stop Other Criminal Activity

**SB685** will only generate court battles for lawfully armed constituents and will not deter criminals from committing robberies, burglaries, or other brazen actions of violence against the public. Recent news coverage clearly demonstrates how criminals will use whatever means necessary to enact their will. Criminals don't even need a gun to endanger constituents in different senate districts throughout Hawaii.
