Chair Angus L.K. McKelvey and Members of the Committee:

Good afternoon, Chair McKelvey and members of the Committee, my name is Charlotte Carter-Yamauchi and I am the Director of the Legislative Reference Bureau (LRB). Thank you for providing the opportunity to submit written comments on S.B. No. 749, Relating to Advancing Civic Engagement.

The purpose of this measure is to:

- (1) Amend section 21G-2(a), Hawaii Revised Statutes, to require the Public Access Room at the State Capitol (PAR) to establish and maintain an outreach and engagement program for primary, secondary, post-secondary, and community education; and
- (2) Establish a full-time equivalent (1.0 FTE) position for PAR and to appropriate funds for the position.

The Bureau takes no position on this measure but submits the following comments for your consideration.

PAR was established in 1994 to help enhance the public's ability to participate in the legislative process; it became part of LRB in 1996. PAR's office and services are utilized year-

round, offering equipment, services, and facilities to enhance the public's ability to participate in the legislative process. We note that PAR already provides, as part of its services, *universal* community outreach and civic engagement seminars, workshops, and information that are not limited to one specific target audience. Accordingly, students can and do already benefit from these pre-existing educational sessions and information. However, this measure provides funds for a permanent full-time equivalent position, to be placed within PAR, to enable PAR staff to undertake a more targeted educational outreach and engagement program with Hawaii educational institutions.

Should the Committee decide that it would like PAR to explicitly provide educational outreach to Hawaii educational institutions, and authorize PAR to have an additional full-time equivalent position to assist with this augmented purpose, the Bureau would be supportive of that intent. We recommend that in order to truly facilitate the implementation of an effective civic engagement educational program as envisioned in this measure, providing dedicated, complementary counterparts within the Department of Education (DOE) and the University of Hawaii (UH) system, or at least a statutory requirement that each entity coordinate with the Public Access Room to assist with this effort should be strongly considered to ensure cooperation between entities. For the Committee's reference, we have provided a proposed Senate Draft 1, which is attached to this testimony. The new language within the draft:

- (1) Inserts new statutory language to require the Department of Education and University of Hawaii to assign appropriate staff to coordinate with PAR with respect to the new outreach and engagement program;
- (2) Amends the purpose section to reflect the new scope of the bill; and
- (3) Makes technical amendments.

A BILL FOR AN ACT

RELATING TO ADVANCING CIVIC ENGAGEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that civic engagement
2	provides an opportunity for residents to become involved with
3	improving their local communities and neighborhoods. In 2021,
4	the supreme court enacted Rule 23 to establish the commission to
5	promote and advance civic education (PACE commission). One of
6	the main functions of the PACE commission is to provide
7	leadership, oversight, and initiatives to increase civic
8	education in the community and at schools, increase citizens'
9	knowledge about government, and promote informed participation
10	in government and democracy in the State.
11	The legislature further finds that the public access room,
12	an office under the legislative reference bureau, provides the
13	public with information, equipment, facilities, and services to
14	assist in research activities, educational outreach, and public
15	engagement related to work with the legislature. The

well-positioned to further civic engagement between the

The department shall assign appropriate staff 9 to coordinate with the public access room with respect to the **10** outreach and engagement program described in section 21G-2(a)." 11 SECTION 4. Chapter 302A, Hawaii Revised Statutes, is 12 amended by adding a new section part II, subpart G to be 13 appropriately designated and to read as follows: 14 "\$304A- Coordination with public access room; outreach 15 and engagement. The university shall assign appropriate staff 16 to coordinate with the public access room with respect to the 17 outreach and engagement program described in section 21G-2(a)." 18 SECTION 5. There is appropriated out of the general 19 revenues of the State of Hawaii the sum of \$ 20 much thereof as may be necessary for fiscal year 2023-2024 and 21 the same sum or so much thereof as may be necessary for fiscal

- 1 year 2024-2025 to establish one full-time equivalent (1.0 FTE)
- 2 position within the public access room.
- 3 The sums appropriated shall be expended by the legislative
- 4 reference bureau for the purposes of this Act.
- 5 SECTION 6. New statutory material is underscored.
- 6 SECTION 7. This Act shall take effect on July 1, 2023.

Bill No. and Title: Senate Bill No. 749 Relating to Advancing Civic Engagement

Purpose: Requires the Public Access Room to establish and maintain an outreach and engagement program for primary, secondary, post-secondary, and community education and appropriates funds for one full-time equivalent (1.0 FTE) position to assist in effectuating this requirement.

PACE Commission Position: Strong support

The PACE Commission strongly supports this bill, which would: (1) revise Hawaii Revised Statutes (HRS) § 21G-2 to add that "[a]s part of its duties, the public access room shall establish and maintain an outreach and engagement program for primary, secondary, post-secondary, and community education"; and (2) appropriate funds to establish a full-time position within the Public Access Room.

The proposed amendment to HRS § 21G-2 is important to ensure establishment of the outreach and engagement program, which would have a significant impact in reaching and educating students and citizens across the state about the Legislature. It is also crucially important to have a dedicated position to focus on this important effort, and thus it will be highly beneficial to

have funds appropriated to establish the full-time position in the Public Access Room. These crucial steps would create a positive and focused engagement with students, educators and citizens to promote learning about the Legislature, understanding of and participation in the legislative process, and further interaction with Legislators. The more direct contact that students, educators and citizens can have with the Legislature, and the more they can see the process in action, the more they will understand and want to be part of this key part of our democracy. The proposals in Senate Bill 749 clearly advance the purpose of the Public Access Room to "ensure improved public participation in the legislative process" set forth in HRS § 21G-1.

Having a clearly stated focus on outreach and engagement for student and community education, and the resources to support such an effort, will go a long way. Although there are many in our community who are seeking to advance civics in different ways, having a full-time dedicated position within the Legislature will be a tremendous asset. Such an individual could also collaborate with the Judiciary History Center to bring diverse programming on civic education to students and the community. Moreover, in today's virtual world, having a dedicated position in the Public Access Room would greatly assist students, educators and others with following bills online, watching videoconference hearings, and submitting testimony on issues important to them.

Brief background about the PACE Commission:

The PACE Commission was created pursuant to Rule 23 of the Rules of the Supreme Court of the State of Hawai'i, issued on January 7, 2021. The purpose of the PACE Commission is to promote and advance civic education for students and citizens throughout Hawai'i. The commission has fourteen members appointed according to Rule 23 by the following: Chief Justice of the Hawai'i Supreme Court, Governor, President of the Senate, Speaker of the House, Office of Hawaiian Affairs, Superintendent of the Department of Education, Chief Judge of the U.S. District Court for the District of Hawaii, President of the University of Hawai'i, Dean of the William S. Richardson School of Law, Hawaii State Bar Association, Hawai'i Association of Independent Schools, and two members selected by the other appointed members.

The commission currently has two committees, one focused on civic education in the schools and one focused more generally on civic engagement in the community. The mission statement adopted by the PACE Commission is: "To create, implement and amplify sustainable programs, resources, and practices that improve place-based, constitutionally informed and culturally sensitive civic education and engagement in Hawai'i schools and communities."

Aloha Chair McKelvey, Vice Chair Gabbard and Members of the Committee:

The Hawaii Association of Independent Schools (HAIS) and its subsidiary, the Hawaii Council of Private Schools (HCPS), strongly supports SB 749. HAIS currently serves 114 independent schools and over 33,000 students in Hawai'i. Member schools include several of the largest independent schools in the U.S., as well as some of the smallest. While distinctive with respect to mission and philosophy, HAIS member schools are united in helping children achieve personal and academic excellence.

The Public Access Room at the Legislature currently provides excellent services to members of the community who are not familiar with legislative processes and procedures and who wish to interact with the members of the legislature. This is a much-needed service, and it should continue to be supported. Equally important, I think, is the need for an outreach component of the Public Access Room to inform members of the community and especially to students in our schools of the important role that the legislature – as well as the other branches of government – play in the very existence of Hawaii as a state and the civil society that it supports.

Almost every student recognizes our beautiful state capitol building, but very few understand what goes on inside of it or how it affects their own lives as students in our schools or as citizens of this state. As a result, civic awareness and civic engagement is very low. This situation can be alleviated to some extent by having a knowledgeable educator in the Public Access Room whose role is to be available to schools and community organizations to explain how our system of democratic government works and how they, as citizens, can engage with it.

I think our future as a successfully functioning democratic society depends upon this kind of awareness and engagement; and I respectfully ask your support for this measure and pass it out of committee.

Hawaii Youth Services Network supports SB 749 Relating to Advancing Civic Engagement.

"Youth civic engagement leads to reduced risky behavior, increased success in school and leads to greater civic participation later in life. . . . Civic engagement provides young people with opportunities to gain work experience, acquire new skills, and to learn responsibility and accountability—all while contributing to the good of their communities. "1

Introducing youth to civic involvement at an early age is important because Hawaii voter turnout has declined in recent years. In the past 5 out of the past 6 presidential elections, Hawaii had the lowest voter turnout of all the states. In 2020, Hawaii was one of the 10 lowest states in voter turnout. Voter participation is at the core of active citizenship and a healthy democracy.

Hawaii Youth Services Network coordinates the annual Hawaii Children and Youth Summit, in which youth are provide recommendations to legislators about what Hawaii needs to be a better place to live, learn, and work. In 2023, youth recommendations about vaping prevention and intervention and sexual abuse and exploitation training for teachers have been incorporated into the Keiki Caucus package of bills.

If the program is funded, HYSN would work in partnership with the Department of Education to engage youth in civic affairs. The young people who have participated in the Children and Youth Summit find the experience empowering, and their involvement leads to continued engagement as adults.

I will close with some quotes from Hawaii's youth that have participated in the Hawaii Children and Youth Summit, "This was my first experience in attending a meeting with other youths where our voices matter. . . . I want to make a difference and attending the Summit gave me the courage to step out and share everything I've learned with my fellow students. I know I will never stop speaking up for what is right."

Community Alliance on Prisons appreciates this opportunity to testify in strong support of civic engagement and our amazing Public Access Room. SB 749 requires the Public Access Room to establish and maintain an outreach and engagement program for primary, secondary, post-secondary, and community education and appropriates funds for one full-time equivalent (1.0 FTE) position to assist in effectuating this requirement.

To our knowledge, Hawai'i is the only place that has a room at the capitol for the community to write testimony, ask questions about the legislative process, and to encourage citizen participation. This is such a wonderful service, especially to students who are interested in how their government operates, kupuna who want to share their voices and experience, and advocates, who spend lots of time there between hearings!

We can speak with experience as each session (and even in between sessions) the amazing staff, Virginia Beck and Keanu Young have led some terrific interns each session and it is heartening to long-time advocates that they continue to find new ways to engage the public.

Community Alliance on Prisons urges the committee to pass this important bill onto WAM with support for the appropriation that is so crucial to a vibrant democracy – citizen participation!
