#### WRITTEN TESTIMONY ONLY

Chair Ichiyama, Vice Chair Poepoe, and members of the Committee:

The Department of Law Enforcement (DLE) strongly supports this bill.

This bill changes the circumstances when an agency may seek reimbursement for search and rescue costs by providing guidance on when such costs can be recovered and requiring agencies to seek reimbursement.

State law enforcement is regularly called upon to participate in search and rescue operations for people who have ignored posted warnings, left defined hiking trails, and ventured into closed areas that have been posted. These situations are not the standard search and rescue of lost or injured persons which are anticipated and part of expected operations of first responders. These are situations created by reason of an individual's choice to ignore warnings and efforts of government agencies or private landowners to keep them safe. When first responders are called upon to engage in these types of extensive search and rescue operations, ongoing operations must be put on hold and agencies often incur additional unbudgeted costs and expense. Requiring agencies to pursue reimbursement in these situations is a reasonable requirement.

SUBJECT: Senate Bill No. 786, S.D. 1, Relating to Search and Rescue

I am Major Shellie Paiva of the Specialized Services Division of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD opposes Senate Bill No. 786, S.D. 1, Relating to Search and Rescue. This bill requires government agencies to seek reimbursement for search or rescue expenses from certain persons if the need for the search or rescue was caused by the person's disregard of posted warnings and closure signage. The HPD opposes this bill as there is no existing mechanism to seek reimbursement for these situations.

In addition, it may deter or delay prompt notification of first responder agencies by persons who may need to be rescued. Such a delay in a request for assistance could make the situation worse and further endanger the lives of those persons as well as first responders. If the injury is not serious and someone knows they have broken the law and shall face monetary reimbursement, there is a chance they will not call for help and try to get out on their own, making the situation worse. The same would apply for a hiker who is lost but does not call for help for fear of a mandatory reimbursement and ends up injured or in a perilous location, making the search and rescue more dangerous. Such calls for service could place an unnecessary risk to first responders.

I am a current member of the Honolulu City Council representing District 5 and serving as the Chair of the Zoning Committee. I stand in support of SB 786 SD1, which requires government entities to seek reimbursement for search and rescue expenses for persons who require rescue after ignoring warning signs, leaving a hiking trail to enter a prohibited area, or hiking on a trail closed to the public.

As stated in the Bill, Hawaii is home to some of the most beautiful hikes and outdoor activities. In District V alone, we have trails that are popular among both locals and tourists alike. But with these trails comes a responsibility of respecting our aina and our laws. There are trails on Oahu that have been prohibited due to erosion, safety hazards, a lack of public access points, and more. Ultimately, these trails are dangerous.

When hikers ignore posted warning signs, leave hiking trails and enter prohibited areas, or enter trails that are closed to the public, they not only put themselves in danger, but they put first responders at risk and cost taxpayers thousands of dollars. Efforts, like the reimbursements sought in SB 786 SD1, are one of the many steps needed to discourage people from entering these illegal trails. They are also a way for the government to recoup costs that would otherwise be a burden to law-abiding taxpayers. More importantly, this measure could help to keep our first responders from putting their safety at risk unnecessarily.

The Hawaii Fire Fighters Association (HFFA), Local 1463, IAFF, AFL-CIO, represents more than 1,900 professional active-duty fire fighters throughout the State. The HFFA, on behalf of all our members, supports S.B. No. 786, S.D. 1, which requires government entities to seek reimbursement for search and rescue expenses for persons who require rescue after ignoring warning signs, leaving a hiking trail to enter a prohibited area, or hiking on a trail closed to the public.

Most recently, on March 6, 2023, the Honolulu Fire Department responded to an injured hiker on the Stairway to Heaven Trail in Kaneohe which has been off limits since 1987. Two engine companies, Rescue Company No. 2, Battalion Chief and Air One were dispatched to this incident. Rescue 2 personnel and Air One made multiple trips to bring the injured hiker along with the other hikers to safety. The maximum fine that these hikers face is a \$1,000 fine and/or 30 days of imprisonment. There are too many instances like this that the fire departments across the State respond to for those who blatantly disregard the law.

The HFFA believes ANY emergency incident and specifically, any rescue operation, regardless of how simple or complex, can have catastrophic consequences. We need to put firefighter safety first, which is to reduce the overall number of rescues our members must perform. The first step is to create a deterrent to try and reduce or eliminate the unnecessary rescues in areas that are restricted from public use.
