- 1 Agency's Position: The Office of Language Access (OLA) supports the intent of the Senate Bill
- 2 814, as it requires the Office of Enterprise Technology Services (ETS), in consultation with the
- 3 Office of Language Access and a working group composed of stakeholders, to develop and
- 4 publish electronic information technology multilingual accessibility standards to be implemented
- 5 by all state entities. We offer the following comments.
- 6 Agency's Testimony: The aspirational and exploratory goal of this measure is in line with
- 7 OLA's mission, which is to address the language access needs of persons with Limited English
- 8 Proficiency (LEP). OLA is tasked to provide technical assistance and to coordinate resources to
- 9 reduce the burden of meeting language access obligations. OLA is charged with providing
- oversight, central coordination, and technical assistance to all state and state-funded agencies in
- their implementation of language access compliance.
- Hawaii is one of the most culturally diverse states and has one of the highest proportions of non-
- English speakers in the nation. According to the U.S. Census Bureau, 2017-2021 American
- 14 Community Survey (ACS) 5-year estimates, an estimate of 25.9% or 353,663 of Hawaii
- residents, 5 years and older, speak a language other than English at home. Of those, 152,929 or
- 16 11.2% indicated that they speak English "less than very well." English proficiency (or a lack of)
- has a great impact on people's economic and social activities, and health literacy and wellness. It

- 1 effects their ability to successfully access education, employment, and important public
- 2 assistance, benefits, programs and services.
- 3 Many state agencies are currently using their websites, portals, and digital platforms in a
- 4 multitude of ways. Digital delivery systems provide critical information and services to our
- 5 residents, are used to accept applications for importantbenefits, and to access and manage online
- 6 accounts. Providing persons with LEP with easy-to-find government digital information could
- 7 encourage their participation in government services, programs, and activities. Establising
- 8 electronic information technology multilingual accessibility standards will provide a critical link
- 9 to communication and make government services accessible to persons with LEP.
- 10 Although OLA does not have the technical expertise in Information Technology (IT), this
- measure will allow OLA to work closely with other partners to further improve language access
- in our state government. If the measure is passed, OLA will collaborate with ETS in providing
- our expertise in the area of language access to support the creation of the accessibility standard.

## SENATE BILL 814 RELATING TO ELECTRONIC INFORMATION TECHNOLOGY ACCESSIBILITY FOR PERSONS WITH LIMITED ENGLISH PROFISIENCY

Dear Chair McKelvey, Vice Chair Gabbard, and members of the committee:

The Office of Enterprise Technology Services (ETS) is in **support of the intent of** this bill, which requires ETS in consultation with the Office of Language Access and a working group composed of stakeholders, to develop and publish electronic information technology multilingual accessibility standards to be implemented by all state entities. We offer the following comments.

We recommend section (3)(c)(1) be changed as follows:

"(1) Require that all electronic information <u>technology</u> developed, purchased, used, or provided by a state entity be made language accessible to persons with limited English proficiency, as provided by title VI of the Civil Rights Act of 1964 (42 U.S.C. 2000d); Executive Order No. 13166; Executive Order No. 14031; and chapter 321C, Hawaii Revised Statutes; and"

We also recommend that the definition of "Electronic information technology" be limited as it is currently overbroad for this purpose. For example, operating systems and robotic process automation, among others, should not be included.

We recommend the definition be changed to:

"Electronic information technology" means electronic information, software, systems, and equipment used in the creation, manipulation, storage, display, or transmission of data, including: as defined in the electronic information technology standards for multilingual accessibility.

(1) Internet and intranet systems;

- (2) Websites and interfaces;
- (3) Software applications;
- (4) Operating systems;
- (5) Video and multimedia;
- (6) Telecommunication products;
- (7) Electronic and digital kiosks;
- (8) Information transaction machines;
- (9) Copiers and printers;
- (10) Desktop and portable computers;
- (11) Robotic process automation; and
- (12) Natural language processing.

The requirements set forth in the standards may have a chilling effect on procurement and modernization as the cost and rigors of compliance increase. The cost of adding multilingual accessibility capacity to state electronic information systems could cost tens of millions of dollars and add years of time to our modernization schedule.

ETS does not have existing staff for this purpose and adding a Program Manager at a cost of \$100,000 will be necessary to be successful.

The Hawai'i Coalition for Immigrant Rights is in **full support of SB814**, which requires the Office of Enterprise Technology Services in consultation with the Office of Language Access and a working group composed of stakeholders, to develop and publish, and periodically review and update, electronic information technology multilingual accessibility standards to be implemented by all state entities.

SB814 is vital in ensuring that all residents in Hawai'i, regardless of their language proficiency, have equal access to the electronic information technology provided by the State. Electronic information technology plays a critical role in our daily lives: from accessing government services and programs to finding employment. With this role in our society, we have to ensure equal access and for many Limited English Proficiency individuals, this technology can be a barrier.

As we saw during the COVID-19 pandemic, the landing pages of key departmental offices like DLIR's Unemployment Insurance and the Hawai'i Med-QUEST division offices are essentially their public-facing connection. When these pages do not have consistent language accessibility it hampers the ability of those that need them most to access them. Language access is not just a "nice" idea for Hawai'i's large Limited-English Proficient communities, it is federal law. Under the 1964 Civil Rights Act Title VI and the Social Security Act any entity receiving federal funds is required to make their services accessible to speakers of other languages. Websites like <a href="https://www.lep.gov">www.lep.gov</a> offer excellent resources for state and local governments to get in compliance with federal law and avoid potential lawsuits.

The Hawai'i Friends of Civil Rights works to achieve equity, justice, inclusion, uphold civil rights, and eliminate discrimination. We stand in **Strong Support of Senate Bill 814.** 

The 2019 State of Hawai'i Data Book reports Hawai'i's total population of persons five years of age or older at 1,331,641. Within this population 348,130 or one in four persons reports speaking a language other than English at home. Of this cohort, one in nine Hawai'i residents or 161,055 persons is limited English proficient (LEP). The top languages spoken by LEP Hawai'i residents are Ilocano, Tagalog, Japanese, Chinese, Hawaiian, Korean, Samoan, Vietnamese, Chuukese, and Marshallese. Hawai'i ranks sixth in the nation with the highest percentage of LEP persons.

An array of federal and Hawai'i laws, regulations, and legal decisions require recipients of federal or state funding to translate vital documents and provide digital access to LEP persons seeking access to federal or state-funded services. Federal authorities include Title VI of the Civil Rights Act of 1966, Executive Order No. 13166 signed by President Clinton in 2020, Chapter 321C Hawaii Revised Statutes, and Lau v. Nichols, 414 U.S. 563 (1974).

Despite the clear mandate to provide accessible services for LEP persons, Hawai'i has been repeatedly cited by the federal court, federal offices for civil rights, and the Hawai'i Civil Rights Commission for its failure to provide language accessible services. Senate Bill 814 offers Hawai'i a path forward.

## TESTIMONY TO THE SENATE COMMITTEE ON GOVERNMENT OPERATIONS

Senate Bill 814 – Relating to Electronic Information Technology Accessibility for Persons with Limited English Proficiency

The Disability and Communication Access Board (DCAB) provides comment on Senate Bill 814 – Relating to Electronic Information Technology Accessibility for Persons with Limited English Proficiency.

Senate Bill 814 would require the Office of Enterprise Technology Services, in consultation with the Office of Language Access and a working group composed of stakeholders, to develop and publish, and periodically review and update, electronic information technology multilingual accessibility standards to be implemented by all state entities.

Individuals who do not speak English as their primary language and who have a limited ability to read, speak, write, or understand English can be limited English proficient (LEP). This may include individuals who are deaf or hard of hearing and communicate using American Sign Language (ASL). Since ASL is a visual language with no written equivalent, individuals who are deaf or hard of hearing may not use English as their primary language. If English is not the primary language of an individual who is deaf or hard of hearing and the individual has difficulty communicating effectively in English, ASL may be necessary to have meaningful access to state programs, services, and activities. The electronic information technology multilingual accessibility standards should address ASL where meaningful access to electronic information technology is an issue for LEP individuals who are deaf or hard of hearing.

Teri Keliipuleole Jasmine Slovak Erica Yamauchi During the first two years of the pandemic, non-profit organizations like ours worked hard to help limited English proficiency (LEP) families access the federal pandemic relief benefits that they qualified for. We focused mostly on outreach to parents who qualify for Pandemic EBT (food purchasing funds when low-income keiki and their families) and the enhanced Child Tax Credit.

While working on this outreach, we learned that our state departments lack resources to provide meaningful language access, and that the federal government and national advocacy organizations do not provide translations of key documents<sup>1</sup> in many of the languages that are the most spoken by LEP families in Hawai'i<sup>2</sup> – such as Ilocano, Marshallese, and Chuukese.

As one of the states with the highest portion of foreign-born residents,<sup>3</sup> combined with the lack of existing resources for translations of government documents and outreach materials into many of the languages that are spoken most here, Hawai'i arguably needs to devote more resources to ensure language access to our government services than most other states. That's why this bill so important.
