
Chair Dela Cruz, Vice Chair Keith-Agaran, and members of the Committee:

The Department of Law Enforcement (DLE) recommends that the Legislature address the funding elements of this bill through Senate Bill 1339 or House Bill 1041, which are the Administration's comprehensive bills to establish an illegal fireworks task force to plan, coordinate, and engage in law enforcement operations to interdict illegal fireworks, develop a comprehensive strategic plan to stop the importation of illegal fireworks and explosives into Hawaii, promote compliance with the state fireworks control laws, and ensure the safety and security of airports, harbors, and other facilities and institutions in the State against the discharge of illegal fireworks and explosives.

The Illegal Fireworks Task Force is focused on concerted multi-jurisdictional law enforcement efforts to investigate, interdict, arrest, and prosecute those violating county, State, and federal fireworks laws. The DLE has already initiated cooperative dialog with appropriate law enforcement agencies and will continue to develop the law enforcement relationships needed to for successful operations and the development of an appropriate strategic plan and recommendations to the Legislature.

Thank you for the opportunity to submit comments on this bill and recommend the passage of one of the administration bills on this subject, Senate Bill 1339, or House Bill 1041.

In Strong Support of SB 821 – Relating to Fireworks Senate Committee on Ways and Means Wednesday, Feb. 15, 10:30 am

Aloha Chair Dela Cruz and members of the committee,

Poi Dogs & Popoki (PDP) is a nonprofit animal welfare organization with a mission to help people and their pets. We are in strong support of SB 821.

In 2019, the legislature passed a fireworks law that holds the property owner or tenant liable for any illegal fireworks ignited on their property. That law specifically allows drone video to be used in the identification and prosecution of illegal fireworks defendants.

In the past year, I've filed 6 police reports citing the address of the illegal fireworks and committing to testify in the prosecution. Every year previously, I've filed similar reports. To date – none have been prosecuted. And I am aware that only one case was sent to the prosecuting attorney's office. The defendant didn't show up to court so the prosecuting attorney's office threw out the charges.

I know most people do NOT want to report their neighbors. So this bill could provide the public with SOME level of peace of mind that more is being done by the police to investigate and prosecute illegal fireworks users. For many of us — our quality of life has deteriorated because the bombs are blown year round — and especially from October through New Years. Please support SB 821. It really is a small price to pay.

Aloha Chair Dela Cruz, Vice-Chair Keith-Agaran and Committee Members:

We present this testimony in COMMENTING on SB821, which requests up to \$1,000,000 in funding for drones to monitor illegal fireworks usage. While drones could prove valuable tools in determining the origins of AND monitoring illegal fireworks usage in Hawai`I, our concerns, among others, are that this equipment could in fact be seriously damaged by aerial fireworks in the course of their operations.

Funding for drones should perhaps be folded into Gov. Green's administration's bills SB1339 or HB1041, which would establish illegal fireworks Task Force to plan, coordinate, and engage in law enforcement operations to interdict illegal fireworks, develop a comprehensive strategic plan to stop the importation of illegal fireworks and explosives into Hawaii, promote compliance with the state fireworks control laws, and ensure the safety and security of airports, harbors, and other facilities and institutions in the State against the discharge of illegal fireworks and explosives.

Another concern is that these fireworks are but a mechanism to import an array of other illegal substances, like narcotics. So, while the intention of employing drones to monitor illegal fireworks is admirable, funds would be better spent on appropriations for SB1339 and/or HB1041.
