





The Department of Transportation (DOT) provides the following **comments** on this measure that authorizes the department to regulate commodities and manifested cargo manned by existing local stevedoring companies.

DOT considers this proposed change as a regulation of labor and not a regulation of facilities. This level of regulation of labor falls outside the purview of DOT. As such, DOT recommends that the committee amend this measure to place the authorization in an appropriate chapter of the Hawaii Revised Statutes that controls labor, such as Chapter 382.

### Chair Lee and Members of the Committee:

The Department of Attorney General provides the following comments.

The purpose of this bill is "to require commodities and manifested cargo requiring tug assistance to be manned by an existing, operational stevedoring company that is currently operating in the State."

The title of this bill is "A Bill for an Act Relating to Mooring Lines." Article III, section 14, of the Hawaii State Constitution requires that "[e]ach law shall embrace but one subject, which shall be expressed in its title." The requirement of this section is mandatory, and a violation results in invalid legislation. Schwab v. Ariyoshi, 58 Haw. 25, 31, 564 P.2d 135, 139 (1977). In Schwab, the Hawaii Supreme Court established the germaneness standard that, as long as all parts of an act embrace one general subject, and these parts are so connected and related to each other, whether logically or in popular understanding, as to be parts of or germane to that general subject the bill satisfies the one-subject requirement. "The germaneness standard is an established and enforceable standard and one which courts in Hawai'i have ably applied to the single subject and subject-in-title requirement for over a century." League of Women Voters of Honolulu, 150 Hawaii, 182, 200, 499 P.3d 382, 400 (2021).

In applying the germaneness standard, the content of the bill does not make the connection between its purpose and its subject matter expressed in the bill's title,

"mooring lines." We recommend that wording be added to the bill to explain how the purpose of this bill is connected and related to mooring lines.

We respectfully request the Committee to address the constitutional requirement discussed above.

Subject: TESTIMONY OPPOSING SENATE BILL (824): A Bill For An Act Relating to Mooring Lines

Chair Lee and Committee on Transportation and Culture and The Arts:

Hawaiian Cement opposes SB824 in its current language, given it will disenfranchise or even displace our current employee workforce who are members of the Teamsters Local 996, and thus request an exemption from this Bill.

Hawaiian Cement has provided cement (considered articles of commerce) throughout the State of Hawaii since 1959 and since 1981 provided cement to four Neighbor Island Cement Terminals using its Company-owned 184ft specialized barge called the "Punapau." For over 40 years, our Teamsters local labor workforce has operated and maintained the Punapau, including internal generators powering specialized cement pneumatic equipment. We use a series of plant equipment and pipelines to load from our Kalaeloa Home Cement Terminal to the Punapau which in turn discharges cement pneumatically also through a series of pipelines to our Hilo, Kawaihae, Nawiliwili and Kahului Hawaiian Cement owned and operated Terminals located at these State Harbors.

The current language specifies the "purpose of this Act is to require commodities and manifested cargo requiring tug assistance to be manned by an existing, operational stevedoring company that is currently operating in the State." It further indicates that the Act would direct marine interisland commerce companies to employee local stevedoring companies in the "...loading and offloading of cargo from vessels [barges using tugs] that are based and registered to conduct business in the State." The Bill does not discriminate on the types of barges nor commodities and thus, as currently written, would eliminate our current local Union workforce who have worked directly as permanent Hawaiian Cement barge employees for the past 40 years.

Hawaiian Cement has and continues to pay all wharfage and pipeline fees to the State for all our cement interisland shipping operations. Hawaiian Cement is a locally based company, and with its local Union workforce, also contributes to the State's tax base. Hawaiian Cement has long established relationships with local stevedoring companies who line moore and discharge our larger overseas vessels at the Kalaeloa Harbor as well as loading and unloading interisland aggregate barges thereby adding value to our overall business model. However, we hope the Committee recognizes the impact this Bill would have on our already established local Union workforce with its 40 years of past history suppling our Neighbor Islands with cement who operate and maintain the only cement barge in the islands. We respectfully request the Committee exempt the Hawaiian Cement Punapau operation from this Bill.

For these reasons, we are in opposition to SB824 as currently written.
