<u>**DEPARTMENT'S POSITION**</u>: The Department of Human Services (DHS) appreciates the measure's intent and offers comments.

<u>PURPOSE</u>: The bill's purpose is to appropriate funds for the Department of Human Services to purchase health care services for certain low-income, uninsured immigrants.

DHS supports the intent of this bill and notes that Hawaii's Medicaid program currently provides coverage of emergency medical services to individuals who are ineligible for Medicaid due to immigration status and may be unlawfully residing in the United States. Emergency medical services are available to lawfully present non-citizen who is age nineteen or over and not pregnant; a non-citizen who was never legally admitted to the U.S. for any period or was admitted for a limited time and did not leave when the time expired; or lawfully admitted for a temporary or a specified period as a legal nonimmigrant. These emergency services coverage is provided to stabilize the emergency medical condition. Notably, Medicaid does not cover any follow-up visits resulting from the emergency visit.

Separately, DHS provides health coverage for other immigrants, such as refugees, through its Refugee Medical Assistance Program and to pregnant women and children who are qualified non-citizens or have a lawfully present noncitizen status if they meet all other categorical and financial eligibility criteria for Medicaid.

This measure seeks to appropriate \$1,000,000 or so much thereof as may be necessary for fiscal year 2023-2024 and the same sum or so much thereof as may be necessary for fiscal year 2024-2025 for the purchase of health care services.

However, DHS notes that providing state-funded health coverage to the estimated 11,000 uninsured individuals identified in the preamble may require a general fund appropriation of at least \$30 million per year to cover this population with an additional appropriation to DHS for human resources and system modifications to support the creation and administration of this new program. Also, these additional services will not be eligible for any federal matching funds and must be 100 percent state funded.

The Hawai'i Friends of Civil Rights works to achieve equity, justice, inclusion, uphold civil rights, and eliminate discrimination. We stand in **Strong Support of Senate 842.** 

SB 842 appropriates funds for the purchase of healthcare services for low-income uninsured immigrants who are ineligible for health care through Medicaid, the Children's Health Care Insurance Program (CHIP), or the federal Affordable Care Act (ACA). These individuals are either undocumented or deferred action for childhood arrivals (DACA).

It is estimated that 45,000 undocumented persons reside in Hawaii. Many of these individuals secure health care insurance through the Hawaii Prepaid Health Care Act which does not deny coverage based on immigration status. Approximately 11,000 Hawaii's undocumented immigrants are uninsured with 43% of these households reporting incomes below 200% of the federal poverty guidelines.

Many low-income residents in Hawai'i, insured and uninsured, obtain quality healthcare services at one of the state's 17 federally qualified or rural healthcare centers (FQHC). However, in addition to sliding scale fees charged by an FQHC, low-income uninsured immigrants scramble to pay for prescriptions and are virtually foreclosed from costly life-saving specialty care such as chemotherapy or radiation.

This appropriation is a step forward towards providing healthcare for Hawaii's neediest and least protected residents.

The pandemic taught us that public health concerns such as deadly viruses affect us all, regardless of immigration status. As an organization that witnesses first-hand the impact that healthcare access can have on our clients, we believe that the passage of SB842 is a step towards ensuring health and wellness for everyone in our state.

Low-income immigrant communities were disproportionately impacted by the lasting effects of the Covid19 pandemic. Many experienced job losses, lower rates of healthcare coverage, less access to unemployment insurance and other public benefits. Passage of SB842 is necessary to ensure that more of Hawai'i's immigrants have access to essential healthcare.

Chair San Buenaventura, Vice Chair Aquino, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> Senate Bill No. 0842, RELATING TO HEALTH CARE FOR IMMIGRANTS.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

The bill, as received by your Committee, would appropriate \$1,000,000 in general funds for fiscal year 2023-2024, and \$1,000,000 for fiscal year 2024-2025, for the purchase of health care services for low-income uninsured immigrants who are not eligible to receive coverage under Medicaid, the Children's Health Care Program, or health insurance exchanges establish pursuant to Part II of the Patient Protection and Affordable Care Act. The bill would take effect on July 1, 2022.

According to the American Immigration Council, nearly one in five Hawaii residents is an immigrant, while one in seven residents is a native-born U.S. citizen with at least one immigrant parent. The Kaiser Family Foundation found that the uninsured rate for Native Hawaiian and Other Pacific Islanders (NHOPI) (13%) was significantly higher than for Asian (7%), and White (8%) populations. They further found that NHOPI were less likely to have private health care coverage and more likely to have Medicaid coverage with half (50%) of NHOPI children covered by Medicaid or the Children's Health Insurance Program. These findings were substantiated in published by the New American Economy in May 2021, which reported that despite making up 18 percent of Hawaii's population, immigrants account for nearly 31 percent of all those without any form of health insurance coverage, making them nearly twice as likely to not have any form of health insurance as their U.S.-born counterparts. In light of this, it is imperative that the State take steps to help these people. When they get sick, they will still utilize our emergency rooms and health care facilities resulting in indigent costs that will impact health care providers' ability to meet the needs of the entire population. These costs will either be borne by consumers in the form of higher premiums, the need for more appropriations for public insurance, but the costs will be much higher.

## Because of this, we SUPPORT this measure and urge this Committee's favorable consideration.

The Hawai'i Coalition for Immigrant Rights is in **full support of SB842**, which appropriates funds for the Department of Human Services to purchase health care services for certain low-income, uninsured immigrants.

Access to quality healthcare is a fundamental right that should not be denied to anyone, regardless of their immigration status. SB842 is essential legislation aimed at addressing the persistent challenges faced by low-income immigrants in accessing affordable health care. Denial of access to health care creates a cycle of disadvantage, leading to poorer health outcomes and greater economic hardships for our immigrant families. They contribute so much to our State and Federal government, yet are unable to access the health care they need. As we witnessed during the COVID-19 pandemic, all of our community's health is bound up together. If we allow some populations to go without services or care, it will eventually impact the collective health of the whole state.

There are approximately 11,000 individuals who may be impacted by this bill. Hawai'i has made significant strides in reducing our uninsured population but there remains a few who are unable to access MedQUEST or the healthcare connector. This money is an investment in preventative care that will save the state dollars that would otherwise be spent in the much more costly Emergency Room. We cannot stop folks from all injury or illness- but getting them care as soon as it is needed is cheaper than more extensive measures later.

SB842 seeks an appropriation of one million dollars over two years for federally qualified health centers (FQHC) to provide in-serve and out of service care for immigrants who are eligible for health care insurance through the Affordable Care Act or Medicaid. This measure will help FQHC to offset their costs, and importantly, provide out-service care where the FQHC does not have the ability to provide a service; this includes services such as Chemo, radiation, etc.

Thank you for the opportunity to <u>SUPPORT</u> SB 842 – RELATING TO HEALTHCARE FOR IMMIGRANTS which appropriates funds for the Department of Human Services to purchase health care services for certain low-income, uninsured immigrants.

The American Cancer Society Cancer Action Network (ACS CAN), the nonprofit, non-partisan advocacy affiliate of the American Cancer Society advocates for public policies that reduce death and suffering from cancer. ACS CAN works with federal, state, and local government bodies to support evidence-based policy and legislative solutions designed to eliminate cancer as a major health problem.

The Affordable Care Act (ACA) expanded health insurance coverage to millions of Americans. However, despite these coverage gains, twelve years after the law was enacted approximately 27 million people in the United States remain uninsured.<sup>1</sup> Data shows that noncitizens are more likely to be uninsured. In 2020, 26% of lawfully present individuals and 42% of undocumented immigrants were uninsured, compared to only 8 percent of U.S. citizens.<sup>11</sup>

The American Cancer Society (ACS) and its advocacy affiliate, the American Cancer Society Cancer Action Network (ACS CAN), believe that everyone should have a fair and just opportunity to prevent, detect, treat, and survive cancer. Cancer impacts everyone and key to eliminating disparities and ensuring health equity is to guarantee that all individuals have access to affordable coverage. Access to care for those who are undocumented not only ensures that serious diseases like cancer can be detected and treated earlier but also often means better patient outcomes and less costs to the individual and the system.

This position is an extension of ACS CAN's existing work to advocate for access to affordable, comprehensive coverage to better prevent, treat and survive cancer regardless of citizenship status thereby ending cancer as we know it for everyone.

Aloha Chair San Buenaventura, Vice Chair Aquino, Members of the Senate Committee on Health & Human Services,

The Hawai'i State Youth Commission (HiYC) was first created through Act 106 in 2018, "to advise the governor and legislature on the effects of legislative policies, needs, assessments, priorities, programs, and budgets concerning the youth of the State." HiYC's Public Health legislative committee is in **Support w/ Comments** of **SB842**, Relating to Health Care for Immigrants.

We <u>strongly support</u> the intent of this measure to put critical funding toward meeting the healthcare needs of Hawai'i's youth and their families, who are part of the approximately 41,426-45,000¹ undocumented members of our immigrant community (4.5% of our workforce as of 2016²), and are working in low-wage, precarious jobs without healthcare benefits. As the bill language rightfully points out, community organizations and nonprofits do their best to meet the healthcare needs of undocumented families when they can, but it isn't enough for longer term illnesses and medical needs, such as pregnancy, mental health treatment, anything that requires surgical operations and aftercare, etc.
