## On the following measure: S.B. 845, RELATING TO ACUPUNCTURE

Chair San Buenaventura and Members of the Committee:

My name is Risé Doi, and I am the Executive Officer of the Board of Acupuncture (Board). The Board supports this bill.

The purposes of this bill are to (1) make comprehensive updates to Hawaii Revised Statutes (HRS) chapter 436E, regarding acupuncture practitioners, to reflect modernized scopes of practice, titles, and licensing and renewal requirements; (2) require thirty hours of continuing education (CE) per licensing biennium beginning July 1, 2025; and (3) allow the Board of Acupuncture to issue licenses by reciprocity.

The Board supports this measure because it modernizes HRS chapter 436E to align with the current professional standards for licensed acupuncturists.

Given the huge undertaking of this measure and, thus, in consultation with the Department of Commerce and Consumer Affairs' Professional and Vocational Licensing Division (Division), the following is respectfully requested to ensure proper implementation:

- 1. General fund appropriation to allow the Division:
  - a. To make the appropriate updates to its internal database. In consultation with the Division and its vendor, the required updates may take upwards of 500 support hours. The updates would require the creation new license types and its corresponding requirements; and update the renewal requirements to include the newly added CE requirement. These hours would be added onto the already extensive daily work of the Division's developer, program analyst, and others outside of the Division. Note that these updates would require additional support and maintenance outside of the budget request being made through Department of Commerce and

Consumer Affairs' request. The sum of \$75,000 or so much thereof may be necessary to fund this request.

2. Minimally, a delayed effective date of at least two (2) years to ensure that this measure implemented correctly, updates to the Division's database are made and tested, and applications are created.

My name is Dr. Wai Hoa Low, President and Chief Executive Officer (CEO), testifying on behalf of the Institute of Clinical Acupuncture and Oriental Medicine (ICAOM).

We are writing in Support of SB 845 that would make comprehensive updates to chapter 436E, Hawaii Revised Statutes, regarding acupuncture practitioners to reflect modernized scopes of practice, titles, and licensing and renewal requirements, including continuing education per licensing biennium.

Hawaii's consumers and students will appreciate the benefits and protection from this bill that revitalizes HRS 436E which has not been updated for over 20 years. Though we support the measure, we would like to take this opportunity to express our reservations concerning HRS 436-E Section 2 "§436E-C Reciprocity". We feel that this new section is a redundancy since all applicants must be treated as initial licensees as stated in Section 2 HRS 436E-A of the bill. In addition, the Hawaii State Board of Acupuncture already has Rules and Regulations in place concerning new applicants. We therefore recommend the following:

#### **RECOMMENDATION:**

ICAOM recommends to the Senate Committee on Health and Human Services to delete Section 2, HRS 436E-C Reciprocity.

[\frac{\pmax}{\pmax}436E \cong \text{Reciprocity.} (a) The board may issue a license by reciprocity if the applicant:

- (1) Files an application and pays fees as prescribed by the board;
- (2) Holds a current, unencumbered, active license pursuant to the laws of any state or territory of the United States with qualifications for licensure that are equal to or exceed those of the State, as specified in section 436E-A; and
- (3) Holds a current certification with the National Certification Commission for Acupuncture and Oriental Medicine, or its successor entity.
- (b) For applicants who graduated before September 1, 2000, the board may issue a license by reciprocity if the applicant:
- (1) Files an application and pays fees as prescribed by the board:
- (2) Holds a current, unencumbered, active license from any state or territory of the United States; and
- (3) Holds a current certification with the National Certification Commission for Acupuncture and Oriental Medicine, or its successor entity."

I am writing to you on behalf of Acuplan Hawaii, an organization of over 50 acupuncturists in Hawaii that seek to promote the professional status of acupuncture by connecting with medical professionals and increasing availability of acupuncture through insurance coverage. We contract as exclusive providers for University Health Alliance (UHA) and Hawaii Medical Assurance Association (HMAA) and Hawaii-Western Management Group (HWMG). **We are in strong support of SB845.** 

HMSA, Kaiser, The Veteran's Administration and many medicare supplement plans all cover acupuncture in some or all or their plans. These insurance companies can determine reimbursement based on what is allowed under our scope of practice. Right now, our scope leaves a lot of room for confusion which results in rejected claims. As evidence for acupuncture grows, coverage will grow and clear language in the scope of practice will be crucial. Compensation for essential services such as evaluations and adequate treatment time must be appropriate and recognized.

Dear Honorable Chair Senator San Buenaventura, Honorable Vice Chair Senator Henry Aquino, and Honorable Committee Members,

We, the Board of Directors of the Hawaii Acupuncture Medicine Association, represent our members and colleagues, as well as our patients and citizens of Hawaii in testifying today in support of measure SB845.

Regulated medical professions require safety of the public and access to care to be of primary importance. Acupuncture has been one of the fastest growing segments in American healthcare due to increased access for the public via medical insurance, Medicare inclusion, as well as its demand as the primary alternative to opioid prescriptions and other medical conditions. The increases in scientific data verified acupuncture medicine's efficacy in a range of health conditions. Simultaneously with the increasing demand and evidence in efficacy, the education, certification, and continuing education standards have improved nationally. Since changes over the last twenty years have not been made to the Hawaii acupuncture medicine scope of practice, the statute must be updated now to represent the current state.

We want our profession to be able to serve the citizens in Hawaii safely and knowledgably. We want to integrate in hospitals, rehabilitation centers, nursing homes, hospice, and other care settings to provide the highest standard of care. As we integrate acupuncture medicine with allopathic medicine and within the health care delivery system in Hawaii, we wat patients to be assured of evidence-based, evidence-informed medicine that is understandable and current.

To provide Hawaii's current and future medical and social needs, statutory updates must accurately reflect the stands of practice for our industry.

We respectfully request for clarification the following language in section 436E -9 (b) to read:

Beginning with the renewal for the licensing biennium commencing July 1, 2025, and every biennial renewal thereafter, all licensees shall be in compliance with continuing education requirements, as approved by the board, by obtaining an equal or a greater number of hours than the minimum required under a national standard, which shall include at least two credit hours of ethics and at least two credit hours of safety, as determined by rule. The board shall adopt rules relating to the requirements and standards that continuing education programs shall meet to obtain recognition and approval from the board.

This recommendation, along with the following, reflect what Hawaii Acupuncture Medicine Association sees as necessary standards of practice for our industry in the State of Hawaii:

- Legacy exemptions are defined
- Expand and clarify upon the concepts of the two existing license designations: LAc, DAc, in line with national trends.
- Simplify and rename application for licensure to eliminate outdated requirements while implementing current national stands for education, national board certification, and continuing education.
- New definitions aligned with current medical terminology, education, training, and skills practiced by acupuncturists, while maintaining and preserving the traditions of this complete medical system

 Reciprocity inclusive of applicants who have maintained licensure and certifications in other jurisdictions wanting to be licensed in the state of Hawaii.

My Name is Marilyn Allen, vice-president of America Acupuncture Council (AAC), editor of Acupuncture Today, US Representative for World Health Organization (WHO) on Traditional Medicine, Professor of Ethics, Law, and Regulations and Professional development testifying on behalf of the (AAC).

As of January 2020, the WHO has released its updated version of the international classification of disease -11 and the new classification of traditional medicine/acupuncture diagnostic codes for worldwide use. When ICD-11 is adopted in the United States Acupuncture will be able to be integrated into the healthcare system. This needs to be reflected in the Hawaii practice act

- 1. Traditional medicine codes will provide a worldwide foundation for the practice of acupuncture.
- 2. The WHO general assembly accepted these codes unanimously.
- 3. The use of these codes will create and collect data to be used in research to further prove the efficacy of acupuncture.
- 4. Double coding by practitioners will help to begin to integrate both eastern and western ICD codes. Double coding means the use of a western code, a traditional medicine disorder and the pattern differentiation process.

Currently Medicare is conducting a nationwide research study on low back pain for seniors with acupuncturist's delivering treatment. It is being in conducted in coordination with medical doctors because acupuncturists are not included in Medicare yet. A Medicare bill, HR 4803, has been introduced into the Congress of the United States. This bill simply conveys the message to have the word acupuncturist added into the Social Security act.

The bureau of labor and statistics has collected data for the first time, through the census collection to include Acupuncturists an independent occupation in the United States. The veteran's administration now includes Acupuncture as a part of their healthcare choices for veterans.

We fully support the acupuncture practice act to be updated in your current practice standards for license acupuncturist. However, I have reservations concerning 436-E New Section 2 "436E-C Reciprocity". I recommend to the Senate Committee on Health and Human Services to **delete Section 2. 436E-C Reciprocity**.

Traditional medicine/Acupuncture must be given as choices and healthcare for the citizens of the great state of Hawaii.

Dear Senator San Buenaventura and HHS Committee Members,

We are members of the Legislative Committee of the American Academy of Medical Acupuncture (AAMA), an organization of medical and osteopathic physicians (MDs and DOs) who have incorporated acupuncture into our medical practices. We are writing to share information regarding **SB845** which makes updates to Chapter 436E of the Hawaii Revised Statutes regulating acupuncture practitioners.

First, it is of continuing concern that HRS sec. 436E-3.5 prohibits physicians and osteopaths from performing acupuncture unless they are also licensed acupuncturists (LAcs). There is in Hawaii, as in the United States in general, a shortage of health care services, including acupuncture. The effect of sec. 436E-3.5 is to exacerbate this shortage by prohibiting medical acupuncture services (i.e., acupuncture treatments provided by physicians) to the people of Hawaii. The basis for this legislative position is 30 years old and no longer supported by the facts surrounding the contemporary practice of medical acupuncture. The medical boards in 48 states and the District of Columbia accept acupuncture as falling within the physician's scope of practice or with the qualification of completion of an approved training program. Only Hawaii and New Mexico insist upon excluding physicians from practicing acupuncture.

Section 5 of SB845 states that only licensed acupuncturists and doctors of acupuncture may engage in "acupuncture," "acupuncture medicine," and "advanced acupuncture medicine." The exclusion of all other health care providers from the described scope of practice is problematic and runs contrary to public policy which favors maximal accessibility of health care services for the public. The American College of Physicians recommends acupuncture as a nonpharmacologic treatment for low back pain. The Centers for Medicare & Medicaid Services covers acupuncture for chronic low back pain. And in the new CDC guidelines for

prescribing opioids, Recommendation 2 states that clinicians should maximize nonpharmacologic approaches to help manage chronic pain including acupuncture for fibromyalgia and low back and neck pain.<sup>3</sup> Physicians on the mainland are able to provide these treatments for their patients, including those on Medicare, while physicians in Hawaii are forbidden to do so.

The legislative history of sec. 463E-3.5 is instructive. "In 1985, the Legislature enacted HRS section 436E-4, which exempted physicians from the jurisdiction of the [Board of Acupuncture]." *HI Att. Gen. Op. No. 03-05 (2003), p. 2.* In 1989 "the Legislature enacted HRS section 436E-3.5, which continued to allow physicians to be certified by their respective boards... to practice acupuncture... pursuant to rules adopted jointly by the [Boards of Acupuncture, Medicine, and Osteopathy]." *Id.* The Boards of Medicine and Osteopathy were instructed to collaborate with the Board of Acupuncture to develop rules for certification of physicians, but the "consultation among the three boards" did not materialize. As a result, in 1993, the Legislature withdrew the physicians' exemption. *Id.*, p. 3.

American physicians have accumulated a great deal of experience with medical acupuncture over the past three decades. There is now no reason that the Hawaii licensing boards cannot formulate a simple and workable set of rules to enable the return of medical acupuncture practice to physicians after 30 years of prohibition.

We propose that in SB845 the Legislature strike the language of sec. 436E-3.5 and replace it with the language of the 1989 statute, to wit:

**Certification.** Persons licensed under Chapters 453 and 460 who desire to practice acupuncture may, in lieu of licensure under this chapter, be certified by their respective boards as qualified to practice acupuncture in accordance with rules to be adopted jointly by the Board of Acupuncture and the Medical Board in accordance with Chapter 436B. The rules shall contain the certification procedure, criteria for certification, and the power of the respective boards to remove the certification for cause. The Hawaii Boards of Medicine and Acupuncture shall jointly adopt such rules no later than December 31, 2024.

The two professional licensing boards are already empowered to monitor scope of practice, form fact-finding committees to make recommendations, and adopt new rules. *HRS sec. 436B-7*. Such an effort by the two licensing boards will serve to improve the provision of health care to Hawaii residents and to promote mutual understanding and cooperation among the health care professions.

Second, the trend in health care toward the increasing use of evidence-based medicine, which is referenced in SB845, is thwarted by the prohibition of medical acupuncture. The definition of "acupuncture medicine" in Section 4 of SB845 is "the evidence-based medicine rooted in traditional theories and practices, integrated with modern biomedical theories and practices." It is important to note that

there are other schools of acupuncture in addition to that taught in Traditional Chinese Medicine. One of these is Neuroanatomical Acupuncture based upon the principles of neuroanatomy, neurophysiology, and pathophysiology.<sup>5</sup> For further information, see Exploring the Science of Acupuncture, C. Medical acupuncture courses for North American physicians include techniques which are based upon scientific research and form the foundation for evidence-based medical practice. As such, medical acupuncture theory and training extend beyond the narrower confines of traditional Asian medicine and acupuncture. Physician acupuncturists, with our years of medical education and training, are certainly competent to deliver this safe and effective therapy. If it would be helpful, we can provide you with additional information on how acupuncture works based on the scientific research.

It is both an honor and a challenge to present this opposition testimony to the legislature. My position on SB845 regarding the future status of acupuncture in Hawaii comes from a deeply dedicated medical experience spanning 45+ years in Taiwan, Italy, China and the US. As a board certified physician, a licensed acupuncturist and a certified medical acupuncturist, I can address personally and professionally the unique standards of education and clinical requirements of both eastern and western medical systems. I am deeply concerned this bill fails to do justice to acupuncture's respected position in the Hawaiian healthcare system and request the legislature table the bill until such time as these concerns are discussed, reviewed and revised by those directly involved with the medical community.

I am a member of the American Medical Association, Hawaii Medical Association, American Academy of Medical Acupuncture, Hawaii Acupuncture Medicine Association, and AcuPlan Hawaii. In addition, I graduated from the Institute of Clinical Acupuncture and Oriental Medicine and am an Associate Clinical Professor with John A. Burns School of Medicine, Univ. of HI. I hold great respect for all of these organizations and understand the valid concerns on both sides of the aisle. While there is clear merit in advancing the status of acupuncture in Hawaii, I am compelled to submit this opposition testimony based on several concerns regarding the clarity of the bill's concepts and semantics, including, but not limited to:

- ➤ **Broad-based use of terminology** related directly to allopathic medicine, yet, loosely translated to acupuncture without definitive clarification
- > Non-delineation of specific diagnostics, biomedical training, advanced acupuncture techniques, etc...
- > Lack of transparency of terms for public health and dilution of integrity of both the systems of TCM (Traditional Chinese Medicine) and western medical practices
- > Violations of existing federal and state laws and statutes defining the practice of medicine

Acupuncture is a branch of TCM, not the entire medical system. To be recognized as an official doctor of TCM requires extensive training in a multi-faceted educational program. Training in allopathic medicine is equally an intense educational investment of many years with diverse advanced curricula. To compare the training of these two systems is inequitable. One cannot be defined in terms of the other. However, to redefine acupuncture as "acupuncture medicine" or "advanced acupuncture medicine" in a western medical system would require redefining medicine in the US on both federal and state levels. This means, the legislature would be required to rewrite the existing statutes on medicine in Hawaii before ruling on this bill which violates several areas of accepted statutory rulings.

Hawaii Revised Statute: §453-2 License required; exceptions. (a) Except as otherwise provided by law, no person shall practice medicine or surgery in the State, either gratuitously or for pay, or offer to practice medicine or surgery in the State, or advertise or announce one's self, either publicly or privately, as prepared or qualified to practice medicine or surgery in the State, or append the letters "Dr.", "M.D.", or "D.O." to one's name with the intent to imply that the person is a practitioner of medicine or surgery, without having a valid unrevoked license or a limited and temporary license obtained from the board of medical examiners.

Acupuncture, TCM, Oriental Medicine or Eastern Medicine are not named in the Hawaii Revised Statute, nor do they appear in the federal statutes on medicine. This bill poses both medical and legal challenges that are unfair to present to the legislature without addressing their ramifications and finding a reasonable course of action to resolve them.

The legendary symbol in TCM of the Yin/Yang represents the sun and the moon within the same sky; the night and the day, a balanced duality in nature. They remain infinitely connected but unique unto themselves. The systems of TCM and allopathy remain distinctly different in their ideologies and technologies, including the more personalized approach to the individual in TCM as compared to the disease/treatment approach favored in allopathy. They are connected in a common quest for ultimate health and healing, yet, as different as night and day. They have much to learn from each other.

In November, 2022, in an effort to generate a collective voice to review and revise this bill before presentation, I contacted several key members of the acupuncture and medical community and suggested a series of meetings to bring everyone to the same table to discuss options regarding the bill. We had an introductory meeting, but no effective discussion of the bill. Similarly to 1989, when the legislature instructed the boards of Acupuncture, Medical and Osteopathy to come together and decide on the rulings of how physicians could practice acupuncture in Hawaii, those meetings did not come to fruition.

We stand at a pivotal cross-roads of elevating and integrating the principles and practices of acupuncture in alliance with western medicine. Each must preserve their integrity and autonomy while furthering the future of healthcare in Hawaii by respecting their individual domains and exchanging vital knowledge and applications. I am actively engaged in the proposal of a credentialed TCM program being offered within a conventional medical school curriculum. We have an exciting journey ahead. This bill, as it stands, may stand in the way of that progress.

It is often said that much is lost in translation. Being fluent in three languages, including Chinese, I know how intricate these translations can be. Translating TCM and acupuncture into western medical terms would be a travesty to both of these exemplary systems. I urge the legislators to consider that it is time to table this bill and instruct those directly involved on both sides of the aisle in acupuncture and western medicine to come to the collective table. This conference of authorizes is where the wisdom of TCM and acupuncture can join forces with 21st century medical technology, creating a truly renaissance healthcare collaboration for Hawaii.

My name is Jeffrey Tice, and am a Doctor of Acupuncture in the state of Hawaii (#732). My practice is in Wailuku, Maui where I co-own Longevity Health Center with my wife, Joyce Tamori. I am also vice president of Hawaii Acupuncture Medicine Association.

I fully support SB 845 to improve the language in the scope of practice for acupuncture medicine in the State of Hawaii and to elevate the licensure requirements for future generations of Licensed Acupuncturists to serve the people safely and effectively.

Acupuncture and associated modalities historically termed Traditional Chinese Medicine or Oriental medicine, is the oldest continuous, documented medicine on the planet, yet also one of the fastest growing today. It has a long history in Asia (4000+ years) yet is relatively new to the rest of the world (100 years). Hawaii was an early adopter of licensing acupuncture in the United States, predating formal accredited schools and national board certifications. Much has changed in the profession over the last four decades and especially in the last twenty plus years since the current statute, 436e was updated.

Acupuncturists licensed to practice in Hawaii practice under two titles, Licensed Acupuncturist (LAc) and Doctor of Acupuncture (DAc). Although two licenses are uncommon in the United States, the current trend is towards a two-tiered profession with Masters level education as the entry point, often specializing in acupuncture while the accredited Doctoral level for Doctors of Acupuncture Medicine to use a more complete practice of the medicine formerly known as Traditional Chinese Medicine (TCM) or Oriental Medicine (OM). Each of these education and scope of practice levels, LAc and DAc, are justified with education and national certifications in SB 845.



The complete practice of TCM/OM includes whole patient care including musculoskeletal conditions as well as mental and internal medical health. SB 845 updates historical diagnostic and treatment languages translated from terms such as Zang-Fu, TaiChi and Qigong into more appropriate and modern English language terms such as internal medicine, exercise and meditation, respectively. The updated nomenclature for Acupuncture Medicine preserves this historically significant practice of medicine and helps it smoothly integrate into the modern healthcare system in Hawaii.

This measure updates chapter 436E Hawai'i Revised Statutes, regarding acupuncture practitioners, to reflect modernized scopes of practice, titles, licensing, and renewal requirements.

The HMA appreciates the intent of this bill to update the existing state laws and would like to call attention to issues of terminology, training, and consumer protection and safety raised by the proposed comprehensive update, as follows:

- 1. "Doctor": While individuals in diverse fields of intellectual education may hold the title of "doctor" by fulfilling education, training, and certification requirements specific to their fields of study, only Doctors of Medicine (MD) and Doctors of Osteopathic Medicine (DO) are recognized as physicians. For instance, a PhD Botanist is not recognized as a physician.
  - It is important that the public be able to distinguish MDs and DOs from the many other health care providers who are also addressed as doctors.
- 2. Licensure: Hawaii physicians are not exempt from acupuncture licensing laws in Hawaii. Given the evolution of the modern physician's scope of practice, an alternate pathway to licensure may be considered.

- 1. The eight (8) new definitions added in section 4 of 436E are helpful for clarity. We recommend editing sections 5 and beyond for consistency replacing all "doctor" language with "practitioner" and/or add "(D.Ac) behind all references to "doctor".
- 2. Add language addressing a potential pathway for physician licensure in acupuncture, in alignment with present CMS guidelines.

Eastern and Western medicinal techniques have an important intersection with acupuncture that both heals and furthers the health and well-being of our citizens. HMA appreciates these efforts to update laws with clarifying language for the regulation and control of acupuncture practice and licensing. As acupuncture continues to grow, HMA looks forward to further collaboration with acupuncture practitioners in Hawaii.

I am an active member of the medical community of Hawaii for over 19 years, in addition to being a member of the American Medical Association (AMA), Hawaii Medical Association (HMA), American Academy of Medical Acupuncture (AAMA), Adjunct Professor with John A. Burns School of Medicine (Univ. of HI) and a retired teacher of Biomedicine at the former World Medicine Institute, school of acupuncture. I submit the following opposition commentary in order to clarify my personal and professional responses to numerous issues of context and semantics in the proposed bill and offer insights that may be of value for the revision of a more strategically accurate document to benefit the practice of acupuncture and transparency in healthcare for Hawaiians.

1). Regarding acupuncture medicine is an evidence-based medicine stated on page 4 line 18 through page 5 line 8:

Page 4 18 "[-fl436E-1[)-] Declaration of necessity for regulation and

19 control. The legislature hereby finds and declares that

**20** acupuncture medicine is an evidence—based medicine rooted in

**21** <u>traditional and modern modalities and that</u> the practice of

Page 5 **1** acupuncture [is a theory and method for] medicine includes

4 and as such affects the patient, therefore requiring regulation

**COMMENT:** Replace "acupuncture is evidence-based medicine." with "acupuncture has increasing efficacy evidence for certain diseases." The legislature should **not** declare a controversial assertion "acupuncture is evidence-based" because the legislature is **not** a finder of scientific fact and promoting something as "evidence-based," while it is still under investigation and not strongly evidence-based, would involve legislature unintentionally perpetrating a fraud on the general public and contrary to consumer protection.

In addition, page 13 line 5 - 6 it is stated that one can lose a license if:

**5(2)** "The use of false, fraudulent, or deceptive advertising

**6** and making untruthful and improbable statements;

Calling acupuncture "evidence-based" will violate this section against false, fraudulent, or deceptive advertising.

Attached are articles pointing to the controversy. Many research papers found in the Cochrane review (A reputed reference standard of qualified clinical and medical studies) pointed to lack of evidence for various TCM (Traditional Chinese Medicine), including the practice of acupuncture modalities <a href="https://www.cochranelibrary.com/search">https://www.cochranelibrary.com/search</a> (review 79 research articles under search topics of acupuncture and pain). Although there are numerous published papers in the literature with support evidence, many of those studies are of poor quality due to low patient number, biased selection and reporting, and lack of adequate control studies or insufficient study design. In many Cochrane reviews, it is stated that it is impossible to conclude that TCM is definitely an evidence-based medicine. Please see further articles in attached Exhibit A.

2). According to the amended Hawaii acupuncture law (section 436E-2):

**COMMENT:** This section contradicts the definition of practice of medicine because acupuncturists claim that they are treating **diseases** which is the practice of medicine as defined by Hawaii statue of practice medicine as a physician or an osteopathic physician. **§453-1 Practice of medicine defined.** For the purposes of this chapter, the practice of medicine by a physician or an osteopathic physician includes the use of drugs and medicines; surgery; manual medicine; water; electricity; hypnotism; telehealth; the interpretation of tests, including primary diagnosis of pathology specimens, medical imaging, or any physical; osteopathic medicine; any means, method, or agent, either tangible or intangible, to diagnose, treat, prescribe for, palliate, or correct disease, or prevent any human disease, condition, ailment, pain, injury, deformity, illness, infirmity, defect, physical or mental condition in the human subject.

Even though an acupuncturist may attend 4 years in an accredited acupuncture school, they lack adequate training in the Biomedical model of disease and therefore inadequately are trained to diagnose diseases / illnesses as defined in western medicine. The majority of times spent in acupuncture school are devoted to learning diagnosis and treating TCM syndromes and patterns, with minimum time dedicated to biomedical theory, diagnosis and treatment (for example: in Hawaii accredited acupuncture school ICAOM's Master Degree Program, Biomedicine: 615 hours; Grand Total: 3240 hours for the entire program, in which Biomedicine represents only 19% of the total hours required).

- 3). On page 6, line 6-8 and 14-19: regarding "Acupuncture medicine doctor".
  - **6** "Acupuncture medicine doctor" means an acupuncture
  - 7 practitioner engaged in the practice of advanced acupuncture
  - 8 *medicine*.

**COMMENT:** This statement goes against the common understanding of what a physician is and what a physician is competent to treat, which is a grave misrepresentation to the general public. An acupuncturist is not entitled to refer to themselves as a "physician" or "medical doctor" if they do not possess an MD or DO license:

These physicians are trained in both modern medicine and acupuncture, giving them the ability to examine a problem, make a diagnosis, and offer treatment options from both modern medical and acupuncture perspectives. That means their patients get the best of both worlds: proven, ancient healing techniques and cutting-edge, modern medicine. See Exhibit B for detailed definition of physician.

**4).** On page 6 line 20 through page 7 line 5:

- Page 6 20 "Practice of acupuncture medicine" means the practice of
  - **21** acupuncture with adjunctive therapies, including but not limited
- Page 7 1 to manual, mechanical, electrical, light, sounds
  - **2** electromagnetic, thermal therapy, herbal and nutraceutical
  - **3** *medicines, lifestyle and nutritional counseling, movement, and*
  - 4 other traditional and modern techniques as further determined by
  - **5** *rule*.

**COMMENT:** Definition of the "practice of acupuncture medicine" is so broadly described that no one else can use any of the enumerated activities without committing a misdemeanor of practicing acupuncture without a license. This should change to "acupuncturists use both acupuncture and other commonly used allied healthcare modalities. Nothing in this law precludes other practitioners or lay persons from using these allied healthcare modalities."

Acupuncturists cannot legally lay claim to or monopolize standard therapies used by other healthcare professionals thereby causing unintended consequences of illegalities and violations for other professionals to use such therapies in the execution of their own licensed professions. Examples include:

- a. Physical medicine and rehab doctors (physiatrists) would be prohibited using thermal therapy, i.e. they cannot put hot or cold pads on the patients.
- b. Physical therapists and pain medicine doctors would be prohibited from using electrical stimulation, including tens unit.
- c. Cardiac rehabilitation doctors, endocrinologists, and neurologists could not engage in lifestyle and nutritional counseling or movement therapy.
- d. Reputed cardiologist Dr. Dean Ornish's lifestyle medicine (cardiac rehab program) could not offer the program, without risk of being accused of practicing acupuncture without a license.
- e. No first responders, including ER doctors, could use cardiac defibrillators because it is electrical stimulation.
- f. Endocrinologists could not recommend dietary programs for diabetic patients.
- g. Neurologists could not use nerve conduction studies with electrical stimulation.
- h. Dermatologists could not perform photocoagulation therapy or laser treatment of skin lesions because it is "light therapy".

- General surgeons could not use laser to ablate tumors because it is "light therapy".
- j. Ophthalmologists cannot use laser therapy for retinal diseases or Lasix because those are forms of light therapy.... Just to name a few.....
- 5). Furthermore, regarding instruction phases of acupuncture: page 13 line 19 through pg 14 line 6,

Page 13 **19 (b)** Any person who practices, treats, or **instructs** in any

20 phase of acupuncture medicine, or uses any word or title to

**21** induce the belief that the person is engaged in the practice of

Page 14 1 <u>any type of acupuncture medicine, without a license or permit</u>

**2** issued by the board, shall be guilty of a misdemeanor and

4 Violation. The board may also seek all legal and equitable

5 <u>remedies available to it for the enforcement of the provisions</u>

**6** of this chapter, including injunctive relief.'

**COMMENT:** First of all, line 20, nowhere in this law is phase of acupuncture medicine defined, therefore it is impossible what is prohibited as far as practice to treat and instruct. Specifically, regarding "instructing acupuncture": This context means that no one can teach in medical school, nursing school, massage school, acupuncture school and other facilities without an acupuncture license if they are engaged in teaching the following subjects listed in page 6 line 20 through page 7 line 5 regarding "Practice of acupuncture medicine including but not limited to manual, mechanical, electrical, light, sound, electromagnetic, thermal therapy, herbal and nutraceutical medicines, lifestyle and nutritional counseling, movement, and other traditional and modern techniques as further determined by rule."

A specific example would involve a neurologist prohibited from using needles approved by the FDA to perform a nerve conducting study nor he/she can teach about it without an acupuncture license.

**6).** Practice of acupuncture medicine: Page 5 line 17 through page 6 line 2, regarding acupuncture practice:

Page 5 17 "Acupuncture" means the integrative examination,

18 evaluation, diagnosis, prevention, and treatment of a physical,

**19** mental, or emotional disease in the patient by stimulating

**20** tissue by puncturing with a needle approved by the United States

Page 6 1 <u>Food and Drug Administration to various depths or utilizing</u>

**2** other means to achieve a response.

**COMMENT**: This describes the practice of allopathic medicine, for example, a neurologist uses FDA approved needles to stimulate tissues to elicit a response during nerve conducting examinations under the authority of the board of medicine. They do not require an acupuncture license. This definition of practice of acupuncture medicine is encroaching on the definition of allopathic medicine, therefore practicing allopathic medicine should not require an acupuncture license.

7). Regarding page 7 line 2 regarding "herbal and nutraceutical medicines":

"Practice of acupuncture medicine with adjunctive therapies includes but not limited to ...Herbal and nutraceutical medicine..."

**COMMENT:** Since herbal medicine is not a controlled profession and does not require a license, there is conflict according to this section stipulating that only licensed acupuncturists can practice herbal

medicine. This indicates that acupuncturists are attempting to monopolize unlicensed and unregulated herbal usages. See **Exhibit C** for detail.

Regarding nutraceutical medicine as part of practicing acupuncture and requiring a license to do so, refer to: **The Dietary Supplement Health and Education Act (DSHEA)** which amended the Federal Food, Drug, and Cosmetic Act (FD&C Act) to create a new regulatory framework for dietary supplements. Under DSHEA, FDA does not have the authority to approve dietary supplements before they are marketed. In addition, the use and recommendation of supplements is not a regulated activity, and do not need any license to do so. This low is trying to monopolize recommendation of supplements.

**8.)** Regarding "physicians and osteopaths are not exempt", requiring physicians to have an acupuncture license to practice acupuncture medicine.

Page 8 line 17, and page 13 lines 19 through page 14 lines 6:

- 17 "436E-3.5 Physicians and osteopaths not exempt. Persons
- 18 licensed under chapter 453 who desire to <u>engage in the</u> practice
- **19** of acupuncture medicine shall be subject to licensing under this
- 20 chapter."

**COMMENT:** MDs and DOs should have an alternate pathway for licensing to practice acupuncture that does not include the same pathway for non-physician acupuncturists because they have an extensive educational background involving specialized understanding of biomedicine, including, but not limited to, diagnosis and multimodality treatments.

Medical doctors and osteopaths should be licensed through their appropriate boards, however, if the acupuncture board wants to credential physicians, then they should apply commensurate rules in all other states for training and credentialing physician acupuncture practice, similar to 48 other states that do not require acupuncture license to practice acupuncture.

**To the Editor:** I am writing in regard to this article and its accompanying editorial. Both advocate for the use of acupuncture in family practice and training of physicians based on weak evidence. The authors of the editorial anecdotally report they have seen skeptical physicians change their minds about acupuncture during training. Seeking to validate their beliefs, proponents of acupuncture tend to cherry-pick the weak but positive studies and ignore the negative ones. However, larger blinded studies show no significant difference in pain relief from acupuncture compared with sham acupuncture. $\frac{1-3}{2}$ 

The article states, "Traditionally, acupuncture is thought to restore the normal flow of energy (qi) in the body." This is typical of pseudoscientific jargon based on the belief in mystical, unmeasurable "vital energies" akin to the "psora" of homeopathy or the "life force energy" of chiropractic. They also state that acupuncture is safe, ignoring incidents of pneumothorax and infection. $^{4-6}$ 

Acupuncture is therefore based on weak scientific evidence; claims of ancient knowledge; unproven, invisible forces; and anecdotes, and only works when sold to the patient with reassuring words and hand-holding. What our patients are actually looking for is someone who will take the time to listen to them, establish trust, and show empathy. When we fall back on smoke and mirrors just to "do something," we betray that trust. Let's not go back to the days of bloodletting and phrenology. You can do better than this, American Family Physician.

Physicians and surgeons are medical practitioners who treat illness and injury by prescribing medication, performing diagnostic tests and <u>evaluations</u>, performing surgery, and providing other medical services a nd advice. Physicians and surgeons are highly trained and duly authorized by law to practice medicine. The education and focus of chiropractors, dentists, and optometrists differ from those of physicians and s urgeons. However, the laws relating to physicians and surgeons generally apply to these medical professi onals as well. In addition, these HEALTHCARE providers are subject to laws regulating their specific area of practice. They are prohibited by law from practicing medicine or surgery.

Statutes and regulations carefully regulate who may use the title "doctor." Use of the title or its abbrevia tion without an indication of the type of degree—D.O., M.D., etc.

is specifically forbidden in many states unless the person holds a physician's and surgeon's certificate. State statutes delineate requirements for a license to practice medicine. To obtain a license, an applicant must demonstrate requisite education and knowledge. A college degree and graduation from an accredit ed medical school typically fulfills the education requirement, and passing a state-

licensing exam demonstrates an applicant's skills. State law determines who may sit for an exam and typ ically limits the number of tries an applicant has to pass the exam. Specialists, such as cardiologists, opht halmologists, pediatricians, and neurosurgeons, must usually pass further exams beyond the initial licens ing exam.

Herbalists are not part of a regulated profession, as opposed to the proposed acupuncture medicine definition (Regarding page 7 line 2: "Practice of acupuncture medicine with adjunctive therapies incudes but not limited to ...Herbal and nutraceutical medicine..." )

Partial copy of above link: Most folks entering the herbal field want to know whether they can become a certified or licensed herbalist in the same vein that nutritionists and massage therapists can become certified and licensed. The truth is, *there is currently no certifying agency or licensing board for herbalists in the United States* and, therefore, no such adjudicated designation as an herbal certification or professional title (such as Master Herbalist or Certified Herbalist) recognized by accrediting agencies in the US.

Most herbal programs award a certificate of completion upon graduation, but this is not the same as obtaining certification from an official board. It is interesting to note that the public is generally not familiar with the subtleties of certification or licensing for herbalists in the United States. As such, herbalists who claim to be "certified" are unnecessarily misleading the public, who, for the most part, assume that there must be a certification process leading to that title. Ethics are central in an unregulated field.

**COMMENT:** If you live in the United States, you can practice herbal medicine without a license or certification, and you can legally charge for your services as a clinical herbalist.

There appears to be more work needed on this, in particular, how evidence-based practice is defined, the treatment of MD/DO's with specialized training in acupuncture and the definition of "scope of practice".
