Senate Bill 848 looks to raise the annual registration fee from \$27 up to \$100 and raise the emblem fee from .50 cents up to \$20. This means that a county could charge up to \$120 for an annual registration on a moped.

In the past, mopeds were classified as bicycles and only were charged a one time \$15 permanent registration fee. Legislation was eventually passed that required mopeds to be registered and receive annual safety checks. The current annual registration is less than \$40 a year. Which is still affordable for a typical person who buys a moped. Moped riders tend to be more budget friendly, have less disposable income, and are looking for an affordable mode of transportation. You can currently buy a new moped for \$800, so it's pretty high for the annual registration to potentially become up to \$120. I understand that the intent of the bill is to generate more revenue, but it does seem unfair considering the price and size of mopeds.

Ultimately, I hope you choose not to read SB848 because things are already expensive in Hawai'i, and tripling the annual fees makes things that much harder for the moped demographic, while delivering no additional benefits to our industry.

My name is Manabo Robert Sato and I am the general manager of Moped Doctors, a local Honolulu moped shop for 12 years .SB848 aims to increase the prices of essential moped registration and legal documents by such a large margin that it will badly hurt the cash strapped riders and owners and businesses that rely on mopeds for basic transportation and livelihood. To increase a reasonable \$27.50 to \$100 is nearly a 400 percent increase. The emblem fee going from 50 cents to \$20 is a 4000 percent increase. Increased fees to some extent as operating and material costs rise is understandable within reason but a four fold to forty fold increase is both unnecessary, excessive and quite frankly ridiculous. ESPECIALLY in light that the moped DMV at Kapalama Hale at the Dillingham Blvd dmv has cut its hours from Monday to Friday 8 hours a day to only Tuesday and Thursdays four hours a day. Moped owners and moped business owners will be paying way more yet are getting way less access and service times. This is simply unreasonable and unfair to all the people who ride mopeds in Hawaii, one of the very few affordable forms of legal personal transportation becoming way less affordable. For example, The extra \$72.50 proposed increase on moped registration is TEN tanks full of gas on a moped .We at Moped Doctors STRONGLY OPPOSE this bill and recommend it be shelved. A reasonable increase this is not. It is way too excessive. A far lesser amount if any increase at all would be better. Say 25 percent. Not 400 to 4000 percent which is what is being proposed.
