# TESTIMONY IN STRONG SUPPORT OF SB869 SD1 RELATING TO THE YOUTH COMMISSION

Aloha Chair(s) Rhoads & Dela Cruz, Vice Chair(s) Gabbard & Keith-Agaran, Members of the Senate Committee(s) on Judiciary and Ways & Means,

The Hawai'i State Youth Commission was first created through Act 106 in 2018, "to advise the governor and legislature on the effects of legislative policies, needs, assessments, priorities, programs, and budgets concerning the youth of the State." The Hawai'i State Youth Commission (HiYC) is in **Strong Support** of **SB869 SD1**, Relating to the Youth Commission.

HiYC supports amending section 352D-11 of the Hawai'i Revised Statutes to set the quorum requirement to a *majority* of the members rather than eight members in order to do business. This

is because, in the past, the HiYC has seen some difficulty maintaining the quorum needed to conduct our mission and purpose. There have been unforeseen conflicts and events, such as staggered start and end times for individual commissioner terms, which affects our ability to fill vacancies and will be important in the coming months as several of the current commissioners will be ending their current terms (giving eligible commissioners the ability to go through the reappointment process again). It has been challenging to meet the current quorum requirements and has hindered the ability of the commission to conduct official business. Amending the definition of quorum to a majority of appointed members will enable the Youth Commission to more easily fulfill its missions and tasks.

In the previous subject matter committee, language was deleted that would have allowed HiYC to appoint its own Executive Director. The Youth Program Specialist staff position, which acts as the executive director for the Hawai'i State Youth Commission, has been left vacant for over six months. As signed into law in 2018, Act 106 appropriated funds for administration costs and for the executive director position, which acts as a liaison between the Youth Commission and the Office of Youth Services. While the commission would still very much like to play an active role in selecting the Youth Program Specialist, we are in the process of working on amended language that would address liability and confidentiality concerns. In the meantime, we would like for your committees to PASS Senate Bill 869 SD1 as is. Changes in quorum requirements is still very much a priority that we would like to see passed by the legislature.

**<u>DEPARTMENT'S POSITION</u>**: The Department of Human Services (DHS) appreciates the measure's intent and defers to the Hawaii Youth Commission and the Office of Youth Services.

<u>PURPOSE</u>: This bill clarifies that a majority of the members appointed to the Youth Commission shall constitute a quorum to do business. Effective 12/31/2050. (SD1)

The SD1 amended the measure by:

- (1) Deleting language that would have allowed the Youth Commission to appoint its own Executive Director; and
- (2) Inserting an effective date of December 31, 2050, to encourage further discussion.

The Department supports the mission of the Youth Commission, which is to advise the governor and Legislature on the effects of legislative policies, needs, assessments, priorities, programs, and budgets concerning the youth of the State per section 352D-11, Hawaii Revised Statutes. Revising the quorum will assist the Youth Commission's ability to make decisions and progress in its work.

Regarding participation in hiring of the Commission staff, DHS suggests as a viable option that the commissioners discuss with OYS ways for Commissioners to participate in the selection process to fill the current administrator position.

Aloha Chair Rhoads, Chair Dela Cruiz, Senate Committee on Judiciary, and Senate Committee on Ways and Means,

Hello, I'm Zoey Duan, a Youth Commissioner on The Hawaii State Youth Commission. I am in support with comments of SB869 SD1, Relating To the Youth Commission.

I support amending the quorum requirement to a majority of the members rather than eight members. This would greatly increase our flexibility in performing and accomplishing various tasks that are time-sensitive and of priority while also accounting for extenuating circumstances.

Additionally, as a Youth Commissioner, I believe I should have a voice in the selection process of the commission's executive director, especially since we commissioners are the only ones who can best identify our needs and gaps that we would like assistance with. Having more mechanisms for us to encourage and facilitate the process will better enable us to find a suitable director in a timely manner. However, since there may be legal liability and confidentiality concerns if Page 4, Line 7-9 of SB869 is passed at this time, I would like to suggest that particular section be removed from the bill. I'd still like to emphasize the fact that it is important to improve upon the current hiring process to allow more engagement from youth commissioners, perhaps just in another way.

With these comments, I support SB869 SD1. Thank you for the opportunity to testify.

I am submitting testimony in support of SB869. I am fortunate to have been selected as one of the new commissioners this year. As I began attending sessions, it was clear that some restraints were halting productivity. In this case, the eight-member quorum regulation is nearly impossible to meet. Before I was voted in, there were only eight commission members, which meant all members needed to be present to vote in the new class of commissioners. We quickly discovered that the eight-member rule is only adequate when there are 15 commissioners. With the fluctuation in the commissioners, changing to a majority vote is a better fit for our current situation.
