- 1 EOA's Position: The Executive Office on Aging (EOA), an attached agency to the Department
- 2 of Health, strongly supports SB900, relating to the Hawaii State Health Insurance Assistance
- 3 Program (SHIP).
- 4 Fiscal Implications: This measure appropriates \$229,680 for SFY 2023 and the same sum for
- 5 SFY 2024 for one full-time equivalent (1.0 FTE) Program Specialist III position, one full-time
- 6 equivalent (1.0 FTE) Program Specialist IV position, and one full-time equivalent (1.0 FTE)
- 7 Program Specialist V position within the EOA to be expended for the Hawaii SHIP.
- 8 **Purpose and Justification:** The purpose of this bill is to appropriate funds for three Program
- 9 Specialist positions within the EOA to meet the growing aging population's demand for accurate,
- 10 timely, and unbiased services. Hawaii ranks first in the nation with an average life expectancy of
- 11 81.3 years of age. Hawaii's cost of living is almost double that of the national average at
- 12 193.3%. In 2022, total medical and prescription drug spending rose to \$157,480,248.

Medicare is essential to providing health care coverage for older adults and persons with 1 disabilities. However, the rules and procedures for Medicare eligibility and enrollment are 2 complex and difficult to navigate. In 1992, EOA received the first SHIP grant. Since then, the 3 Medicare population has more than doubled in 30 years from 133,439 to 295,405 in 2022. 73% 4 of Medicare beneficiaries live off their savings and 47% rely on family and friends for support. 5 Hawaii SHIP was established to assist and educate Medicare beneficiaries to: (1) Make 6 informed health plan choices based on their individual's needs and budget; (2) Enroll in 7 Medicare when first eligible to avoid lifetime late enrollment penalties; (3) Access wellness and 8 9 preventive services to improve health outcomes, lower medical costs, and promote aging in place; and (4) Enroll in Medicaid, Medicare Savings Programs, and Extra Help to reduce or 10 eliminate out-of-pocket costs. Hawaii SHIP provides free, local, unbiased, and confidential 11 assistance by phone, email, or in-person statewide. 12 In 2016 and 2017, federal funding for SHIP grantees was nearly eliminated by Congress. 13 who undervalued the importance of qualified Medicare education and assistance despite 65,000 14 people turning 65 every day. Continued advocacy, support, and stable funding is critically 15 needed to sustain the program and services for Hawaii's aging population. The Administration 16 for Community Living considers an eight percent (8%) penetration rate (23,191 individuals) as 17 acceptable (minimum) performance and justification for continued funding. However, Hawaii 18 SHIP currently serves 8,800 individuals per year, which is approximately only three percent 19 (3%) of Hawaii's Medicare population. Since 1992 Hawaii SHIP has had only two temporary 20 full-time staff, therefore, additional staff positions are needed to reach federal performance goals 21 by fiscal year 2025 and the growing needs of our aging population. 22 **Recommendation:** EOA strongly supports this measure provided that its enactment does not 23 24 reduce or replace priorities with the Administration's budget request.

Support for SB900, Relating to the State Health Insurance Assistance Program Hawaii State Health Insurance Assistance Program (SHIP) is a federally funded, volunteer-based program that is administered by the Hawaii State Department of Health, Executive Office on Aging. Hawaii SHIP helps Medicare-eligible individuals, their families and caregivers, and soonto-be retirees make informed, cost-effective healthcare decisions. This is accomplished through one-on-one counseling sessions, answering questions, distributing informative brochures at health fairs, and providing Medicare-related presentations. These services are free to the public who contact Hawaii SHIP through the Helpline and website. Volunteers, who provide these important services, are recruited and trained throughout the year to keep up with the changes or updates to Medicare.

I am a 3rd-year Master's in Social Work (MSW) Graduate student at the University of Hawai'i at Mānoa Thompson School of Social Work and Public Health, specializing in the area of Gerontology. Also, I am a current practicum student with the Hawaii SHIP Program and the University of Hawaii Manoa SHIP Native Hawaiian Outreach Community Liaison. Also, I am a caregiver to my aging father who has vascular dementia. In the Fall 2022 semester, I began my training to navigate the Medicare system so that I may become a counselor, presenter, and plan comparison specialist with Hawai'i SHIP.

I quickly discovered that the **Medicare system is complicated and overwhelming**. Learning and comprehending the Medicare system was difficult for me, a graduate student; so, I know it could be for a beneficiary. The complexity of navigating the system creates barriers for older adults and their families to affordable and accessible healthcare. Misleading or misunderstood information could result in costly consequences if healthcare decisions are poorly made. These factors contribute to widening the gap between affordability and accessibility in healthcare coverage for the aging population.

During my time as a Volunteer Hawai'i SHIP counselor, I have had the privilege of providing life-altering information about Medicare to beneficiaries, family members, and caretakers. The information I have shared assisted with making cost-effective comprehensive decisions about their Medicare which in some cases saved beneficiaries significant money per year. This is a vital outcome for beneficiaries in Hawaii as the cost of living here is astronomical.

Throughout my various titles, I witnessed the dedication of the two full-time employees and kindhearted volunteers in providing Medicare-related services for Hawai'i Kūpuna, their

families, and the aging community. As the University of Hawai'i Manoa SHIP Native Hawaiian Outreach Community Liaison, I have witnessed the importance of the distribution of correct and cost-effective planning of Medicare information. As a future Social Work clinician and an advocate for older adults, the sustainability for the SHIP Program to **continue and expand** is needed for the aging population and their families to make confident, healthcare-related decisions.

Hence, I strongly support HB649 & SB900, relating to the State Health Insurance Assistance Program, which would provide Hawaii SHIP with much-needed funding for three program specialist positions thereby expanding access to important Medicare-related services to Hawaii residents statewide.

Hawaii State Health Insurance Assistance Program (SHIP) is a federally funded, volunteer-based program that is administered by the Hawaii State Department of Health, Executive Office on Aging. Hawaii SHIP helps Medicare-eligible individuals, their families, caregivers, and soon-to-be retirees to make informed, cost-effective healthcare decisions. This is accomplished through one-on-one counseling and community outreach such as presentations, fairs, and exhibits. Services are free, local, individualized, and unbiased.

As a Social Worker in the field of Gerontology, I can see an increased need for services and supports for older adults in Hawaii. With increases to Social Security and Medicare expenditures, coupled with an increase in cost of living, older adults often find themselves struggling to financially meet their basic needs. Health insurance should be considered a necessity. Older adults are more predisposed to chronic conditions, hospitalizations, and have a higher utilization rate of medical services and prescription medication. Medicare is a complex program which is difficult to navigate for even the most capable and connected. With annual changes, numerous Medicare notices, enrollment periods, and lifetime late enrollment penalties it can often be overwhelming.

What happens if the SHIP program goes away tomorrow? People won't know when or how to sign up for Medicare. Because they didn't enroll into Medicare, they have no health insurance. Without any health insurance they won't go to the doctors or get the appropriate health care. Uninsured or underinsured people will face expensive medical bills. It only takes one health scare for a Kupuna living on fixed income (SS benefits) to lose their home. We want to prevent lower health outcomes, higher healthcare costs, and higher rates of poverty.

Hence, I strongly support SB900, relating to the State Health Insurance Assistance Program, which would provide Hawaii SHIP with three additional staff to sustain the program and meet the growing needs of our older adult population. I urge the committee to pass SB900. Thank you for this opportunity to testify.

Testimony in favor of SB900,

Dear Senators Buenaventura and Aquino;

I am a volunteer Medicare counselor with the State Health Insurance Assistance Program and am also a retired physician who saw patients in the Hilo area and was also the East Hawaii Medical Director for the Hawaii Health Systems Corporation from 2010 until 2017. In both my clinical practice and as a hospital medical director, I saw or heard of many patients who did not get the medications, lab tests, xrays, or follow-up care because they were concerned about the cost. For example, it is estimated that 30% to 50% of patients either never pick up their prescriptions or take them incorrectly, partially due to financial concerns. Their financial concern is often because they made a poor choice of insurance or were not aware of the many programs for low income Hawaii and U.S. residents. I believe that I and the many SHIP volunteers are helping our fellow residents obtain better coverage that will allow them to make medical decisions with fewer concerns about cost. Better health for our residents will ultimately result in lower costs to our health care system. SHIP's use of volunteers along with a very small staff is a cost efficient way to help Hawaii residents obtain cost effective high quality health care.

An example of the benefits of SHIP to our citizens and to our state budget is a resident that I counseled who is 68 years old and whose's only medical insurance was free Medicare Part A which only partially covers hospital costs. She has no insurance at all for outpatient care. She had a major injury to her leg, but did not seek care until she it worsened because of cost concerns, As a result, she is now burdened with thousands of dollars in doctor bills and may end up with additional thousands of dollars of hospital bills if she needs in-patient care. It is very likely that she will not be able to pay for her care, and will become reliant on medquest which is partially funded by the state. If she had approached a SHIP counselor before this accident, we would have been able to help her obtain cost effective insurance that covered most outpatient care, such as a no or low premium medicare advantage plan, and, thus, would have prevented the worsening of her health.

I have also had four clients with rare diseases with three needing 1 drug each costing more than \$150,000 per year and one needing 1 drug costing \$350,000 per year. Because of the existence of SHIP and my training as a counselor, I was able to get all four drugs under \$10,000 per year each, which they could afford. If they had not been able to get these drugs for their very serious diseases, they likely would have ended up with expensive enough care resulting in them becoming dependent on medquest and the state budget. Cases like those above are one the reasons why I and other counselors have volunteered to counsel for SHIP.

In my previous role as Medical Director for three hospitals on the Big Island, I have dealt with many staff members and executives of Hawaii State Government. I have found the very small number of staff working at the SHIP program to be among the very best state employees that I have encountered, due to their very hard work ethic despite understaffing, their prompt and helpful responses to my and other volunteers' many questions and suggestions, and their dedication to serving the needs of the SHIP clients. I am concerned that their salaries are dependent on federal grants and that the existence of SHIP and the training and maintenance of the many SHIP volunteers would be in jeopardy if the federal grants are not renewed.

Hence, I strongly support HB649 & SB900, relating to the State Health Insurance Assistance Program, which would provide Hawaii SHIP with much-needed funding for three program specialist positions thereby expanding access to important Medicare-related services to Hawaii residents statewide.

My name is Wanda Anae-Onishi of Waikele, Oahu. I am testifying as a private citizen in support of SB900. The State Health Insurance Assistance Program (SHIP) in the Executive Office on Aging (EOA) provides free, unbiased Medicare counseling, presentations, and information to beneficiaries statewide, including their families and caregivers, and people turning 65. SHIP's services help them make educated, cost-effective decisions based on their health needs while preventing late enrollment penalties which would be added to monthly premiums if they don't sign up when first eligible.

The bill requests appropriations to fund three permanent staff positions. Additional staff will provide more support to meet the needs of a growing Medicare population statewide. The Medicare population has doubled since 1992 when the EOA received the first federal grant, from 133,439 in 1992 to 295,405 in 2022. Hawaii State Health Insurance Assistance Program (SHIP) is a federally funded, volunteer-based program that is administered by the Hawaii State Department of Health, Executive Office on Aging. Hawaii SHIP helps Medicare-eligible individuals, their families and caregivers, and soonto-be retirees make informed, cost-effective healthcare decisions. This is accomplished through one-on-one counseling sessions, answering questions, and distributing informative brochures at health fairs, and providing Medicare-related presentations. These services are free to the public who contact Hawaii SHIP through the Help Line and website. Volunteers, who provide these important services, are recruited and trained throughout the year to keep up with the changes or updates to Medicare.

As a volunteer, I respond to calls from the public about Medicare. Medicare can be quite confusing and may lead to lifelong penalties in premiums if the person does not enroll at appropriate times or they be without insurance coverage if they miss an enrollment period. I have had state/city retirees who call wondering if they should respond to the barrage of TV ads, mailers and phone calls they receive during Medicare Open Enrollment period wondering if they should change their coverage. Generally, this would result in less coverage and lot of difficulty in returning to EUTF coverage. We exhibit at fairs, malls and conferences and always have individuals come up to ask questions about their Medicare coverage. Federally funding is never guaranteed and while SHIP has been fortunate to have many years of funding, the loss of funding would result in a free, unbiased and local resources no longer available to Hawaii residents.

Hence, I strongly support HB649 & SB900, relating to the State Health Insurance Assistance Program, which would provide Hawaii SHIP with much-needed funding for three program specialist positions thereby expanding access to important Medicare-related services to Hawaii residents statewide.

There are 295,405 Medicare beneficiaries statewide as of 2023. Hawaii SHIP's goal is to assist

as many beneficiaries in Hawaii as possible. With 80+ volunteers statewide in 2022, SHIP assisted 2,675 with Medicare counseling and reached 6,465 beneficiaries through outreach presentations and fairs/exhibits. By 2025, SHIP will need to reach 10,000 Medicare beneficiaries which is a drastic increase from SHIP's current capacity.

Today, the program continues with only two FT employees while the number of Medicare beneficiaries has increased to more than 295,000. As Hawaii continues to lead the U.S. in average life expectancy (83.1), there is a significant amount of *kupuna* (60 and older) who need practical, accurate and on-demand help to sift through Medicare and attempt to make the right choices for their health, safety and well-being. The program faces dire consequences if additional qualified staffing is not met now. Kupuna will make uninformed decisions, be negatively impacted and ultimately, affect the state as a whole.

Reports show that in 2037, a mere 14 years from today, the state's aging population is projected to be more than 500,000, which would comprise 1/3 of the total population.

Hawaii would do well to staff this program as each of us are all aging. Medicare is the health insurance we have all paid into since working as young adults or prior. With sufficient staffing, a well-respected volunteer workforce of equipped volunteers and the values of 'ohana and reverence for our elders, I strongly support **SB900**, relating to the State Health Insurance Assistance **Program**, which would provide Hawaii SHIP, with three additional staff to sustain the program and meet the growing needs of our older adult population in this state. #### Support for SB900, Relating to the State Health Insurance Assistance (SHIP) Program

Aloha Chair Buenaventura, Vice Chair Aquino, and Members of the Committee,

My name is Sharie Nagatani and I am a final year Graduate Student at the University of Hawai'i at Mānoa Thompson School of Social Work and Public Health, earning a Master of Social Work with a focus in gerontology. During the years of 2021-2022, I was a previous practicum student with Hawaii SHIP and the Graduate Research Assistant for the Introduction to Medicare Course under instruction of Dr. Victoria Fan for the Spring semester. This course was a partnership between the Department of Health Executive Office on Aging (EOA) Hawaii SHIP Program and the University of Hawai'i Center on Aging (COA). In Spring 2021, I was presented with the opportunity to complete the Introduction to Medicare Course before my title as a Graduate Research Assistant. As a student, learning and understanding the terminology and navigating the Medicare system was complex and difficult. These challenges in the system create barriers for older adults and their families to affordable and accessible healthcare. Misleading or misunderstood information could result in costly consequences if healthcare decisions are poorly made. According to the National Council of Aging (NCOA), researchers have found that older adults spent an average of \$368 per year more than they needed to, and, while only 5% of older adults chose the lowest cost plan, more than 20% were overspending by \$500.00 per year (Kina, 2021). These poor-led choices are contributing to the widening gap of affordability and accessibility in healthcare coverage for the aging population.

Overall, I witnessed the dedication of two full-time employees and kindhearted volunteers in providing Medicare-related services for Hawai'i's Kūpuna, their families, the aging community, and to the public. As an emerging Social Worker with a passion for advocating for older adults, the sustainability of the Hawaii SHIP Program to continue and expand its dedicated staff is crucial to providing Medicare-related services to older adults and their families in making confident, healthcare decisions.

Hence, I strongly support SB900, relating to the State Health Insurance Assistance Program, which would provide the appropriate funds for three program specialist positions within the Executive Office on Aging (EOA) for Hawaii State Health Insurance Program (SHIP). With a larger staff, Hawaii SHIP will have the potential to provide more Medicare-related services, outreach, and education to Hawaii's residents. I would like the committee to be aware that my testimony is on my behalf and not of an organization despite my past affiliations. I urge the committee to pass SB900.
