SCR115/SR109 (the "Resolution") attempts to resolve a very unfortunate and preventable accident that occurred in one MLCD in the State by eliminating all access by recreational boaters in every MLCD in the State. While there are some MLCD's that do not allow any vessel access, most MLCD's do allow recreational vessel access. We believe that current access should remain open to recreational vessels as well as commercial. It would be a mistake to penalize all recreational vessels because of the criminal negligence of one operator.

Sadly, the vessel grounding at Honolua MLCD could have been prevented had the current 2 hour maximum use law been enforced.

The Environmental Caucus has an enrolled membership of more than 7,000 politically active Hawaii voters and we strongly support any bill that protects our oceans and sea-life.

These resolutions are so closely related we offer support to both for similar reasons.

Marine Conservation districts were created to protect the sea life in them for the future as a hope for restocking after ignorant or careless recreational boat owners have ruined the ocean they can access. We should not have to remind this committee about garbage thrown over the boat side or running to fast and hitting sea life. Sadly there are some who feel like they can fish anywhere they are. We do not need them to be anywhere near protected areas.

Dear Chair, Vice Chair and Honorable Members of this Committee:

As a recreational boater who sails to Honolua Bay with my family on a regular basis, I am writing to express my strong opposition to the proposed resolution prohibiting recreational boating activities in Marine Life Conservation Districts.

Here are some of my reasons for opposing the proposed administrative rules:

- The proposed rules would unfairly penalize responsible recreational boaters for the actions of one individual who violated the law. While the diesel spill caused by a grounded vessel off Honolua Bay was unfortunate, it should not be used to justify a blanket ban on recreational boating activities in Marine Life Conservation Districts. Instead, measures should be taken to hold individuals accountable for their actions and prevent similar incidents from occurring in the future.
- Recreational boating activities, such as sailing, allow families like mine to connect with the natural environment and appreciate the beauty of our state. Banning these activities would deprive families of these valuable experiences and discourage tourism.
- Recreational boating activities, such as sailing, fishing, and snorkeling, can be done in a responsible and sustainable manner that is compatible with protecting marine life and ecosystems. Prohibiting all recreational boating activities in Marine Life Conservation Districts would be an extreme measure that fails to recognize the important role that responsible boaters play in promoting marine conservation and stewardship.
- There are already regulations in place to protect Marine Life Conservation Districts, including permits required for taking marine life for scientific, educational, or other purposes. Prohibiting all recreational boating activities would be an unnecessary and excessive measure that goes beyond what is necessary to protect marine resources
- The proposed administrative rules would limit access to public waters and natural resources, which goes against the principles of public trust doctrine that hold that natural resources should be held in trust by the government for the benefit of all citizens. The public should have the right to access and enjoy the natural resources that belong to them.
- Finally, the proposed administrative rules do not take into account the fact that many recreational boaters are responsible and respectful of the marine environment, and have a vested interest in preserving it for future generations. It is unfair to punish all recreational boaters for the actions of a few bad actors. Instead, the focus should be on educating

boaters and promoting responsible and sustainable practices that protect marine life and ecosystems

In conclusion, I urge you to reconsider the proposed administrative rules and instead explore alternative solutions that balance the protection of natural resources and wildlife with the needs of recreational boaters and their families. Thank you for considering my opposition to the proposed rules.

While this bill is well intended, based on recent occurances at Honolua Bay, the prohibition of ALL recreational boating may have unintended consequences. For instance, prohibing the use, enjoyment and inspiration gained from using hand powered watercraft including kayakas and paddle boards. We recommend a bill that encourages DLNR to focus on mooring capacity and location and the management of motorized craft (including sail boats with motors) or vessels over a certain size threshold when in the vicinity of marine life districts.
