Re: SCR 202 - Relating to Health Care Position: SUPPORT

The Hawai'i Section of the American College of Obstetricians and Gynecologists (HI ACOG) **strongly supports SCR 202**, which requests that the auditor conduct an analysis on mandating parity for in vitro fertilization health insurance coverage.

While during the COVID-19 pandemic, the use of fertility services decreased, overall the number of people seeking treatment for infertility has increased over the years.<sup>1</sup> For a variety of reasons, more people are experiencing infertility as well. Currently we have insurance coverage for in vitro fertilization for only certain individuals – same sex couples and unmarried women are excluded. This is discrimination and is unjust.

We ask the legislature to pass SCR 202.

Dear Honorable Committee Members:

The Fertility Institute of Hawaii strongly supports the bill to expand Mandatory Health Insurance Coverage for fertility treatments currently provided to married opposite-sex couples undergoing in vitro fertilization procedures. We urge you to pass this bill enabling individuals, including same-sex couples, unmarried women, and opposite-sex couples with male infertility issues, to access fertility coverage.

We live in a tolerant and inclusive world. As such, our legislation should conform to today's world. Everyone should have equal access to fertility services. Infertility is a complex issue, and the path to parenthood varies. We firmly believe that access to fertility treatments, such as insemination, IVF, and surrogacy, should be a fundamental right for all Americans, regardless of their sexual orientation, marital status, or gender identity. These treatments are the Standard of Care for treating fertility issues. Over 9 million babies have been conceived using In Vitro Fertilization, and millions have been born using other fertility treatments.

Having a child and building a family is a fundamental desire and liberty for everyone, regardless of relationship status, gender, or sexual orientation. Unfortunately, the current limitations on coverage for these treatments disproportionately affect vulnerable populations already facing social and economic barriers in pursuing parenthood.

According to the American Society for Reproductive Medicine, infertility affects one in eight couples of reproductive age in the United States. LGBTQ+ couples, single parents by choice, and couples struggling with male-factor infertility face additional hurdles on their road to parenthood. Expanding mandatory health insurance coverage for fertility treatments can remove some obstacles and create a more equitable healthcare system for all.

We commend you for taking steps to address this critical issue, and we urge you to pass this legislation without delay. The vast majority of Americans believe that insurance should cover fertility treatments, and we trust that you will represent the voices of your constituents and support this vital bill.
