## SUPPORT OF SCR 220 RELATING TO PREDATORY COSMETICS ESTABLISHMENTS

The Maui Chamber of Commerce would like offer **our SUPPORT of SCR 220** urging the County of Maui to immediately and substantially increase the fines assessed against predatory cosmetics establishments for violating the Maui County historic districts ordinance.

We wholeheartedly support this bill. This activity happens across the mainland and I have experienced it considerably in Las Vegas, which led to me to avoid those areas while shopping. We see this same behavior happening in Lahaina across Front Street, which hurts neighboring businesses as residents and visitors bypass these areas.

We hoped this issue would be solved with the Maui County Historic Districts Ordinance and agreements with these companies. We understand there is a challenge with having enforcement officers but we feel raising the fines for something as egregious as this, where prior agreements aren't being honored, is important. If this behavior is allowed, it will continue to proliferate.

We support the efforts of the Lahaina Town Action Committee and West Maui Taxpayers Association to get this resolved.
