The Department of Transportation Services (DTS) of the City and County of Honolulu (City) is in **strong support** of Senate Concurrent Resolution 43/Senate Resolution 37 (SCR 43/SR37), relating to the implementation of the Pearl Harbor Historic Trail (PHHT) pilot demonstration project.

DTS notes that ongoing congressional appropriation is funding a planning study for a 30-mile South Shore Bike Path spanning Nānākuli to Mānoa that the City is working to develop in partnership with the State Department of Transportation, of which the existing PHHT is a majority link in the bikeway. DTS also recognizes that the pilot demonstration project will be instrumental in determining and developing a working relationship between City, State, and Federal partners with respect to the shared jurisdictional property boundaries and land interests.

Although the DTS strongly supports the coordination of the PHHT as an essential multimodal connection, running parallel to the City's rail alignment, DTS does not currently have large-scale funding in place to make infrastructure improvements in our upcoming proposed FY24 budget. However, the City can move forward, with the State's partnership, in negotiating agreements with the United States Navy to resolve access issues in 'Aiea in order to provide a contiguous path on the PHHT in the areas of the Admiral's Boathouse and the Pearl Harbor Historic Monuments, with connections to our Hālawa Aloha Stadium Rail Station.

The DTS strongly believes that implementation of the PHHT pilot demonstration project is an integral step in completing the long-term vision of the 'Aiea-Pearl City community, and will not only link neighborhoods and historic sites, but will provide a much needed recreational opportunity for residents and visitors, enhancing their mental and physical health and well-being, while showcasing the island's visual beauty and regional attractions along the old Oahu Railway and Land Company pathway.

On behalf of the 'Aiea Community Association and the Friends of the Pearl Harbor Historic Trail, I would like to express our full support for SCR 43 and SR 37: to have the necessary governmental agencies move forward on the Pearl Harbor Historic Trail Demonstration Project, entering into long-term agreements with the Navy to sustain the viability of this multi-use trail.

The Pearl Harbor Historic Trail (PHHT) was identified and highlighted in the 'Aiea and Pearl City Livable Communities Plan in May 2004. It was also the vision of Empower O'ahu as an economic engine when the City applied for a HUD Empowerment Zones and Enterprise Communities designation in 2000. The PHHT stretches 18.6 miles from Halawa Landing to Nanakuli links the communities along the west side of O'ahu.
