In consideration of SENATE CONCURRENT RESOLUTION 92/SENATE RESOLUTION 85 REQUESTING THE DEPARTMENT OF AGRICULTURE, DEPARTMENT OF LAND AND NATURAL RESOURCES, DEPARTMENT OF HEALTH, THE CITY AND COUNTY OF HONOLULU, AND THE COUNTY OF HAWAII, TO COLLABORATE TO ESTABLISH AND IMPLEMENT A FIVE-YEAR PILOT PROGRAM TO MITIGATE AND CONTROL THE SIGNIFICANT INCREASE IN THE POPULATION OF FERAL CHICKENS, ROOSTERS, AND PIGS.

Senate Concurrent Resolution 92/Senate Resolution 85 recognize that feral chickens, roosters, and pigs have become a nuisance in suburban and urban areas, and their populations and impacts are increasing. It requests the Department of Agriculture, Department of Land and Natural Resources (Department), Department of Health, the City and County of Honolulu, and the County of Hawaii to collaborate to establish and implement a five-year pilot program to mitigate and control feral chickens, roosters, and pigs. **The Department offers the following comments.**

The Department controls populations of feral chickens (including hens and roosters) and pigs on lands under its jurisdiction, with a heavy emphasis on fencing forested lands to prevent deforestation and the spread of invasive plant species and Rapid 'Ōhi'a Death (ROD) from pigs and other hoofed animals. However, the Department does not have the capacity to implement nuisance chicken and pig control on private and county lands. The Department believes efforts to suppress feral chicken and pig populations in suburban and urban areas are best led by the respective counties. The Department notes that rats, cats and mongooses pose an even larger threat to native and endangered forest birds, seabirds, shorebirds, and migratory birds as they eat adult

There are examples of entire native bird colonies in Hawai'i being killed by a single cat.

Cats also pose a particular threat to native species in Hawai'i as their feces carries a parasite that carries the disease toxoplasmosis - a leading cause of death in the endangered Hawaiian monk seal. Toxoplasmosis quickly causes inflammation and organ failure in Hawaiian monk seals. When it rains, stormwater picks up toxoplasmosis from dissolved cat feces in yards, streets, sidewalks, drainage canals, and in nature and empties into the ocean waters surrounding the islands. Twenty percent (20%) of households in Hawai'i own cats, and half of those cat-owning households allow their cats outside, which means that their feces plus the feces of stray cats, is impacting the marine environment through rain runoff. Toxoplasmosis is in the water column and in Hawaiian monk seal prey (crab, shrimp, lobster, fish, squid, octopus). Toxoplasmosis has also been found to affect and harm Hawaiian spinner dolphins, and 'Alalā (Hawaiian crow) which prey on mice and smaller animals that have toxoplasmosis from eating cat feces or drinking affected water.

Chairperson Gabbard and Members of the Committee:

SCR92 Requests the Department of Agriculture (HDOA), Department of Land and Natural Resources, Department of Health, the City and County of Honolulu, and the County of Hawaii, to collaborate to establish a five-year pilot program to mitigate and control the significant Increase in the population of feral chickens, roosters and pigs.

The pilot program is to begin in the areas of Moanalua, Kalihi, Kalaeloa, and Kapolei in the City and County of Honolulu and the Puna area in the County of Hawaii, and the HDOA is requested to submit an interim report regarding the fiveyear pilot program to the Legislature no later than twenty days prior to the convening of the Regular session of 2026, and a final report to the Legislature no later than

twenty days prior to the convening of the Regular session of 2028. The HDOA opposes this resolution for the following reasons and offers comments and recommendations.

The HDOA opposes the resolution because SCR92 also requires that the fiveyear pilot program 1) Provide free traps to members of the public to capture feral animals; 2) Collect traps containing the captured feral animals; and 3) Return of empty traps to the members of the public. HDOA does not have the personnel or financial resources to support operational or field work activities for these types of animal control projects. Providing, collecting and returning traps, and disposition of captured animals is costly, labor intensive and requires training and a fleet of suitable vehicles to implement the program.

In addition, nuisance and identified threats from feral chickens and roosters primarily involve urban areas. Feral pigs are often associated with public lands not under the HDOA's control. Consequently, the HDOA should not be the agency to manage this project. Feral chicken control is best accomplished by the counties because it is under their jurisdiction and the counties can objectively target urban areas. Feral pigs, as with other wild game, is best managed by DLNR.

The HDOA comments that we can be a partner in the five-year pilot program, providing technical information to other agencies, such as restricted use products.

The recommendation is that a task force be established to determine the agency with the skillsets and resources to establish and implement the five-year program to take the lead. The task force would include representatives from federal, state and county agencies, agriculture associations, hunting clubs, and the University of Hawaii. The task force would secure a contractor via the Request for Proposals method of procurement, with a scope of services that includes measurable, science-based, and realistic actions, collaboration with agencies and agriculture/commodity/hunting groups,

with milestones for reporting dates and with the option to request additional funding or extending the time of performance.

1 Fiscal Implications: This resolution may impact the priorities identified in the Governor's

2 Executive Budget Request for the Department of Health's (Department) appropriations and

3 personnel priorities.

4 **Department Testimony:** The Department opposes this resolution because the Vector Control

5 Branch is not equipped and not staffed for feral chicken or pig control. Managing the

6 widespread use of live animal traps is an intensive activity requiring equipment and workforce.

7 Because feral chickens and feral pigs themselves are not a threat to public health, the

8 Department should not be the lead agency to control these feral animals. The resolution proposes

9 responsibilities to the Department regardless of human health hazards, and most actions under

10 this resolution will therefore extend beyond human health hazards; thereby expanding the

11 Department's responsibilities.

12 Animal (feral chickens, roosters, and pigs) control activities are better suited for agencies 13 already providing feral animal control or the Counties. This pilot program may also require

14 additional funding and resources.
