The Department of Business, Economic Development and Tourism (DBEDT) offers **comments** on SCR 178 / SR 122, which requests the Governor to establish a 2023 Asia-Pacific Economic Cooperation Hawai'i delegation team to participate in the 2023 Asia-Pacific Economic Corporation events in Seattle and San Francisco.
