Aloha! I am a resident of Lahaina town I have recently been subject to aggressive encounters with the lotion salespeople on Front Street. Today, December 21 my husband and I were walking on the Mauka side of the street, between Lahainaluna and Dickenson. There are two of these stores on that side of the street, and this one was the shop closest to Lahainaluna. My husband was walking on the inside and the saleswoman walked directly in front of him, blocking him from walking, and reached out to hand me the sample. I was highly bothered that she stepped in front of my husband trying to block our walking, so I said "get out of my way!". She immediately acted like she was appalled, saying something to the effect of, oh my god, wow, I don't remember the exact words, but I assume it's scripted for them when they get someone who doesn't take kindly to them.

Another encounter I had was on December 19. I was walking on the Makai side between Lahainaluna and Papalaua, in front of the shop next to Fish Co. The salesman said ma'am, I ignored, and he followed and pursued, saying ma'am, ma'am. I finally turned around because I was so annoyed that he was aggressive and following me, and I said "what part of ignoring you do you not understand?".

I know its the holidays so they are probably being more aggressive, assuming everyone is a tourist and in a shopping mood, but I, and everyone I know, are truly so disgusted by these aggressive sales techniques, not to mention the entitled attitude and lack of aloha these lotion shops are bringing into our community. I find myself wanting to avoid Front Street, which saddens me. This also reflects badly on our town and community and it saddens me that our beautiful town may be getting a bad reputation because of these aggressive barkers.
