# II. Background and Summary

Hina Mauka was established as The Alcoholic Rehabilitation Services of Hawaii Inc., dba Hina Mauka in July 1977. With 85 full-time and 21 part time employees, we serve low-income adults (18 years and older) with Substance Misuse Disorders as well as co-occurring mental health disorders. Over 80% of our population is low to moderate income, and 76% of our patients report an annual income of less than \$19,000. Hina Mauka is a leader in treating complex patients in Hawaii having substance use disorder, addiction, mental illness, and chronic health conditions. We offer comprehensive services including substance use disorder treatment and co-occurring mental health disorder treatment, case management, peer mentoring, psychiatric services, prevention, and family education. Programs are collaborative, involving many other referral and treatment agencies in our treatment planning. Individual and group counseling, process groups, skill-building, and relapse prevention education are a part of Hina Mauka's services. Modalities include – Residential Day Treatment, Intensive Outpatient, Continuing Care, and Motivational Enhancement Groups. We treat clients through cognitive therapies and peer group support. We also have begun serving mildly complex patients who need integrated care with psychiatrists,

primary care physicians, and psychologists to help with co-morbidity issues. Recently we expanded our services to include medication-assisted treatment, and offender reentry programming. Several years ago, we were fortunate enough to have legislative and community support to help us expand a new 16-bed wing to our residential facility to accommodate a long wait list. However, the previous 48 bed facility is showing significant signs of aging and deterioration.

2. The goals and objectives related to the request;

The objective of this project is twofold: First, to address the existing issues with our roof, which is currently experiencing leaks, in preparation for the eventual installation of Solar Power Panels on the repaired section. The need for roof repair arises both from the leaks and the necessity to ensure that it can endure the expected 20-year lifespan of the solar panels.

Upon the completion of repairs to the roof segment, our plan is to begin planning for the installation of solar power panels on that specific section. This initiative serves a dual purpose: it mitigates our environmental impact on Oahu by reducing our carbon footprint and addresses the financial challenges Hina Mauka faces.

As a 24/7 healthcare facility, Hina Mauka's electricity consumption is substantial, resulting in a monthly bill exceeding \$11,500. The installation of solar panels carries significant importance for several reasons:

- 1. **Cost Efficiency**: Hina Mauka operates within budget constraints. By implementing solar panels, we can substantially curtail our energy expenditures. These cost savings can then be redirected toward critical services and programs that directly assist individuals grappling with substance abuse disorders and behavioral health concerns. This reallocation of resources can elevate the quality and accessibility of our services.
- 2. **Sustainability**: Hina Mauka aspires to be a community leader in adopting sustainable practices. Embracing solar power underscores our commitment to environmental preservation, aligning with principles of stewardship and responsibility.
- 3. **Reliable Energy Source**: Solar power offers a more dependable and consistent energy supply, reducing our reliance on the traditional power grid. This reliability is paramount for Hina Mauka, given our need for uninterrupted services for our residential treatment clients.
- 4. **Long-term Financial Planning**: While installing solar panels necessitates an initial investment, it promises enduring financial benefits. The predictability of energy costs associated with solar power facilitates more effective and stable financial planning. Such stability proves indispensable for Hina Mauka, where financial uncertainties can significantly impact the delivery of services.
- 5. **State Requirement**: Hawaii's Energy Information Administration (EIA) mandates that 100% of electricity must be generated from renewable sources by 2045. As of 2022, roughly 29% of the state's total generation came from renewables. Hina Mauka has consistently been at the forefront of treatment services and aims to maintain this progressive stance, aligning with the state's evolving energy needs.

This project promises cost savings for Hina Mauka and aligns with sustainability principles and responsible stewardship. It enhances our financial stability, fosters community engagement, and contributes to the broader objective of creating a healthier environment, particularly for individuals grappling with substance abuse and behavioral health challenges.

#### 3. The public purpose and need to be served;

As one of the state's largest substance abuse treatment facilities Hina Mauka provides a multitude of treatment services to patients with multiple chronic conditions (MCC) that include substance use disorders (alcohol, meth opioids), co-occurring mental health disorders (depression, anxiety, PTSD) and co-morbid physical disorders (heart and liver disease, diabetes, hypertension) still receive disjointed, uncoordinated, and inadequately funded care. MCC is a high-priority health need. Many of them are homeless and suffer from acute medical and behavioral health conditions. The 2020 Oahu homeless count of 4,448 estimated that 57% were unsheltered. Ranging from 27% to 35%, many have substance abuse, mental illness, or physical conditions while 26% were Native Hawaiian or Other Pacific Islander.

As a result of untreated complex problems involving substance use disorders, co-occurring disorders, and physical health disorders, these consistent users of the system cost our state an average of \$82,000 per year per person. (Homeless in Hawaii: Facts and Resources, 2021). In a report published by the Hawaii Health Department in January 2020: "Hawaii community members who experience homelessness and chronic homelessness are especially at risk for substance dependence issues." Hawaii has the 3rd highest per capita homelessness in the nation at 2.7 times higher than the national average.

While opioid abuse is increasing, alcohol and methamphetamine remains Hawaii's most prevalent drug used among adults. "Homelessness [and drug activity] is a serious problem for...small and mid-sized businesses who have to grow accustomed to property damage and customer complaints linked to a rising tide of what they deem threatening or criminal street behavior" (Star-Advertiser 2019).

Because we are a 24/7 inpatient treatment facility, we rely heavily on the current electrical grid, hence our outrageous electrical bill. To reduce our carbon footprint Hina Mauka intends to install enough solar panels to produce enough renewable energy to power our own facility as well as give back to the electrical grid! This transition from dependency on electricity generated through fossil fuels to solar will benefit the Island of Oahu and alleviate our significant electrical cost, which is approximately \$11,500 a month. Hina Mauka can then use this money to implement an integrated healthcare approach to more patients, as the evidence clearly shows it is the most efficacious and cost-effective approach to treating substance abuse, mental health, and physical health problems among chronically homeless people.

#### 4. Describe the target population to be served; and

Located in Windward Oahu, we serve the entire State of Hawaii; our population is predominately low-income adults +18 years old who suffer from chronic drug/alcohol addiction, mental health disorders as well as disabling medical conditions. This population can include homeless, elderly, battered spouses, illiterate, disabled, and veterans with mental health issues. 84% of our patients are between the ages of 20-49, the largest ethnic groups served by our programs are: 52% Hawaiian/Pacific Islander, 21% Asian, and 20% Caucasian. 89% of our patients meet the HUD definition of homelessness and 61% report earning less than \$10,000 annually.

Hina Mauka provides residential services to residents statewide.

Hina Mauka will work closely with the state as well as contractors to ensure that all work meets regulatory codes and requirements of this grant. Hina Mauka's facility maintenance department

will review all plans/proposals and review the work of the contractor to ensure compliance with the scope of services.

As a large treatment provider for low-income residents with over 50 years of experience, Hina Mauka has state licenses (STF), national accreditation (CARF), and about 25 contracts with the government and ensures to provide residential treatment services.

Operations began in 1995 when Hina Mauka successfully constructed the residential facility (24,000 sq. ft.) which was funded by State Grant-in-Aids Funds as well as numerous local foundations and businesses.

Hina Mauka has an extensive history in completing Capital Improvement Projects. Our most significant was completing our 16-bed capital improvement project called Pakui' Hale. The goal of this project was to add an additional 16 beds to our existing 48-bed facility. The residential expansion project planning began in 2013, the design phase started in 2014, and the completion of this project was in March 2018.

Since the completion of this major project, Hina Mauka has completed additional projects on our residential facility, such as flooring renovations, sum pump upgrades, and our most recent HVAC installation for our cafeteria. These various projects were funded through State and City and County Grant in Aid funding.

Hina Mauka employs about 100 employees throughout the adult and adolescent programs. We have had long-term leadership with CEO and President Alan Johnson, who has guided Hina Mauka since opening its doors in 1995. Under his leadership is a strong and competent management team that has the ability to oversee, plan, and implement a project of this size.

- Roof repairs completed to support the solar system

These outcomes are aligned with the priorities of the Grants in Aid Fund because they will directly benefit homeless and low to moderate individuals who are struggling with substance use disorder and behavioral health challenges. 100% of the savings that will be realized because of this project will be reinvested into programs for the benefit of these individuals.

#### 2. Facilities

#### Kaneohe: 45-845 Po'okela Street, Kaneohe, Hawaii 96744

Hina Mauka's Kaneohe facility has the ability to provide residential services to 64 clients at any given time. This residential facility has adequate space for several outpatient groups and houses our administrative staff, kitchen, dining room, laundry room, and individual counseling rooms. The residential clients reside upstairs, which is accessible by stairs and elevator. On the ground floor, there are 5 large, enclosed group rooms, an expansive dining room that also serves

for client groups, recovery meetings and staff trainings, 9 individual enclosed counseling rooms, a Treatment Associates' office that is open 24 hours a day, a physician's office, a nursing office, a physical examination room, a large, enclosed chart/documentation room, and a large enclosed clinical administrative office. Double closed doors provide privacy and separate the clinic area from the large open lobby where our receptionist and intake specialist's welcome guests, our patients, families, and those seeking program services.

The building meets all ADA regulations and has been further designed to accommodate persons with disabilities. The building is equipped with an elevator; wide doors; client rooms and offices that accommodate wheelchair access; accessible bathrooms and several handicap parking spaces. The facility is isolated, providing client confidentially, and is several blocks from the nearby Hawaii State Hospital, Kaneohe Court House, Windward Community College, Windward Mental Health and the Windward District Park. The facility is accessible by bus and there is a bus stop within 2 blocks of the facility.

Pursuant to our state licensing requirements, the Kaneohe building meets all federal, state and local regulations (e.g. building codes). The building was specifically designed for alcohol and other substance abuse rehabilitation, with the integrity of the confidential relationship and the personal dignity of the client of primary consideration. Hina Mauka modified the existing inhouse bathrooms according to recommendations from the US District Court representatives to improve upon the integrity and accuracy of urine collections. The health and safety of employees, clients and the community is a priority and is monitored by the Office of Health Care Assurance annually.

To meet the growing needs of our community, Hina Mauka expanded its operations with the completion of the Annex building in 2008. The completion of the project has given Hina Mauka the capacity to provide comprehensive services that include peer mentoring, psychiatric services, family program services and case management. The Annex is equipped with a large conference room used for provider, family and board meetings, monitoring/audits, clinical group supervision, and education/process groups. It also provides office space for management and outpatient counselors. The second floor affords enough space to house all clinical medical records for 7 years. The Annex building meets all ADA regulations.

Security - Ingress and egress is maintained 24/7 by the use of personnel, surveillance cameras and door locks armed with an alarm system. Adequate personnel are on hand and signs direct people to the front desk where visitors are required to sign in. Personnel are stationed in the main lobby to welcome visitors and ensure only authorized persons are allowed on the premises. Any movement from the upstairs residence to the first floor and any attempt to open external doors will be identified by the alarm. As an extra layer of security Hina Mauka has surveillance cameras throughout the perimeter and buildings.

## VI. Personnel: Project Organization and Staffing

#### 1. Proposed Staffing, Staff Qualifications, Supervision and Training

Hina Mauka has the staff to manage construction vendors who will complete the work. Hina Mauka has an impressive resume of key personnel that will provide direction and supervision on a project of this scope. Hina Mauka's core leadership is under the direction of Alan Johnson, CEO and President who has guided the organization since 1995 through different platforms including Director of Finance and Chief Operations Officer. Desie Graves, Chief Financial Officer, has over 30 years of fund accounting experience with non-profit organizations. Sherrie Kinoshita, Director of Administration has been with Hina Mauka for 15 years and has worked in the clinical program as the Clinical Administrative Supervisor; currently she oversees the DHS Testing Department, Clinical Administration, and Administration. Heather Butler, Administrative Supervisor, has been with Hina Mauka for 10 years and has the organizational and time management skills to keep the project moving and on task; currently she oversees Facilities and Food Service department. Aaron Lee, Facilities Personnel, has been with Hina Mauka for 2 years and has extensive knowledge of demolition, reconstruction and contacting contractors.
