Aloha Animal Sanctuary was founded in 2019 as O'ahu's first 501(c)(3) non-profit sanctuary for farmed animals, and currently cares for over 30 animal residents. The sanctuary was established by a team of animal rights activists who recognized the need for a farmed animal sanctuary on O'ahu. Aloha Animal Sanctuary is a vegan facility located on two acres of lush farmland in Kaneohe, and provides both short-term and life-long care and rehabilitation to neglected, abandoned, or abused farm animals. The sanctuary aims to educate the community on environmentally sustainable choices through a mindset of compassion and respect. We are 100%

volunteer-based and have over 120 active volunteers, providing not only a safe space to our animal residents, but to all animal lovers of the local community.

The goals and objectives related to the request;

If selected to receive the requested funds, Aloha Animal Sanctuary will use \$12,000 of this grant to acquire and retain a part-time managing director that can assist with key areas of the organization's operations for at least 1 year. The other \$8,000 of this grant will be used to cover veterinary costs often associated with the rescue of abused, abandoned, and neglected farm animals. Unfortunately, the sanctuary is often forced to turn away prospective animals due to a lack of space and resources. This grant will allow the sanctuary to expand services both immediately and sustainably long-term and more aptly plan for growth in the future, with an overall goal of expanding services for underprivileged community members with livestock animals.

3. The public purpose and need to be served;

Farm animals are often the first left to suffer, abandoned on public lands, or killed when owners are faced with hardships. To compound this issue, veterinarians that treat livestock animals are a limited resource on Oʻahu, and there are often challenges associated with treating farm animals due to their association as a food source. With extremely limited access to veterinarian care and support, it is likely that livestock owners in the community will abandon their sick or unwanted livestock on private or public lands, allowing the spread of dangerous diseases across Oʻahu and permitting feral populations to further establish and harm the ecosystems they invade.

Aloha Animal Sanctuary's mission is to provide a safe, compassionate space for farm animals. The sanctuary's goals are to help as many members of the local community as possible access services to care for abandoned and abused farm animals, and help address some of the environmental impacts associated with invasive livestock species on O'ahu. Unfortunately, Aloha Animal Sanctuary is often forced to turn down new animal residents due to a lack of space and resources. With the acquisition of this grant funding, the sanctuary will be able to continue expanding and providing services to underserved local communities.

4. Describe the target population to be served; and

The target population Aloha Animal Sanctuary aims to serve is underprivileged community members who do not have access to emergency care for their livestock animals. The sanctuary particularly focuses on cases of extreme abuse and neglect, and will often take in animals that are facing death or have nowhere else to go.

5. Describe the geographic coverage.

Aloha Animal Sanctuary currently operates on two acres of land in Kahalu'u, on the east side of O'ahu, Hawai'i. The sanctuary provides services for all of O'ahu.

III. Service Summary and Outcomes

In order to expand our services and outreach, Aloha Animal Sanctuary is committed to securing a managing director to guide our growth efforts better into the future. This position will oversee day to day operations of the sanctuary to include management of residents and over 120 active volunteers that come on-site and support remotely who live in various time zones. This position would allow us to plan our expansion in a sustainable and efficient manner. To make a greater impact on local communities and the welfare of local farm animals, grant funds will also be used to cover veterinary expenses, allowing us to immediately provide veterinary care for more individual animals than previously possible.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

Aloha Animal Sanctuary will hire a managing director at the beginning of the fiscal year that funds are received. Throughout the rest of that fiscal year, remaining funds will be used on an as-needed basis for veterinary costs. These veterinary costs will be associated with treating both long-term and short-term animal residents. All progress relating to the managing director position and details regarding veterinary costs will be reported quarterly.

At Aloha Animal Sanctuary, we have developed a comprehensive quality assurance and evaluation plan to ensure the effective utilization of the grant funds and the continuous improvement of our operations throughout the grant duration.

We are committed to maintaining a high standard of performance in various areas. Firstly, we will conduct regular internal checks to assess my performance as the managing director. These checks are essential to ensure that our leadership is effectively guiding the organization toward its goals. Reports on performance will be generated and reviewed on a consistent basis. Furthermore, the Aloha Animal Sanctuary Board of Directors will closely monitor the veterinary services provided during the grant period. This oversight is crucial to ensure that the health and well-being of our beloved animal residents are properly addressed. We will generate reports on the veterinary services conducted to maintain transparency and accountability.

To measure and assess our performance continually, we will establish monthly metrics that we will personally oversee. These metrics will focus on key areas:

• Project Management: We will track our ability to address day-to-day infrastructure repair and maintenance needs. This includes evaluating how efficiently and effectively we manage essential tasks to maintain our sanctuary's facilities.

- Animal Residents: We will personally monitor the health needs, enrichment activities, coordination of medical care, and management of health records for our animal residents. Ensuring their well-being and care is our top priority.
- Volunteers: We will be actively involved in managing our volunteers and recruitment efforts. This involves overseeing volunteer activities, conducting interviews, extending offers, and personally participating in volunteer training programs.

By implementing these monthly metrics and internal checks, we are dedicated to ensuring that the grant funds are used responsibly and that our animal residents receive the highest standards of care. Our commitment to quality assurance and continuous improvement is at the core of our mission at Aloha Animal Sanctuary

Our sanctuary is entirely volunteer run, with over 120 core volunteers. Everyone in the organization has a different specialty; there are animal caretakers who feed the animals their meals twice per day, human resource volunteers who onboard and train new team members,

facility volunteers skilled in repairs and construction, fundraiser planners and accountants, and so on! The sanctuary is truly a hive, and everyone involved plays a critical and unique role for the sanctuary's success.

Initially we set out to create a place of refuge for farmed animals in need. However, the sanctuary quickly evolved into a safe gathering place for humans as well. We hear over and over again from our volunteers that they were inspired to join Aloha Animal Sanctuary not only because of our mission, but to meet other people with similar interests. It is very common for our volunteers to get together outside of their scheduled shifts, and many have gained lifelong friendships through the sanctuary. We offer a space for retirees, military spouses, schoolchildren, families, and people from all walks of life to feel a sense of belonging through uniting for a selfless purpose.

Over the last 4.5 years, Aloha Animal Sanctuary has hosted volunteer opportunities for local schools, programs, workplaces, and general open volunteer days for anyone to join. Here are a few

recent examples from this past 2023 year:

- We hosted an internship program for six students from Assets High School for the 2022-2023 academic year. The students came every week for 3+ hours to help with sanctuary projects.
- This past August, a troop of girl scouts categorized all the invasive species of the sanctuary grounds and assisted with the removal of many of them. This troop also went on to plant endemic species on sanctuary grounds instead.
- Rotaract E-Club 'Ohana District 5000 came to do a volunteer day at the sanctuary in September 2023 and assisted with general projects.
- Student Animal Legal Defense Fund at UH Mānoa has hosted multiple volunteer days at the sanctuary for their college students.
- Key Project (a non-profit for seniors) came to visit the sanctuary for one of their outings.
- The sanctuary hosts open "volunteer days" every month where anyone can join, including keiki. Together we work on sanctuary projects and bond with each other and the animals!

And of course, we can't go much longer without bringing the focus back to our WHY!

Aloha Animal Sanctuary's main purpose is to provide a safe refuge for farmed animals. Many people ask, why farmed animals? The reason is because many organizations exist to help companion animals (cats and dogs), but often these organizations do not have the capacity to help animals like our Ellie (a 700 lb piggy!) or baby lambs who need to be syringe-fed around-the-clock (like our sweet Ho'ola and Daisy!).

Aloha Animal Sanctuary is located at the base of the lush Koʻolau Mountain Range in Kahaluʻu, Kaneʻohe and rests on 2 acres of land. Just a hop and a skip from the ocean, the property enjoys the sea breeze and ample rainfall which keeps temperatures mild and cool for the animals. The sanctuary has a few fenced-in areas for larger livestock such as pigs, goats, Muscovy ducks, and sheep. We also have several aviaries for our blind or injured chickens, turkeys, and other smaller livestock birds. We have around 120 active volunteers with a wide variety of skill sets from animal caretakers and hoof groomers, to social media managers and outreach volunteers, to grant writers and bookkeepers. Our volunteer base is dedicated not only to caring for each of our resident animals, but towards the success of the sanctuary's mission as a whole.

Our diverse and skilled volunteer group will be pivotal in the success of the managing director position. In addition, we have established care with a local livestock veterinarian, and are adequately staffed to support any treatment plans required for veterinary care.

Veternary clinics that currently provide care: Feather & Fur, VCA, Affordable Vet Service, and Dale Veternary Mobile Services.
