Big Brothers Big Sisters Hawai'i (BBBSH) serves at-risk youth, their families, and volunteer mentors with one-to-one mentoring programs on O'ahu, Maui, and Kaua'i. Our mission is to build and support one-to-one relationships to ignite the

most promising futures for Hawai'i's children. Our core operating principle is the quality of relationships determines the quality of our lives.

Since 1963, BBBSH has provided mentoring services to vulnerable youth. We primarily support single-parents and at-risk youth through evidence-based mentoring programs, modeled after Big Brothers Big Sisters of America's nationwide services. All funding for programs is raised locally and supports Hawai'i's children and families.

2. The goals and objectives related to the request;

Big Brothers Big Sisters Hawai'i has an opportunity to acquire property that will help to achieve initiatives in the organization's recently completed strategic plan:

- Organizational stability;
- Expansion of programs and services beyond traditional one-to-one mentoring
 - Enhanced programs and services focused on teens and their future success;
- Increased community presence and awareness;
- Space will be available for community workshops and training;
- A professional services area to house our professional case management services and youth counseling.

The property will be transformed into BBBSH's Mentor Center Campus that will house an Innovation Hub community space to make mentoring accessible and to create a bridge to future opportunities for youth with an expanded focus on teens. At the Hub, teens will have access to mentoring resources, explore job and career opportunities, access online resources, receive individualized care and case management, and enjoy socialization with other teens.

The campus, modeled after successful BBBSH programs on Maui, will be safe, welcoming, and dedicated to teens and young adults. The organization will connect youth to mentoring opportunities that align with their interests, passions, and goals, to expand their career pathways and help plan their future success.

The property identified for purchase is 15,225 square foot building located 414 North School Street in Liliha on the island of O'ahu. The purchase price

is \$6.25 million of which \$2.5 million has been secured. This grant in aid will complete the purchase. Discussions with the landowner are currently underway and the property will be available for purchase in mid-2024.

(The property will require renovations, these expenses are not included in this request and will be funded through a capital campaign.)

3. The public purpose and need to be served;

In December 2021, Surgeon General Vivek Murthy issued a rare warning: Mental health challenges were leading to "devastating effects" among young people. His statement came as the suicide rate for young Americans ages 10 to 19 jumped by 40 percent from 2001 to 2019, while emergency room visits for self-harm rose by 88 percent.¹

Ever-present technology evolves so quickly that its impact on young lives is hard to measure or control. Meanwhile, the threats of climate change, gun violence, economic and political instability, and racial and gender inequality are reported widely while measures to address these problems move slowly. Our youth learn early that the world is not a safe place at the very time in their lives when they most need stability as they are growing into adulthood.

Add to this post-pandemic hardships that have disproportionately impacted marginalized communities and families at lower income levels. Working low paying jobs to put food on the table and a roof over a child's head is stressful and reduces the time and energy a parent can give to their family. Adults in the household who suffer mental health or addiction issues cannot be healthy role models.

These situations and others contribute to the increasing *mentoring gap* that refers to the growing number of youth without positive relationships in their lives. This perpetuates inequality because our most vulnerable youth have less access to caring adults outside their families, and fewer opportunities to engage with those individuals through academic, community, and extracurricular activities.

Big Brothers and Big Sisters Hawai'i recognizes that the future of thousands of young people and in turn our community is at stake. BBBSH must expand its programs to reach more young people and do more to help them. By creating more connections, increasing opportunities, and generating higher quality relationships, Big Brothers Big Sisters Hawai'i can have a greater impact on the quality of life in Hawai'i.

4. Describe the target population to be served; and

BBBSH assesses each young person and their family circumstance to provide individualized support to best fit their needs. Our youth and families have different family structures, socioeconomic levels, ethnic backgrounds and live in communities on O'ahu, Maui and Kaua'i. Priority is given to youth who have a single parent or one who is deployed; or a foster or incarcerated parent. At-risk indicators include youth who are facing poverty or homelessness, have a history of abuse and/or neglect, are involved with the juvenile justice system; children who are bullied, have attempted suicide or display self-harming behaviors, or have experience or are at risk of being sex trafficked. Our program reaches Hawai'i's disadvantaged communities and serves the most at-risk youth and families.

5. Describe the geographic coverage.

Big Brothers Big Sisters provides mentoring programs on Oʻahu, Maui, and Kauaʻi. The new campus will be located in the Liliha community and will serve the Honolulu neighborhoolds of Liliha, Kapālama, Palama, and Kalihi where a large percentage of underserved children and their families reside. However services will not be limited to this region – as in the past BBBSH programs will be available to youth across Oʻahu. BBBSH administrative offices will be located on the new campus and will support operations statewide.

A review of Census data reveals that 11 percent of children residing on O'ahu are experiencing poverty, while in urban Honolulu, this figure rises to 13.3 percent. Notably, the census tracts in close proximity to the new campus exhibit even higher percentages, ranging from 20 to 53 percent, of children living below the poverty level.

In addition, these census tracts have a higher prevalence of single-parent households. While the average number of single-parent households on O'ahu is 20 percent, the census tract encompassing the new campus reports 54 percent as single-parent households. Similarly, the two adjoining tracks have percentages of 29 percent and 35 percent for single-parent households.

The BBBSH Building Committee has been established with members that include the Board Chair, CEO, CEO Emeritus, board members and volunteers who possess expertise in areas such as design and construction, finance, real property law and corporate real estate.

Dennis Brown, the former president/CEO of BBBSH, retired at the end of 2023 after serving 25 years and Tyler Kurashige was appointed by the board to succeed Dennis as the new president/CEO of BBBSH. At the request of the board of directors Brown has agreed to continue working on the project as CEO Emeritus, leading efforts for property acquisition and the capital campaign.

BBBSH regularly monitors, evaluates and, if necessary, makes improvements to its services through its established quality assurance protocols. Quality assurance checks on case management are performed bi-monthly to ensure adhearance to best practices. The process involves review of case files and case management notes and feedback to appropriate staff. Spot checks are conducted using real-time data on timeliness, completion rates, and other key performance indicators. Review and summary of quality assurance is overseen by the Program Director and Chief Operations Officer, and presented to the President/CEO to report to the board of directors.

Program impact is measured using a research-based pre/post test designed and tested by our national organization and used across the Big Brothers Big Sisters mentoring network.

The BBBSH Building Committee will provide oversight and direction for the property acquisition and prepare regular reports for the board of directors.

Dennis Brown, the retired president/CEO has taken on the role of CEO Emeritus at BBBSH. In this capacity, he focuses on the capital project and capital campaign initiatives in collaboration with the the president/CEO, board of directors, the building committee, and capital campaign committee.

BBBSH is an affiliate of Big Brothers Big Sisters of America which provides resources and an infrastructure based on nearly 150 years of nationwide experience and best practices.


