

God Forgives Bad Boys and Bad Girls

(2) The Public Purpose for the grant

The grant will be used for the purchase of transportation that will be used to provide for our youths, homeless feeding, neighborhood security watch program and for transporting men/women from homeless or incarceration to resources or clean and sober homes.

(3) The services to be supported by the grant

In addition to the purchase of transportation vehicles, service that would be conducted and not limited to a) community outreach and engagement, to individual referrals, case planning, b) continue to forming communities Neighborhood security watch i.e. from Ewa Beach, Waikele, Kapolei, Waianae Coast, Kalihi – with the transportation we can be able to go into other neighborhoods. C) weekly homeless feeding in hard areas where agency's cannot reach i.e. Pearl City, Pearl Harbor, water front homeless; Wahiawa in the deep mountains of acres of hidden homeless families; d) provide resources to inmates and assist in placements to the clean and sober home and after care programs; a special focus would be providing with opportunities that involve community partners also providing services at low-moderate locations.

(4) The Target Group

Our target population consist of disadvantage youth and adult male and female, who come from low-income backgrounds, with criminal activity, and are at very high risk from the Leeward Coast, Ewa Beach, Kalihi, working with HPD-D8. Criminal crime has shown a huge increase in these areas of violence, bullying and gun activity.

(5) The cost of the grant and budget

The total requested for the State Grant in Aid is \$206,050 in Operating.

Background and Summary

1. Brief description of GFBBBG's background:

God Forgives Bad Boys and Bad Girls (GFBBBG), - established in 2018 – provides support in communities in reducing crime by forming Neighborhood Security Watch teams in the low-high crime communities in assisting together with HPD D-8 Community Policing Team. Prayer and referrals to men and women to the right help and resources in leaving incarceration, recovering in substance abuse, and involved in the criminal justice system.

2. The goals and objectives related to the request

MISSION: is to assist churches, organizations, HPD CPT in communities with outreaches to unify communities. The effort is to develop working relationships in faith based to adult criminals, juveniles thus to reduce crime in our communities.

God Forgives Bad Boys and Bad Girls teams goes into the areas with a history of high levels of crime, drugs use gangs and severe economic struggles.

VISION: "Built a strong relationship in the communities to build mutual trust".

The organization name may be very unusual to many because using the word "God Forgives", which the faith based of many people whom we have worked with since 2018, has either been incarcerated, recover drug users, and in criminal activity. Now turning their lives into ministry, churches, and supported from pastors they can be able to know that God Forgives them and to be able to walk into a better life in our community. Many are still in clean and sober homes recovering from drugs or criminal activity and has turned their cycle in outreach giving back to the community.

Some members on the Board walked into their shoes and experienced addiction, incarceration, homeless, with alcohol or prescription drugs. Members have strong bonds with working with youths and adults in the low-moderate communities in getting them the resources and help.

With the high increase of crime in the low-moderate areas, members can relate by doing several sign holdings of bullying and gun violence in engaging with the community and encourage for safer communities. Families who have lost a family member of gun violence are engaged in our organization by attending many of our community neighborhood watch, speak at schools and community churches to bring the attention and awareness.

3. The public purpose and need to be served

It is in a generational note that most adult criminals began their criminal careers as young juveniles.

Many crimes cause economic and social costs for those that are victimized and the communities they live in work and play in. By developing a relationship with authorities and HPD to form community Neighborhood Security watch program, it can result in assisting and engaging neighbors and community to work closer in the reduce of crimes within their community. Some of the direct crime can cause cost lost of wages; medical and mental health care treatment costs for victim; huge property damage; funeral and burial costs affiliated to decease victim.

Our State has spent millions of dollars on prevention of crime and has been prosecuting criminals. The HPD also has struggled in fighting crime and been coming up with programs to engage with communities. The HPD cannot do this alone, and it must be a shared responsibility in network in geographical areas with a history of high levels of crime, drug use, and severe economic challenges.

Due to our strong trust relationship with the communities, we serve, we have shown success. We have increased our relationship with HPD D-8 in West Oahu in supporting enforcing the laws by teaming up with our neighborhood security watch teams.

The volunteers come from the seniors' adults, youths, churches, and other organizations to be able to affect change in communities!

- We listen to what the community is sharing to listen then work with the community to address those needs; the relationship needs to remain to adapt to the community.
- Through social and economic factors such as family's income, education and employment with safer communities plays a huge significant role in our youth along the Westside.
- We are currently building relationship with other communities to partner in after-school programs with Kuhio Park Terrace youths, Youth Challenge men. It is known that other areas such as Waipahu, Kalihi, Ewa Beach already have these programs in place during-school programs. Wai'anae Coast are building up in our neighborhood security citizen patrols and networking with elected officials, HPD to make our State a safer place to live.

4. Describe the target population to be served, and

The areas that God Forgives target are:

- 1) Wai'anae Coast
- 2) Wahiawa
- 3) Old Ewa Beach
- Kalihi

These above sites are targeted because their leaders and pastors are willing to step up to partner in recognizing the crime, drug activity and gang affiliation. We will serve the low moderate-income residents in the targeted communities in reaching out to the toughest populations including the homeless, seniors and youths. Many are our native Hawaiian people with many disadvantages of parents being incarcerated or not active in the household.

5. Describe the geographic coverage

The God Forgives organization has taken place in the areas of Ewa Beach, Maili communities, which is part of HPD District 9, City Council District 1 which is part of our Senate district 20 and Senate district 22. These communities are under HPD Community Policing Team (CPT), which we have developed a partnership in recruiting citizens to participate in community's citizen patrolling, feeding the homeless along the Wai'anae Coast and areas that are unseen to officials.

These areas are designated as high crime and unemployment rate where many are on the beach parks, beaches and nestled anywhere but not in our shelters. In these areas there are no public housing to offer but high affordable studios developed by the City and County of Honolulu which is still very high and costly to many families. For example, as the statistic will show that many of our families that reside homeless their children tend to become as well and will drop out of school.



They have touched the lives of many of our youth, kupunas and our houseless population in the following ways:

A. Coordinating large scale community awareness events:

Rise and Shine - a free youth event at Nanakuli Beach Park which featured the testimonies of many well known positive role models, local bands, free food and clothing, gifts for the youth and prayer for anyone desiring help from God.

Back to School Event at the Waianae Boat Harbor - a free community event featuring the same services as above.

- B. Planning and implementing sign waving and Neighborhood Security Walks with our local community and police department (these walks have really made a huge difference in reducing crime and bringing community awareness in response to recent violence).
- C. Numerous outreaches to the marginalized houseless population living on our coast offering a touch of love, prayers, warm meals, clothing and directing them to services available.
- D. Working daily with many of our local pastors to bring encouragement and hope to their congregations through phone calls, hospital visits, and social media.

The above mentioned are just some of the things God Forgives Bad Boys and Bad Girls has done in our Waianae Coast community but they have also done the same in many other communities such as Ewa Beach, Waipahu, Kalihi, Wahiawa and even outer islands.
