II. Background and Summary

1. A brief description of the applicant's background;

Hawaiian Humane Society was established in 1883 and have been serving Oahu's animals and people for 140 years. The organization is Oahu's largest animal welfare organization that shelters, protects, rescues, reunites and rehomes animals. The organization's mission is to promote the human-animal bond and the humane treatment of all animals. Throughout its long history, Hawaiian Humane has been dedicated to creating a more compassionate community for animals and people on Oahu.

The organization welcomes all pet animals in need regardless of age, breed, species or condition, and provides services for more than 30,000 animals annually and thousands more in communities across O'ahu through field service programs and community outreach. In May 2023 we opened a second campus in West O'ahu to improve access for communities West of Honolulu's urban core and provide previously underserved groups with our full range of lifesaving services.

As the official pet lost and found for the island of O'ahu and a safe haven for all pet animals, our organization experienced 12,524 animals coming into our two shelters from July 2022 to June 2023 and conducted 31,721 animal health examinations. The organization spayed and neutered 15,584 animals, fostered 3,684 pets, created new families through adoption for 7,227 pets and reunified 1,860 pets with their families. Through the outreach program, the organization served 244 people and 11,264 animals and distributed 52,396 pounds of pet food to struggling pet owners. Our Pet Visitation program experienced a boom, with 188 visits and an increase of 129.3%. A total of 3,998 people were served by the Pet Visitation Program, an increase of 191.4%. The organization experienced a continued demand for our educational programs and the number of programs increased by 22.7%. In fiscal year 2023, our field services team prioritized education in working with the public to address animal welfare issues which helped to foster a more informed and responsible community. This strategy reduced animal-related issues, enhanced public safety and ultimately improved the overall wellbeing of animals in our community.

2. The goals and objectives related to the request;

It is vital that animal facilities prepare for disasters, both to protect the animals housed there, the people caring for the animals, and to safeguard the facility.

Goals and Objectives

Goal 1: To install hurricane screens to mitigate damages to the facility

Objective 1: To make the shelter hurricane-safe by eliminating or minimizing the impact of disasters caused by hurricanes, strong winds or storms.

Goal 2: To protect animals housed at the facility from injuries

Objective 2: To create a safe space to house animals already in our care as well as the ones in the community that will need safehousing.

3. The public purpose and need to be served;

With continued high shelter populations due to increased animal intake and longer stays Hawaiian Humane and shelters across the state are vulnerable to emergent events like natural disasters. The recent Maui wildfire tragedy resulted in a flood of lost and injured animals in need, and highlighted the importance of disaster planning for facilities that house animals.

As the official pet lost and found for the island of O'ahu and the largest animal care facility in the community, many will look to Hawaiian Humane Society for care for animals in and out of our shelter. The organization will play a key role in the safehousing of animals during a disaster. Hawaiian Humane Society is committed to the safety and well-being of animals on O'ahu. Aligned with this commitment, a major part of our disaster planning includes disaster preparedness.

Windstorms, which include hurricanes, make up 22 percent of all disasters and are the deadliest type of disaster after floods. According to a hurricane risk assessment report published by Geore Pararas-Carayannis, hurricanes present the greatest risk for the Hawaiian islands with serious impacts on public health and safety. The report indicates that while O'ahu has never had a direct hit by a hurricane, the potential risk of a tropical storm or hurricane cannot be ignored. O'ahu and other Hawaiian islands are potentially vulnerable to hurricane and hurrican storm surge flooding. Strong hurricane winds and surges have the potential to disastously impact O'ahu and result in extensive destruction on the island.

Hawaiian Humane has embraced animal welfare best practices for shelter design, which maximize natural light and ventilation to improve animal health and wellbeing, and minimize the spread of disease. These designs do, however, make our facilities vulnerable to inclement weather. As such, a key priority for Hawaiian Humane Society is to set up our facility to mitigate windstorm damage. The organization aims to install hurricane screens, a common commercial storm damage mitigation barrier that will keep debris and rain propelled by strong hurricane-force winds out of the shelter. The hurricane screens will help the shelter withstand the strong winds and storms, and allow for the preservation of the benefits of this design, while allowing animals and people to be kept safe in the event of powerful storms.

4. Describe the target population to be served; and

The island community will look to Hawaiian Humane Society to provide care for animals in and out of our shelters in the event of a disaster. The target population that will be served by the hurricane screen project will be all animals already in our care and animals that will be lost and injured as a result of the disaster and will need safehousing.

5. Describe the geographic coverage.

Hawaiian Humane Society plans to install the hurricane screens at the Mōʻili'ili campus in Honolulu and at the Kosasa Family Campus in Ewa Beach as a safety measure to minimize windstorm damage to the shelter, protecting people and animals. The

Honolulu shelter will present a hurricane safe place for animals in the Honolulu and surrounding area, as well as animals island wide if able to get to the shelter.

III. Service Summary and Outcomes

Hurricanes and windstorms pose a major threat to Oahu. If a hurricane should make landfall on the island or pass closeby, it could have devastating effects for the entire island. Setting up our shelter for windstorm prevention will help mitigate damages to the facility and keep animals and people safe.

Installing hurricane screens will help the shelter withstand strong winds and storms by mitigating severe damage and protecting the animals housed in the shelter in the event of a major storm. Fitting the shelter with hurricane screens will reduce property damage and prevent costly repairs. Mitigating shelter damage will prevent possible injuries to animals and people, and provide a safer environment for the animals in our care.

Hurricane screens are a common commercial storm damage mitigation barrier frequently used. This hurricane fabric is a piece of trampoline-like material that will help protect the shelter from flying debris and rain propelled by strong, hurricane-force winds. These large pieces of mesh fabric are much stronger than standard door and window screens. The hurricane screens can be stretched over glass doors and windows, as well as other openings, such as carport entrances and porches.

Hawaiian Humane Society will employ the services of a contractor for the manufacture/construction and install of the hurricane screens.

The installation of the hurricane screens is projected to be completed during the course of fiscal year 2025. Hawaiian Humane Society will track project progress to keep on schedule and budget.

To ensure the project is completed on time and within budget, the project timeline will be managed by our facilities and operations leadership team. Additionally, the Hawaiian Humane Society will hire a local contractor to provide and manage the installation of the hurricane screens.

Hawaiian Humane Society has been O'ahu's leader in animal welfare issues since our establishment in 1883. The organization's programs and services have received national recognition and have been replicated by other humane organizations across the country. The organization partnered with American Humane and Honolulu Department of Emergency Management to host a 2-day training on "Animal Disaster Response" from August 4 to August 5, 2023, a 4-hour virtual training on "Introduction to a Coordinated Response for Animals Impacted by Disasters" on November 2nd, 2023, and a 3 day in person training on "Basic Animal Emergency Response and Disaster Animal Sheltering" from November 29 to December 1, 2023.

2. Facilities

Hawaiian Humane moved to the Mō'ili'ili campus in 1942, expanding the facility over the years with the construction of our admissions, shelter veterinary services and animal holding building, dog adoption houses and cat house in 2016. These buildings were designed to improve the overall experience for people who visit, while optimizing behavioral, psychological and socializations of animals in our care. Many of these buildings are open air enclosures and susceptible to damage from inclement weather. In 2018, we opened the Ginny Tiu Community Spay/Neuter Center, a specialized high quality, high- volume spay/neuter clinic that increases the availability of affordable cat and dog spay/neuter services for our community.

Our recent expansion includes construction and opening of a second campus in West O'ahu to make a greater impact on animal overpopulation on O'ahu and improve access to services for underserved communities west of Honolulu's urban core. The West O'ahu campus includes a 20,745-sf two story building, an adoptions lanai with six adoption pavilions for dogs, cats, and small animals and a spacious off-leash community dog park. The new campus features a new generation shelter, providing a safe space for animals, veterinary care, spay/neuter services, adoptions, foster care, education and volunteer opportunities for the community.

Anna Neubauer has been President & CEO of the Hawaiian Humane Society since October of 2019 and leads a dedicated team of more than 100 staff and more than 1,000 volunteers in caring for O'ahu's animals in need. Prior to joining Hawaiian Humane Society, Neubauer served as vice president of operations at the Dumb Friends League of Denver, Colorado, an open-admissions shelter regarded as one of the country's most progressive and best-run animal shelters. Before joining the Dumb Friends League, Neubauer was a co-founder and clinic director of the Fort Collins Cat Rescue & Spay/Neuter Clinic in Fort Collins, Colorado. Neubauer has her MPA degree and is a certified veterinary technician, a certified animal welfare administrator, and was an instructor in Shelter Leadership at Colorado State University from 2016-2019.
