1. A brief description of the applicant's background;

Founded in 1992, Healthy Mothers Healthy Babies Coalition of Hawaii (HMHB) is a statewide nonprofit dedicated to improving maternal, child, and family health through collaborative efforts in public education, advocacy, and partner development. Celebrating our 32nd anniversary this year, HMHB has evolved into a creative organization dedicated to ensuring equitable access to health for pregnant and parenting families, as well as individuals of reproductive age, through the integration of social, behavioral health, and clinical care. We provide education, outreach, and

wrap-around services through the following programs: Mana Mama Clinical Care, Mana Mama Mental Health, Hawaii Cribs for Kids, Piko Pals new parent support group, Community-Based Doula Program, and Māna 'ai Food Distribution.

We are currently in a stage of rapid growth. While we are over three decades old, our programs and services have expanded under the leadership of our current staff, who have shifted away from the status quo. We championed adding clinical services in 2020 during the height of the pandemic. This innovation sparked initiatives including launching three mobile clinics and two new offices, opening a 24/7 telehealth line, conducting home visits to ensure the most vulnerable members of our community receive care, and providing reproductive health care in homeless shelters and even on the street. Most recently, in response to the recent Maui wildfires, our team quickly deployed to ensure the needs of pregnant and postpartum women are not overlooked in disaster relief and recovery.

2. The goals and objectives related to the request:

The overarching goal of this proposal is to increase HMHB's capacity to meet the growing needs for health screenings and vaccinations for Hawaii's most vulnerable residents (uninsured, underinsured, and low-income individuals of reproductive age). HMHB is seeking \$241,080 to improve health outcomes on Oahu, Maui, and Hawaii Island through community-based initiatives such as mobile clinics and home visits. Our activities include health screenings (physical exams, blood draws, COVID-19, TB screening) and vaccinations (COVID-19, flu, HepB, RV, Hib, MMR, and other CDC-recommended vaccines). To achieve these objectives, HMHB is requesting funding to purchase a vaccine storage and management system along with software. This system is designed to ensure the safe storage of vaccines with guaranteed temperature control, reduce waste and loss, standardize and streamline workflows for staff efficiency, automate compliance, and enhance safety by ensuring accurate dosages to each client.

Funding is also requested to support the hiring of new staff, specifically a Data Manager and Operations Director, essential for enhancing HMHB's capacity. Although vital for the organization's mission and growth, securing funding for these roles is challenging through alternative revenue streams due to their classification as administrative support, which is often restricted by many grants.

3. The public purpose and need to be served;

Routine vaccinations and health screenings are vital for safeguarding community health. Yet, we have experienced a significant increase in the percentage of children with incomplete immunizations in Hawaii schools. According to data from the Hawaii Department of Health, the rate of students with incomplete immunizations skyrocketed from 7.63% in the 2021-2022 school year to a staggering 18.70% in the 2022-2023 school year—a 145% increase within a single academic year. This concerning surge can be attributed to various factors, including concerns about in-person doctor visits

during the pandemic, the suspension of vaccine reporting requirements during virtual learning, a lack of follow-up from school officials, new vaccine requirements, difficulty scheduling appointments, transportation concerns, and the proliferation of misinformation about immunizations.

This alarming trend poses a serious threat to the community as it puts students at risk of absenteeism and increases the potential for the spread of communicable diseases within classrooms. Essential vaccinations are critical for preventing disease outbreaks. The Centers for Disease Control and Prevention recommends children receive one dose of the Measles, Mumps, and Rubella (MMR) vaccine at 12-15 months of age, with a second dose at 4-6 years of age. Healthy People 2030 has set a target of 90.8% of children aged 2 years having received at least one dose of the MMR vaccine. However, across Hawaii, only 83.6% of children have met this target (Hawaii Department of Health, 2019).

Addressing this critical gap in vaccination coverage, HMHB has taken proactive measures to make accessing vaccines convenient and accessible. Operating a mobile clinic that visits the homes of families and hosts vaccine drives at community events, HMHB aims to encourage families to receive vaccinations in easily accessible locations. Additionally, HMHB provides physical exams for children and parents who may struggle to schedule routine visits with their primary care physicians.

4. Describe the target population to be served; and

While HMHB serves all families across the state, our emphasis is on ensuring reliable access to health and social services for uninsured, underinsured, and low-income individuals of reproductive age and their families in underserved and marginalized areas. We particularly reach out to socially high-risk and medically low-risk individuals. Our programs directly address structural and systemic factors that contribute to health inequities for moms and babies. During the previous year, a significant majority of HMHB's clients, three out of every four, faced financial constraints, with household incomes below \$75,000. Most, 83% of clients, identified as Black, Indigenous, and people of color, with nearly half identifying as Native Hawaiian.

5. Describe the geographic coverage.

HMHB serves families across Hawaii, ensuring access to care statewide through telehealth services. Our physical presence includes offices on the island of Oahu, Hawaii Island, and an emerging office on Maui. Additionally, we operate mobile clinics across Oahu, Hawaii Island, and Maui.

III. Service Summary and Outcomes

Collaborating with community health centers, social service agencies, and health plans, HMHB actively addresses gaps in care for underserved populations, particularly those with transportation challenges and incomes below the federal poverty level. Committed to comprehensive family care, the grant aims to facilitate vaccinations and health screenings through in-home visits and community events. To enhance efficiency in meeting vaccination demands, HMHB seeks funds for a vaccine storage and management system, addressing challenges like waste and inventory management. In the past, HMHB has experienced losses in critical vaccine supplies due to user error and power outages. This new system has a battery back-up in place and automatically tracks vaccinations by location, funding source, and expiration date, streamlining staff workflows to allocate more time to client interactions.

The grant will support the administration of over 1,000 life-saving vaccines, in-home and community health screenings for 100 individuals, and the dissemination of health education through community events.

The balance of HMHB's unrestricted current assets as of December 31, 2023 is \$1,320,000, with \$1,117,000 earmarked for mid- to long-term Maui recovery.

V. Experience and Capability

1. Necessary Skills and Experience

HMHB is Hawaii's only nonprofit organization dedicated exclusively to supporting the physical, social, and behavioral health needs of perinatal people and their families. We are a known leader for facilitating community maternal and child health workshops as well as the provision of social service and resource referrals. We have evolved to provide direct clinical and mental health care in addition to supportive services. Our highly-skilled team has quickly grown our services to meet the unique needs of the community. Our team consists of a Family Nurse Practitioner, Licensed Certified Professional Midwives, International Board Certified Lactation Consultants (IBCLC), Licensed Mental Health Therapist, community doulas, case managers, and support staff who specialize in culturally competent engagement. We envision a future where Hawaii is a leader in maternal and child health outcomes, where our hapai people and keiki thrive!

Over the past year, HMHB helped nearly 4,000 community members through our programs and services. The following data demonstrates HMHB's impact:

- Hawaii Cribs of Kids launched in 2013, 92% of participants continue safe sleeping practices after completion of the program
- Piko Pals new parent support group launched in 2017 and has provided over 277 participants with social, emotional, and educational support
- The Community-Based Doula Program has resulted in 0% preterm births among participants and 100% of participants receiving mental health screening as well as 100% initiating breastfeeding. 93% of program participants identify as BIPOC
- Nearly 200 home visits (blood draws, physical exams, vaccinations, prenatal visits, postpartum visits, lactation consulting, and mental health therapy) were completed last year
- Over 2,000 COVID-19 vaccine doses have been administered since July 2021 for individuals 6 months and older
- 40,000 meals and provisions have been delivered to pregnant and new moms

The organization is led and staffed by women and mothers of color who are culturally anchored. Our Executive Director is an ambitious, results-oriented healthcare leader

who holds a Master of Business Administration, is a Registered Nurse, a Certified Lactation Consultant, and is an Army Veteran. HMHB staff ensure that all applicable licensing and operating requirements as well as generally accepted quality standards are integrated into its policies and procedures. We have extensive experience managing foundation and government contracts. HMHB has received national recognition for its work from organizations such as MIT SOLVE, Direct Relief, and the Institute for Medicaid Innovation.

Our organization is rooted in the following values:

- A child's right to be born healthy and raised in a safe nurturing environment
- Equal access to quality care
- A collective voice to facilitate change
- Eliminating health disparities among all populations
- Cultural competence and respect for diversity
- Education to encourage health choice

2. Facilities

On Oahu:

HMHB leases two office spaces within the Kukui Center (located at 245 N. Kukui St. Suite 102A & 203 Honolulu, HI 96817) with a combined square footage of 2,855 sq feet which accommodates staff offices, food pantry with hot and cold meal storage, lounge/children's playroom, conference rooms for classes/group counseling sessions, client meetings, private offices for individual therapy sessions, medication/supply closet to restock our mobile clinic, and storage for approximately 200 cribs, diapers and breastfeeding/perinatal supplies and donations.

Our mobile clinic is a 2017 Ford Transit extra long, extra tall vehicle that is completely retrofitted as a clinic on wheels, providing home visits and can go directly to the client anywhere on the island of Oahu if visits cannot be done via telehealth or in the office downtown. The mobile clinic is air-conditioned and powered with two 175-watt solar panels on the roof that stores power within three 100-amp hour lithium-ion batteries, with a 3000-watt inverter and battery isolator that charges the car while driving to provide off-grid power. The clinic features two separate client areas separated by a door, a dry flush toilet for urine specimens, a hand washing station with a 7-gallon tank for running water, a vaccine refrigerator, ultrasound capabilities, an infant scale, CPR/AED machine, and all other necessary clinic supplies.

On Hawaii Island:

HMHB leases a 700 sq footage office space in Kailua-Kona for staff offices, client meetings, and storage. We have also retrofitted a 2022 Mercedes-Benz Sprinter for our

Hawaii Island mobile clinic. This new van is solar and battery powered and includes educational materials, a patient bed, handwashing station, toilet, vaccine refrigerator, and capabilities for fetal monitoring and ultrasounds. The clinic on wheels is equipped with 4-wheel drive, a shower, and other technological capabilities, allowing staff to traverse the rugged terrain on Hawaii Island. The van can accommodate at least two patients simultaneously and enables staff to conduct various services, including prenatal and postpartum visits, well-mom exams, reproductive health screenings, infant checks, vaccination administration, and more.

On Maui:

On Maui, we operate from an 800 sq ft office space at the Cameron Center, serving as staff offices, client meeting space, and storage. Additionally, we have a 2021 Mercedes-Benz Sprinter for our Maui mobile clinic and are in the process of acquiring an additional fully electric mobile clinic. Both vans will be retrofitted to match the design and functionality of the Oahu and Hawaii Island vans.

Our mobile clinics are versatile and can be transported to other islands as needed to address emerging needs and expand our reach.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

HMHB has twelve full-time, and one part-time staff member, with plans to hire four additional staff in 2024. We are supported by contracted mental health providers, doulas, nurses, a community health worker, an Organizational Development consultant, eight involved board members, and a corps of volunteers (120+ engaged annually) who carry out the mission of the organization. HMHB's volunteer Board of Directors governs and sets policies, and takes responsibility for strategic planning for the organization. The BOD supervises the Executive Director and ensures the long-term sustainability of the organization.

The Executive Director administers the agency and its services with the direction, policies, and long-range plans of the Board of Directors of HMHB. She serves as chief executive and planning officer for information on internal organizational issues and changing community needs.

The Data Manager (written in this request) will play a crucial role in managing, maintaining, and reporting on our client data using the agency's data tracking database. As such, they will have primary responsibility for the collection of client data, analyzing

outcome data, and interpreting that data to enhance the quality of services HMHB provides. The Data Manager will work closely with program staff to ensure accurate and timely data entry, analysis, and reporting to support our mission of promoting maternal, child, and family health.

The Operations Director (written in this request) will support day-to-day operations of the organization, including oversight of programs, financial management, communications, and ensuring the agency is in compliance with all grant and contract requirements.

The staff and board of HMHB reflect the incredible diversity of Hawaii in race, ethnicity, and professional experience. Our strategy for sustaining and expanding activities involves building on existing partnerships, forging new alliances, and cultivating trust within the community. As a credentialed provider with Hawaii's major insurance payors, such as AlohaCare, Med-QUEST, HMSA, HMAA, UHC, UHA, Ohana, and Medicare, we can bill directly for certain clinical encounters, generating ongoing revenue.

While insurance reimbursements cover some clinical encounters, many essential programs, like keiki vaccinations and home visits, remain underfunded. To bridge the gap to ensure every member of our community can access care, HMHB actively engages in fundraising efforts targeting individual donors and private foundations. Over time, we've seen a progressive increase in funding, with an 18% growth from FY21 to

FY22, a 53% increase from FY22 to FY23, and an anticipated additional 48% increase from FY23 to FY24. We are committed to the long-term viability and growth of our programs, ensuring that HMHB continues to serve and positively impact our community.


