

Hina's Legacy Rescue Foundation will provide relief for communities grappling with an increasing number of abandoned animals and an epidemic of horrific, violent animal cruelty incidents.

Hina's Legacy Rescue Foundation, a 501(3)(c) organization, was founded on May 2, 2023, by Chantell and Cassie Moniz. This grassroots organization is dedicated to ending animal cruelty and rescuing, rehabilitating, fostering and rehoming animals in need on O'ahu. Our mission is to advocate for stronger animal cruelty laws and stricter enforcement of those laws to make O'ahu a place where all animals are treated with compassion, respect, and empathy.

- 2. The goals and objectives related to the request;
- Goal #1 Retain legal and/or professional assistance to review and strengthen existing legislation on animal cruelty.
 - Objective #1 Identify areas in current animal protection laws that can be refined to provide more protection for animals.
 - Objective #2 Introduce new resolutions and/or amendments that will enhance penalties for perpetrators of animal abuse, ensuring that the consequences are commensurate with the severity of the offense.
- Goal #2 Leverage the expertise of government officials, law enforcement, animal welfare organizations and other stakeholders to come up with more effective enforcement of animal cruelty laws.
 - Objective #1 Facilitate early intervention of suspected cases of animal abuse to help safeguard the welfare of the animals.
 - Objective #2 Secure additional resources and funding for more animal cruelty investigators, ideally creating a task force dedicated to animal related cases. This includes investing in training programs to ensure that law enforcement officers are well-equipped to handle cases of animal cruelty.
- Goal #3 Expand and increase the campaign against animal cruelty through demonstrations, educational workshops and advocacy.
 - Objective #1 Increase awareness about animal cruelty issues so community members can make compassionate, informed decisions and sustain a strong, lasting stand against animal cruelty.
 - Objective #2 Amplify community efforts in combatting animal cruelty by providing education on reporting animal abuse, the signs of cruelty, and legal actions that can be pursued. An informed and vigilant community plays a crucial role in preventing and addressing animal abuse.
- Goal #4 Create "safe spaces" network to provide temporary, emergency care for animals in need due to abuse, neglect and/or abandonment.

- Objective #1 Remove victimized animals promptly so further harm is prevented, and critical care is provided.
- Objective #2 Prepare, train and provide tools to caregivers for animal rehabilitation and socialization to enable successful adoption.

3. The public purpose and need to be served;

Hina's Legacy Rescue Foundation serves the needs of all abused, neglected and abandoned animals. Hina's Legacy has a mission to advocate compassion for those who cannot speak for or defend themselves. Our message of kindness, compassion and caring for one another transcends all species. O`ahu's communities are plagued with increasing violent crimes, and research has established a link between animal cruelty and human violence. Hina's Legacy aims to end not just cruelty to animals, but also to restore community values of kindness, mālama, respect and integrity. These values are crucial in promoting the humane treatment of all animals and in fostering safer communities.

4. Describe the target population to be served;

Hina's Legacy Rescue Foundation targets animals in need because of cruelty, neglect or abandonment. Education and outreach will be disseminated across all communities, with emphasis in critical neighborhoods, e.g., Leeward areas, where many recent, violent incidents have occurred. Through our anti-animal cruelty campaigning we will serve as positive role models for youth in our communities, demonstrating and embodying positive values and behaviors related to compassion and empathy.

5. Describe the geographic coverage.

Animals from across O`ahu are aided, assisted and/or rescued by Hina's Legacy with emphasis in Leeward areas.

II. Service Summary and Outcomes

Making a greater impact in reducing animal cruelty requires alliances with legislators, policymakers, law enforcement officials and other animal welfare organizations. Grant-in-aid funds will allow Hina's Legacy to retain legal and professional assistance to propose and garner support for a legal framework and animal-friendly legislation that deters cruelty and holds offenders accountable.

The scope of our work is to engage with community members through education, training and outreach to raise awareness about animal welfare and the consequences of cruelty. With community involvement we can facilitate initiatives focused on prevention and intervention and establish a reliable network in each neighborhood that communicates their animal welfare concerns and participates in collective solutions. Grant-in-aid funds will allow for more immediate action in rescuing animals in need and provide for their, sometimes, extensive medical recovery.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

Hina's Legacy anticipates retaining suitable legal and/or professional assistance within the first quarter of the funding period, allowing for drafting legislation, resolutions or ordinances in the remaining quarters. All initiatives are targeted for introduction in the 2025 Legislative Session. All other objectives and activities will be accomplished within the one-year funding period.

3. Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results; and

Hina's Legacy Rescue Foundation holds regular Board meetings and will submit updates and progress reports of activities and outcomes at each meeting. All Legislative initiatives and related activities will be documented and updated on Hina's Legacy's website so community members can stay informed and voice their comments and concerns. Hina's Legacy has a network of volunteers with diverse backgrounds facilitating the organization's success, namely Veterinary Technicians with over 20 years of experience, certified Obedience trainers and Animal Behaviorists with 15 years of experience and caregivers who have been lifelong pet owners. Hina's Legacy has been participating in neighborhood and community groups for the past 3 years and has been cultivating relationships with many board members and city council members. Our organization has grown in public presence in the latter half of 2023, with more news media coverage of our anti-cruelty rallies and more support from city and state representatives.

2. Facilities

Hina's Legacy Rescue Foundation currently has 12 kennels in multiple locations to provide temporary shelter for rescued animals. Hina's Legacy in collaboration with other animal welfare organizations is currently providing another 12 foster homes for temporary care and rehabilitation. Through our outreach and training initiatives we are anticipating our foster care capacity to double in 2024.

The foundation's leaders, Chantell and Cassie Moniz, continue to be faces in the community giving residents a resource when animal welfare needs arise. They are contacted daily, as Hina's Legacy Rescue Foundation has been able to successfully rescue and provide safety for many animals on the Leeward coast. Through community engagement, volunteer recruitment and legislative support, Hina's Legacy will undoubtedly make an even greater impact in the community, maximizing the number of animals rescued, reducing animal cruelty and contributing to overall crime prevention efforts.

Should Grant-in-Aid funding be received in fiscal year 2024 we will be able to achieve the goals and objectives set forth above. This funding will be critical for Hina's Legacy to initiate change at the legal and law enforcement levels. This grant will demonstrate that communities can "take back" their neighborhoods by reducing tragic, violent offenses and restoring kindness, compassion and caring for all, especially animals. Grant-in-Aid funds will allow Hina's Legacy to build a larger volunteer base, leading to more animals being rescued.

If Hina's Legacy Rescue Foundation does not receive additional funding after fiscal year 2024 we believe we will have already started the legal and legislative initiatives and gained valuable experience and knowledge with this process to keep moving forward. Success with fundraising strategies should allow us to

sustain our initiatives and continue to rally for change and support. No additional funding, however, may decrease the number of animals we may be able to rescue.
