Lack of basic nutrition breeds deterioration in life and therefore succumbing to illness and dependency.
- Describe the target population to be served; The target population consists of Medically frail and in need as referred by Medical providers, children, homeless, elderly in congregate dining and in Food Security programs and others in need of nutrition.

KEO's experiences have included direct human services, construction, property management and many other services.

In the most recent three years, KEO has provided Housing and Homeless Services in direct specific needs along with providing shelter and housing accommodations; Meals delivery to Medically referred, Elderly Nutrition, Elderly Food Security, Pre School Programs and participants, Elderly Day Care and Health Center, private clientele: Energy and Weatherization Services to eligible individuals and families; Mediation Services for the Fifth Circuit and the community at large; Persons in Need Services towards various needs; COVID 19 Education and Mitigation Services; among others.

Although starting January 01, 2024 we will continue to provide the meals delivery to all mentioned in the paragraph above except the Elderly Nutrition Home Delivered meals due to KEO's shortage of staff, we continue to serve all of the others preparing and delivering approximately 3000 meals per week calculating to approximately 156,000 meals per year.

Beyond these human services, KEO has acquired property, executed construction projects, managed those projects, including property management, acquired equipment for all projects, including vehicles over the 57 years in operation.
