#### (2) The public purpose for the grant:

Malama Pa'akea o Waimalu (MPOW) was created as a nonprofit organization in 2023 after thirty years of private management. The Pa'akea fishpond is located in Aiea and was formerly owned by the Healani Land Company, who maintained the site and the adjacent property. The public purpose of this Grant-in-Aid request is to restore the Pa'akea fishpond and adjacent garden area to become a Hawaiian cultural land-based learning site and a center for community engagement.

Over the past five years, Healani's CEO Stacy Philippou has dedicated financial resources to preparing the Pa'akea property to function as a nonprofit organization for the purpose of education and community engagement. This includes the contribution of two staff to focus on developing plans and implementing property improvements; much of the work has been done in concert with the Hui Malama Loko I'a. The public intention of the Pa'akea project is to be an accessible cultural site for the community that provides hands-on cultural and restoration activities grounded in traditional Hawaiian fishpond stewardship. In FY 24-25, MPOW envisions the fishpond as an ideal site to engage youth and community through educational programs, volunteer opportunities, and public gatherings.

With this grant funding, MPOW will work with government and Hawaiian fishpond experts and cultural advisors to develop long-term conservation and land use strategies. MPOW will engage with the local community to determine needs, opportunities, and concerns regarding public access to the site.

#### (3) The services to be supported by the grant:

- **1. Documentation:** MPOW will document the fishpond's historic significance and any historical events associated with it. Build public content that will be used in a website and/or social media postings. This will be done with curators from the Bishop Museum and University of Hawaii library research.

#### II. Background and Summary

#### 1. A brief description of the applicant's background:

Malama Pa'akea o Waimalu (MPOW), meaning in the Hawaiian language to care for Pa'akea [fish pond] of Waimalu, oversees an historic Hawaiian fishpond at the back of an eight-acre property in Aiea, located on the island of Oʻahu in Hawaii. The fishpond lies across from Pearl Harbor and was among the fishponds and loʻi kalo growth areas that once fed the ahupua'a of Waimalu. Acquired by Howard K.O. Chong Jr. for Healani Land Company in 1990, the fishpond is part of a commercial parcel. For more than 30 years, the Chong family has cared for the fishpond by securing its perimeter, reducing the growth of invasive mangrove trees, and protecting the land adjacent to the pond.

Pa'akea fishpond is in the Waimalu ahupua'a and is an important historic site linked to the water resources along the bay at Pearl Harbor. Waimalu, translated as "sheltered water," takes its name from the main stream of the ahupua'a, with its tributary of Punanani that once watered the kalo growing in the lowlands near the bay. Waimalu's loko i'a (fishpond), known as Loko Pa'akea (literally "coral bed, limestone"), was said to have been built by Kalaimanuia, a famous chiefess of O'ahu. The mo'olelo of Waimalu include references to Pu'uloa and the major figures found there including various mano (sharks), Ka'ahupahau (a famous manō) and Ka'ehuikimanoopu'uloa (Hawai'i Island mano who visits Pu'uloa), mo'o (supernatural water spirits), the gods Kone and Kanaloa, the ali'i Kūali'i, Maihea (a farmer) and his sons, and various bodies of water.

The dream of MPOW comes from the vision of founder Stacy Philippou. As the only child of Howard Chong Jr. she took over Healani Land Company in 2019. Philippou, who's ancestry is part Hawaiian, is seeking to restore the fishpond and its waterfront with the intention of making it an accessible learning site to perpetuate Hawaiian culture and land stewardship.

Raised in Hawaii, Philippou is a graduate of Punahou School with a Master's in Business Administration. She has worked at Healani Land Company for 11 years, becoming its President and CEO in 2019. Philippou is a member of the Hui Malama Loko I'a and of the Council for Native Hawaiian Advancement. She is working to make MPOW a Native Hawaiian Organization. The team also includes a Business Manager, trained in bookkeeping and as a teacher; the third staff member is an Operations and Facilities assistant who works with volunteers. We plan to add a student intern.

#### 2. The goals and objectives related to the request:

<u>Goal:</u> To preserve, protect, and make the Pa'akea fishpond and adjacent garden accessible to the community for the purpose of providing Hawaiian cultural education.

Researchers estimate that prior to western contact there were 488 fishponds in Hawaii. A 1901 inventory identified 99 active fishponds remaining with an estimated annual production of about 486,000 pounds of 'ama'ama and 194,000 pounds of awa. Pearl Harbor was once a center of fishpond cultivation, with over 20 fishponds lining the shore. The largest fishpond covered more than 200 acres. By the early 1900s, developers had infilled most fishponds for sugarcane cultivation and military use. 'Aiea's waterfront was covered by highways, homes, and

commercial construction. Few fishponds in the area remain relatively intact. The Ali'i Pauahi Hawaiian Civic Club and the 'Aiea Community Association are working to support the restoration of Loko Pa'aiau, a fishpond located on 'Aiea land leased for Navy housing.

Pa'akea lies opposite to Loki Pa'aiau in Pearl Harbor. Prior to the land purchase by Healani, the site was the home of Primo Brewery. Primo structures have existed there since at least 1969. In 1990 Healani took over the commercial buildings and upgraded the old Primo Garden adjacent to the fishpond. The site included a hale, a stage, and a gazebo with other ancillary buildings. An historic rock wall borders the fishpond, but in the 1960s, this was capped with a concrete sidewalk. Besides staff and brewery clientele the fishpond has not been accessible to the public.

The aim of MPOW is to restore the Pa'akea fishpond and adjacent garden area to become a Hawaii Department of Education (DOE) 'aina-based learning site through the Na Hopena A'o School and Community Partnerships. This form of experiential education is grounded in teaching that encompasses the land, ocean, air, and all living things. Students deepen their relationship with the natural environment, cultivate community connections, and build critical skills. MPOW envisions the fishpond as an ideal site to engage youth and community through educational programs, volunteer opportunities, and public gatherings.

#### Objectives:

#### a. To complete a site assessment and establish a conservation plan.

The site assessment complements a decades-old environmental assessment (1990s) to assess the current ecological and physical state of Pa'akea and its surrounding shoreline. MPOW will work with Hawaiian fishpond experts and cultural advisors to identify strategies and practices that are appropriate for this site and use as an educational facility.

b. To address and ensure legal and regulatory compliance such as permitting needed to launch canoes from the site and/or use the site for cultivation of fish or shellfish species.

This will involve consultation with Hawaii Department of Land and Natural Resources (DLNR), the US Navy, NOAA, and the City & County of Honolulu to obtain necessary permits and approvals.

#### c. To engage the local community in planning.

Create and implement a plan to convene community stakeholders to address issues of access, signage, safety, and public use of the site going forward. Malama Pa'akea o Waimalu is and will collaborate with various organizations as it works toward becoming a Hawaiian learning site for the community.

MPOW is a member of KUA's (Kanaka 'Oiwi Unity and Advocacy) Hui Mālama Loko l'a and a member of the Council for Native Hawaiian Advancement (CNHA). We have worked with curators at the Bishop Museum to gather photographs and other historic information about the Pa'akea site. MPOW is partnering with Kalihi Kai Canoe Club to learn about traditional cultural values associated with the canoe and ocean, and we anticipate incorporating canoe activities into our educational programs.

#### d. To establish an education plan with curricula.

Work with Hawaiian cultural advisors, fishpond, and garden experts to ensure we understand indigenous best practices for site management and develop an educational curriculum based

upon these practices. The goal will be to align with the Office of Hawaiian Education's Na Hopena A'o School and Community Partnerships.

#### 3. The public purpose and need to be served:

MPOW was created as a nonprofit organization in 2023 after thirty years of private management of the fishpond and its surrounds. The Pa'akea fishpond was formerly the property of the Healani Land Company, who maintained the site and the adjacent property since 1990. The site has not been accessible to the public for many decades, having previously been the property of Primo Brewery (since at least 1963). The public purpose of this Grant-in-Aid request is to restore the Pa'akea fishpond and adjacent garden area to become a Hawaiian cultural land-based learning site and a center for community engagement.

Over the past five years, Healani's CEO Stacy Philippou has dedicated financial resources to preparing the Pa'akea property to function as a nonprofit organization for the purpose of education and community engagement. This includes the contribution of two staff to focus on developing plans and implementing property improvements; much of the work has been done in concert with the Hui Malama Loko I'a. The public intention of the Pa'akea project is to be an accessible cultural site for the community that provides hands-on cultural and restoration activities grounded in traditional Hawaiian fishpond stewardship. 

#### 5. Describe the geographic coverage:

The Pa'akea fishpond site is located behind the Aiea Best Buy parcel (98-051 Kamehameha Hwy, Aiea, HI 96701). MPOW's intention is that Pa'akea activities have a statewide reach.

Restoring an historic fishpond has numerous precedents across Hawaii and MPOW will work collaboratively with other sites and expert Hawaiian practitioners. This Phase II project in FY 2024-25 involves a combination of research, planning, preservation efforts, and community engagement. We anticipate these activities:

#### Scope of Work/ Activities:

1. **Documentation:** MPOW will document the fishpond's historic significance and any historical events associated with it. Build public content that will be used in a website and/or social media postings. This will be done with curators from the Bishop Museum and University of Hawaii library research.

#### Tasks:

- Request archival information from curators at the Bishop Museum and the University of Hawai'i library and archives (examining maps and photographs).
- Digitize photographs and maps and other ephemera.

**Responsibilities:** MPOW Program and Business Manager working with a university student research assistant.

2. Site Assessment: Evaluate and document the current state of the site to ensure that Pa'akea is safe, authentic, and educational for school and community groups.

#### Tasks:

 Identify deterioration, damage, or alterations to create baseline data and develop a strategic plan for the fishpond and its surrounds.

**Responsibilities:** MPOW Facilities Manager working with Hawaiian Fishpond experts and volunteers.

**3.** Community Involvement and Collaboration with Partners: Engage with Hui Malama Loko, the local community, stakeholders, and fishpond organizations to gather input and feedback regarding public access and eduction.

#### Tasks:

- Outreach, meetings, and site visits. MPOW staff will consult with Hawaii Department of Land and Natural Resources (DLNR), the US Navy, NOAA, and the City & County of Honolulu to obtain necessary permits and approvals. MPOW Executive Director and Program and Business Manager will engage with Hui Malama Loko partners.
- MPOW will host community engagement events to solicit feedback regarding site use and opportunities to provide youth education.
- Determine staffing and other needs to host school visits and community activities.

**Responsibilities:** Executive Director and Program and Business Manager will work with community members and volunteers.

**4. Develop Educational Program:** Develop educational materials and interpretive signage to help visitors understand the site's historical and cultural significance.

#### Tasks:

- Work with Hui Malama Loko partners to determine the types of educational activities appropriate to the Pa'akea site.
- Hire a Hawaiian cultural educator to draft curriculum and signage. Apply for Hawaii
   DOE Na Hopena A'o School and Community Partnerships status.

**Responsibilities:** Executive Director and Program and Business Manager will work with educators and cultural experts.

#### 2. The target group:

MPOW's target service population are the students attending schools in the Aiea-Moanalua-Radford Complex Area, including Aiea, Waimalu, Alvah A. Scott, Pearl Ridge, and Webling Elementary; and Aiea Intermediate and High School. The student population within the complex is approximately 3,500 youth ages 5-18. Malama Pa'akea o Waimalu was created as a nonprofit in 2023 after years of consideration and maintenance of the fishpond and grounds by the Healani Land Company. Quality assurance will occur in three ways. The Board of Directors will meet quarterly and as needed in FY 24-25 to review all financial expenditures and programmatic decisions regarding the use of the site and renovation activities. Second, staff will work with Hui Malama Loko fishpond partners and attend workshops to establish goals and objectives for the Pa'akea site. These will inform MPOW as to how to maintain quality assurance in all their activities. Lastly, MPOW will work with the City & County, DLNR, and NOAA to ensure that activities are permitted and compliant with regulations.

Evaluation and documentation will be a key part of each of the activities planned in FY24-25. The intention in building capacity for MPOW is to identify objectives and to develop and implement strategies to achieve these. During the grant period, staff will report progress to the Board of Directors, who will use the information to clarify goals. MPOW staff will host a minimum of two community meetings/events and will seek feedback in the form of facilitated discussion and post-event surveys.

MPOW was created as a 501c3 in 2023 but the Pa'akea site has been under the management and care of the Healani Land Company since 1990 when the land was purchased for commercial development. The Pa'akea site had been the home of Primo Brewery since at least 1969. In 1990 Healani took over the commercial buildings and upgraded the old Primo Garden adjacent to the fishpond. The site included a hale, a stage, and a gazebo with other ancillary buildings. An historic rock wall borders the fishpond, but in the 1960s, this was capped with a concrete sidewalk. Besides staff and brewery clientele the fishpond has not been accessible to the public.

The dream of Malama Pa'akea o Waimalu (which in the Hawaiian language means "To care for Pa'akea [fish pond] of Waimalu") comes from the vision of founder Stacy Philippou. As the only child of Howard Chong Jr. she took over Healani Land Company in 2019. Philippou, who's ancestry is part Hawaiian, is seeking to restore the fishpond and its waterfront with the intention of making it an accessible learning site to perpetuate Hawaiian culture and land stewardship.

Raised in Hawaii, Philippou is a graduate of Punahou School with a Master's in Business Administration. She has worked at Healani Land Company for 11 years, becoming its President and CEO in 2019. Philippou is a member of the Hui Malama Loko l'a and of the Council for Native Hawaiian Advancement. She is working to make Malama Pa'akea o Waimalu a Native Hawaiian Organization.

On the MPOW Board is attorney Christine Denton, also of Hawaiian heritage. She volunteers her time and provides legal guidance. Her experience includes five years at Chaminade University, working in Human Resources and Administration, and since 2022 as General Counsel. Currently she is a Deputy Prosecuting Attorney, Juvenile Division.

Also on the Board is Bri Gamiao, a US Navy veteran and Information Systems Technician. Gamiao has been a Platform Information Technology Manager at Pearl Harbor Naval Shipyard.

Healani hosted one community fundraising event for the Kalihi Kai Canoe Club in 2023. This engaged over 50 people in an imu activity.
